### 100 device milestone reached in Dayton

Grateful community celebrated Gerlitz at Locally Nourished

DAYTON — Gordon Gerlitz reached an impressive milestone by distributing 100 refurbished computers in his community. A small gathering was held to celebrate his accomplishment and

service to others at Locally Nourished.
"Why do you do this," he was asked during the celebration. "I have been blessed with the gift of time and enjoy helping others," answered Gerlitz.

Chrisann Christensen, his first donor, said, "I think he advertised on Facebook. At that time, my daughter and I had some computers that we had replaced, so it seemed like a good way to offload those and repurpose them. He was my high school teacher, so I trusted he would actually clean the computers and donate them to an appropriate person or agency."

"I respected him and what he was doing for the community, so I wanted to give back any way I could," said Katie Leid, who donated the one-hundredth computer.

Not one to rest on his laurels, Gerlitz will continue the program. How does it work? People with non-working or outdated computers can donate them to Gerlitz. He asks donors if they have a charity preference. Most tell him to donate them where they are needed.

Gerlitz then erases, installs a fresh copy of Windows, and adjusts the computers for maximum performance before donating them. Organizations that have benefited from the program include Project Timothy, Walla Walla YWCA, Blue Mountain Counseling, Blue Mountain Action Council, Waitsburg Historical Society, and Christian Women.

After retiring from the Dayton School District, Gerlitz started G Whiz Computing, which he closed in December 2023.

### **Dayton School Board reviews org** chart

Budget extended to handle surplus funds

DAYTON — The Dayton School Board met in the high school library at 6:30 p.m. on August 21, 2024. School board members present were Chair Jeffrey McCowen, Grant Griffin, and, over Zoom, Ryan Paulson. Superintendent Jeremy Wheatley and Business Manager Jana Eaton were also present. Zac Fabian and Aneesha Dieu were not present.

The board passed the consent agenda, including hiring Vikki Griffin as a food service assistant, Judy Ketterling as a high school science teacher, and Stacy Startin as a bus driver. The approved consent also included a \$250 donation to the Girls High School Basketball Team from the Columbia County Conservatives.

Wheatley presented a draft of the new organizational chart, with himself as superintendent and Amy Cox as the primary and secondary principal. Hilary Wheeler now heads the Special Education Department under contract from ESD 112.

Wheatley said work on the schools was moving along quickly, with teachers in the buildings preparing for the start of school. He said the air-conditioning units were cooling while final adjustments were being made. Wheatley

said he was hopeful the district would be awarded a grant it had applied for to renovate the football field and track, including lighting.

Wheatley also addressed the idea of a two to three-year Policy Governance implementation process with assistance from an outside contractor. This is part of the initiative introduced by the last superintendent, Rich Stewart. Policy governance removes the board from any role in the management of the school's operations. Instead, the board delineates, using policies, the district's end goals and provides the economic means to meet goals and monitor the process.

Eaton asked the board to approve a budget extension since the district received \$529,000 more income in the past fiscal year than forecasted-most of the surplus from grant funding. An extension is needed so that the district can utilize the surplus funds. The board approved a resolution to increase the district's expenditures by \$390,000, the remaining amount of the surplus.

The board approved a bid with Coleman Oil for fuel and Meadow Gold for the district's dairy products.

The board changed the September 4 work session to a school board retreat.

There was no executive session, and the meeting adjourned at 7:03 p.m.





WAITSBURG — For the past four years, Waitsburg has been home to a funky little vintage gift shop just inside The Old Town Hall. Gaudy Gals on Main opened in February of 2022. Owners Lori Davis and Kimi Bruzas created a beautifully curated space for locals and travelers to enjoy.

A couple of weeks ago, a member of the Waitsburg Historical Society approached Davis to ask about her



PIONEER PORTRAITS

Waitsburg - It was an unusually full house at last week's City Council meeting, at least through the first item on the agenda: discussion and action on the new public art selection finalists. Members of the Waitsburg Art Commission, community members and artists alike were on hand to offer input on the final Council approval of the two bronze sculptures -- to reside on Main Street - selected by the Commission earlier this month. On August 13 artists Jeffrey Hill and Squire Broel presented their visions for "The Founding Fathers," a piece depicting Waitsburg founders Sylvester Wait, William Bruce and William Preston, while Keith McMasters and Wayne Chabre shared their concept for "Game Table," a sculpture honoring Fanny Weller and the young child of William Bruce who drowned as a toddler. On August 14 the Art Commission voted to recommend the work of Broel and Chabre to the Council. Chabre's "Game Table" depicts Fanny Weller sitting at the table, a young Edward Bruce reaches for a children's nook atop the table. The piece incorporates a game called The Waitsburg Story" that visitors can sit at the table and play. Broel's memorial to the founding fathers is a 10-foot-tall obelisk created with four bronze panels. Engravings of the faces of Bruce, Wait and Preston will be placed at the top of each panel with images depicting local waterways and wheat fields running down the lengths. The fourth panel will show an eye in a harvest moon at the trop and will incorporate past, present and future contributors of Waitsburg on the panel.





### Semolina Orange Cake

It is ironic that I would start and finish my time writing this column with recipes for desserts, being that I do not have the biggest sweet tooth. In fact, my gastronomic cravings tend to be more for the savory or spicy side of things. However, after sharing an array of recipes, from appetizers, soups and salads to stews and meaty entrees, it made sense to end on a sweet bite. This week, to celebrate a family birthday I turned to a recipe that John developed during the early days of the coffee



crumbly texture, this delightful semolina cake topped with dried apricots was a weekend special that always sold out. As I am beginning a new chapter, this cake felt like the perfect celebration of my time at both "The Times" and Ten Ton Coffee.

### **Ingredients:**

- 1 orange
- 1 lemon
- 1/4 cup half & half
- 2 large eggs
- 2 teaspoons vanilla extract
- 1 cup olive oil, plus more for greasing
- 2 cups all-purpose flour
- 1 cup semolina
- 1 ½ cups sugar
- 2 teaspoons baking powder
- 2 teaspoons kosher salt (or 1 teaspoon fine salt) 7 to 8 dried apricots, sliced. In half crosswise
- 1/4 cup honey
- 1 teaspoon orange blossom water (see notes)
- 1 tablespoon butter

#### **Directions:**

Preheat the oven to 325 degrees. Generously grease a 9- by 13-inch baking dish with olive oil and line the bottom with parchment paper.

Use a micro-plane or fine grater to zest the orange and lemon. Peel the pith off of the orange and cut the fruit into large chunks. Cut the lemon in half, setting one half aside for later, then peel the pith off the fruit of the other half. Add the citrus zest, and peeled fruit from the orange and lemon to a food processor, pulsing into a smooth puree. Add the half & half, eggs, and vanilla extract, pulsing until combined. Next, with the processor running, pour the olive oil in a steady stream until incorporated into the mixture.

Meanwhile, in a large mixing bowl, whisk the four, semolina, sugar, baking powder, and salt until combined. Using a rubber spatula, add the wet ingredients to the dry mixture. Mix to combine with the whisk until a thick, smooth cake batter just forms. Pour the batter into the prepared baking dish and spread in an even layer with a spatula. Decoratively arrange the apricot halves over the top. Bake for an initial 25 to 30 minutes until the cake just starts to set.

While the cake is baking make your honey syrup. Juice the reserved lemon half. In a small saucepan, combine the lemon juice, honey, orange blossom water, and butter with a small pinch of salt. Set pan over medium heat and bring to a simmer, cooking for a few minutes to make a light syrup.

After the initial 25 to 30 minutes of baking time, remove the cake from the oven and pour the syrup over the top. Use a pastry brush to evenly spread the syrup across the top of the cake. Return the cake to the oven and continue to bake until the cake is cooked through, and the top is a light golden brown, about another 15 to 20 minutes. A toothpick inserted in the center should come out clean. Remove and allow cake to cool before serving.

### **Notes:**

Because the entire citrus, both the fruit and the zest, are used in the batter, try to find the best quality fruits available. The pureed orange and lemon should yield about one cup.

Orange blossom water is made from distilling the essence of the flowers from bitter orange trees. It is often used to add a floral note to desserts in the Mediterranean and the Middle East. You can find bottles of it in some large grocery stores or from online sources. If you cannot find orange blossom water, you can use vanilla extract as a substitute.

Serve this lovely cake with chocolate or pistachio ice cream. It would also be wonderful simply served with a dollop of fresh whipped cream. Until our next meal together, enjoy.
