CWWFD2 asks public for input on fire chief job description

WALLA WALLA — The Columbia Walla Walla Fire District 2 volunteers and board are grateful for the voters' approval of the 2023 Levy Lid Lift. In allocating these resources, the department has prioritized hiring a full-time, paid Fire Chief.

The department understands the importance of the community having an opportunity to give input on leadership of CWWFD2.

Assistant Fire Chief Matt Spring formed a hiring committee of department and community members to begin the process. The committee reviewed Fire Chief Descriptions from other fire departments to tailor one that meets the district's unique needs. The acting volunteer Fire Chief, Colter Mohney, approved the document which was then given to all FD2 Volunteers for review.

Now, the department is making the draft available to the community for its feedback.

The draft job description is available for review at <u>www.cw-wfd2.com/hiring</u>.

Why community input matters:

- Community-Centric Approach: The department serves all the residents and businesses in the district. The publics perspectives, concerns, and expectations are vital in shaping the qualities and qualifications the department seek in our Fire Chief.
- Ensuring representation: Involving the community in the job description review will help the future Fire Chief serve all community members effectively.
- Transparency and accountability: The department invites the public to participate in this process as part of its ongoing commitment to openness and inclusivity in all aspects of the district's operations.

How to get involved:

- Review the job description: Take the time to read the draft job description available at www.cwwfd2.com/hiring, and consider how it aligns with the needs and values of our community.
- Provide feedback: Residents' opinions matter. The department wants to hear suggestions, including additional qualifications, concerns about specific requirements, or ideas to improve the description. Feedback can be submitted by email or direct mail, as indicated at the end of the job description.
- Spread the word: Encourage friends, family, and neighbors to participate in the review process. The more voices heard, the better informed the decision-making will be.

On behalf of the department, volunteer firefighter Corben Ketelsen said, "Together, let's work towards selecting a fire chief who will meet the highest professional standards and reflect the priorities of our community. Thank you for your ongoing support and commitment to keeping our neighborhoods safe."

"Cabrini" THE TIMES

DAYTON —"Cabrini" is the powerful epic of Francesca Cabrini, an Italian immigrant who arrives in New York City in 1889 and is greeted by disease, crime, and impoverished children. Cabrini sets off on a daring mission to convince the hostile mayor to secure housing and healthcare for society's most vulnerable. With broken English and poor health, Cabrini uses her entrepreneurial mind to build an empire of hope unlike anything the world had ever seen.

This movie, directed by Alejandro Monteverde (who also directed Sound of Freedom), has been well regarded; with a 91% favorable by Rotten Tomatoes critics and a 96% by audiences. That website's critic's summary, in part, is that "Cabrini is an uplifting biopic with a timeless message" while the audience summary is that this movie is "a powerful reminder of what can happen when people are willing to make sacrifices for the things they believe in." It is rated PG-13 for thematic material, some violence, language, and smoking. The IMDb rating is 7.9 out of 10 and that website's parent's guide notes that this movie has moderate levels of drugs, alcohol and smoking, plus some emotionally intense scenes. Runtime is 145 minutes.

COLUMBIA COUNTY COMMUNITY POOL WORKSHOP APRIL 18



FIRST AMENDMENT RETALIATION

Dear Editor

It appears that some CCC members and elected officials continue to display disregard for all community members' First Amendment rights. Port of Columbia Commissioner Seth Bryan is the administrator for the Dayton Uncensored Facebook page, which allows harassment, defamation, doxxing, and cyber-harassment of community members engaging in constitutionally protected activity.

LETTERS

The First Amendment right to criticize public officials, access the courts, and comment on issues of public interest are well-established and supported by case law.

An elected official's retaliation against a citizen for exercising their First Amendment rights is a blackletter constitutional violation. The violation includes anyone's behavior to deter "a person of ordinary firmness" from continuing to engage in protected speech or conduct.

Disagreement is part of the democratic process. However, intimidation, stalking, cyber-harassment, and defamation with the intent to silence opposing voices is not. When a private entity has acted jointly and intentionally with elected officials, it is proper to hold these entities accountable for the actions that they helped bring about, encouraged, and condoned.

I have endured two years of retaliation for my First Amendment-protected actions, violating my constitutional rights. It's very disheartening to witness this community held hostage by a handful of individuals who attack livelihoods and reputations with disregard for constitutional rights. Creating an atmosphere of fear and effectively censoring voices.

Those words will soon be heard as the summer Olympics in Paris begin. Springtime is also the beginning of Major League Baseball with the famous words,

As lovely as Waitsburg is, it's not Paris or home to an MBL team. When I hear, "Let the games begin," it's to announce the start of Daniel's and my garden competition. As a friend once said, "You guys don't have a relationship; you have a competition." She hit that nail

While Daniel is at work, I have gotten a head start on planting, weeding, and cleaning the beds. However, he has done the dirty work, dragging bags of compost into the yard and spreading it throughout the planters.

I have planted radishes, albeit three times. The first was too soon, typical for my impatient nature, and they didn't make it through the cold and wet weather. The second time, they started to sprout, but I was overly ambitious about weeding. Moving the dirt to dig out mint and oops, I dug up the radish sprouts. The third planting is the charm, and I see sprouts!

I also planted lettuce too early, so it's on to batch two. To ensure I have some lettuce to harvest, I also planted some starts with the seeds. After all the lettuce

The birds have been busy this year, and I've added a few more feeders to the garden for our entertainment. Even Mugsy has resigned himself to the birds' intrusion in his "yard, " allowing them to eat in peace instead of chasing them away. This does not apply to neighborhood cats or squirrels hanging out in the yard; those he attacks without success, other than chasing them all away.

Living History: Charlie Potter, stagecoach driver on April 14

WALLA WALLA — The Living History program at The Fort Walla Walla Museum will highlight stagecoach driver Charlie Potter. The man loved his horses; that's what the history books say about Charlie Potter, the famed stagecoach driver from Walla Walla. Visitors have seen the museum collection's iconic stagecoach and can now meet the driver.

Living History reenactor Ron Krause will bring Potter to life in the museum's Pioneer Village at 2 p.m. on April 14.

The stagecoach driver is a new character for the ensemble this year, and Walla Walla historian Susan Monahan gave the following account of Potter's life.

The 1880s were hard times for stagecoach drivers, according to Monahan. Railroads were taking over passenger and mail transportation. Due to the railroad's increased efficiency, stages went from essential to increasingly obsolete in just a few short years. Drivers, including Charlie Potter, devoted their lives to getting people and mail to their destinations and were significantly impacted.

Potter moved from London, England, in 1848 when he was 15. Four years later, at 19, he had his first job as a stagecoach driver with a company based in Alton, Illinois. Monahan said the time was right for providing transportation due to the gold rushes in the West, which lured him to driving coaches in California and Idaho. Along the way, Potter married Margaret McInroe, who immigrated from Ireland and served as a nurse during the American Civil

Potter was in a race with railroad expansion. Potters' older children were born in various frontier towns from Illinois to Missouri as he tried to keep one step ahead.

The Potters arrived in Walla Walla in 1871 and built a permanent home on Cherry Street. As railroads expanded, stagecoach lines in southern Idaho were being eliminated. However, the route between Pendleton and Walla Walla was still served by a stagecoach line owned by John Ladd. Potter drove a Concord-style stagecoach for that route, carrying passengers, mail, and errands for bankers, storekeepers, and merchants. The route took Potter through the Umatilla Indian Reservation, and his stage encountered no difficulties getting through, even during the Indian troubles.

Monahan described the weather as an ever-present challenge to a stage driver. Potter proved his bravery and resourcefulness in 1875 when he saved his horses, passengers, and cargo in an accident. On route to Pendleton, Potter traversed along the Tum a Lum River on a Thursday when the water was even

with the hubs of his stage. By Friday, the river had risen over four feet, his stagecoach overturned, and one horse drowned. Potter cut the other horses loose, the two passengers managed to exit the coach, and no mail or express cargo was lost.

After the Walla Walla to Pendleton route was eliminated, he continued driving a stage between Pendleton and Blue Mountain Station until it closed.

At the time, Athena, Oregon was called Centerville, and a journalist of the Centerville Examiner suggested that when the old stagecoach was "lain aside" and the loud crack of his whip "heard no more," that Charlie Potter might take the job of conductor on a train. Instead of changing jobs, Charlie

Stagecoaches arrived and departed at the Stine House Hotel on the corner of 4th Ave. and Main St. The horses were stabled at the Kirkman Stable at the corner of Spokane St. and Sumach St. There is no mention of this stable in the Kirkman family records. However, the building is visible on the Sanborn Fire and Birdseye map renderings.

Harry Painter, a native of Walla Walla, was a schoolboy in the 1880s. As a student at the Baker School, he could observe the stage terminal and barns from a classroom window.

The stage's arrivals and departures from the Stine House were sure to bring a crowd. But that crowd numbered in the hundreds when Potter returned from his last trip to Pendleton. Painter's schoolboy memories inspired him to write a poignant account of Potter's last day as a stagecoach driver.

"Potter drove to the Stine House. His passengers exited, and he tossed the mail bags to the sidewalk and drove to Kirkman stage barn on Sumac Street. The hostlers hurried out to unnitch and unnarness his horses. Without a word, he waved them to one side. One by one, he threw his arms about the horses' necks. He talked to them in a low tone, and no bystanders heard what he said. He did not notice the outstretched hands of those who tried to say goodbye. As he walked away, the horses followed him with their eyes. As days went by, the school children from across the street saw him sitting in a chair on his front porch, smoking his pipe and remembering. In about a month, his obituary appeared in the local papers. I don't know what the cause of his death was as written by the physicians on the death certificate, nor did I need to know, for the neighbors told me that he died of a broken heart."

Charlie Potter died at the age of 53, and the death certificate listed the cause as brain fever. Well-known through his work, Potter's death was announced in newspapers outside Walla Walla. His obituaries de-

scribed him as a man of exceptional skill as a driver and praised his personal qualities.

"The Oregonian," said in its obituary for Potter, "The most remarkable and pathetic passing away of any of these old stage coachmen, was that of Charley Potter, after 35 or more years of continual service---a driver of various lines in California Oregon, Idaho, and Washington, which meant a life of great endurance, peril and hardship."

The Walla Walla Museum is open daily from 10 a.m. to 5 p.m. through the end of October. Admission is \$12 for adults, \$10 for seniors and students, \$5 for children ages 6-12, and children age five and under are free. Museum members receive free admission all year. Memberships start at \$35 for seniors and students; a couple can buy a dual membership for \$55, and a whole household can join for \$65.

Membership entitles people to free admission, email announcements of special events, the quarterly newsletter, "The Dispatch," and a discount at the museum store. It also includes free admission to the Tamástslikt Cultural Institute near Pendleton. Visit the museum's calendar at fwwm.org/all events. For more information, call (509) 525-7703 or visit fwwm org. The Jones family who founded Abacela, a central Oregon winery that is coming up on its 30th anniversary next year, did years of careful research on climate and soil conditions all over the country with a specific goal in mind. They were determined to grow Tempranillo - the renowned Spanish grape - somewhere where it could best thrive. They found the land they sought outside of Roseburg and began planting Tempranillo and a number of other Mediterranean varieties. They've succeeded beyond all expectations, and make up to five different versions of their signature grape, including this most affordable young version named Fiesta. The new vintage brings fragrant berry and mocha scents that carry on into the palate, making this instantly delicious. The tannins are lightly grainy, bringing accents of coffee grounds, black tea and tobacco as it winds down through the finish.

Skillet Chicken with Black Beans & Rice

And just like that, the busy season is upon us. After a full day of spring cleaning the house and freshening up the garden beds, the thought of cooking dinner can feel extra daunting. This is when a satisfying one-pot recipe can really come in handy. Big flavor with fewer dishes. Here chicken thighs are roasted crisp over a bed of cumin spiced black beans and rice. Served with some fresh avocado and lime. this comforting meal has become a new weeknight favorite.



Ingredients:

6 to 8 bone-in, skin-on chicken thighs (about 3 pounds)

Salt and fresh ground black pepper

2 tablespoons olive oil

1 large white onion, chopped

1 red bell pepper, halved and sliced

2 cups chicken stock

1 jalapeño peppers, seeded and chopped

1 cinnamon stick

3 garlic cloves, minced

1 teaspoon ground cumin ½ teaspoon ground cayenne

1 (15-ounce) can black beans, drained and rinsed

5 ounces cherry tomatoes, halved

1 cup basmati rice, rinsed in mesh strainer

1/4 cup chopped fresh cilantro

Options for garnish:

Fresh lime wedges Sliced avocado

Sour cream

Radishes Pickled red onion

Directions:

Preheat the oven to 375 degrees. Season both sides of the chicken thighs with salt and black pepper. Heat the oil in a 12-inch heavy, ovenproof skillet over medium-high heat. Working in batches, brown the chicken until deeply golden all over, 3 to 5 minutes per side. Transfer to a plate and set aside. Add the onion and bell pepper to the pan and sauté until starting to soften, about 5 minutes. Season with a pinch of salt and

In a small saucepan, bring the chicken stock to a boil. Meanwhile, add the jalapeños, cinnamon, garlic, cumin, and cayenne to the onion mixture. Continue to cook for another 2 minutes then add the beans and tomatoes. Generously season with salt and pepper. Sprinkle the rice over the top in a single layer. Don't stir, leave the bean and onions on the bottom. Gently pour the boiling stock into the skillet to just cover the rice and vegetables. You might need to use a little more or less depending on pan size. Arrange the chicken, skin side up, over the top along with any accumulated juices on the plate.

Carefully, set skillet on middle rack of oven and bake, uncovered, for 35 to 40 minutes. The chicken will be perfectly crispy and golden, while the rice should be cooked tender. Sprinkle cilantro over the top and allow the dish to rest for a few minutes. Serve chicken in bowls on top of the rice and beans. Garnish with your favorite toppings, such as sour cream, fresh lime, and sliced avocado.

Notes:

The 12-inch size of the skillet is a very important factor to the success of this dish. Too much smaller or bigger and you could risk under or over cooking the rice. I used a cast iron skillet. To catch any possible overflow, I placed a sheet pan lined in foil on the rack below the skillet.

This recipe has a delightfully balanced chili flavor. However, you can adjust the heat to your taste by reducing or increasing the cayenne. If jalapeños are too spicy, try using a milder chili like a poblano or Anaheim. If you want more heat, try increasing the chilis or adding some chopped serrano peppers.






