Marijuana Hearing Monday in Dayton

COLUMBIA CO. TO ADDRESS **POT BUSINESS MORATORIUM**

DAYTON - On Monday, March 16, Columbia County Commissioners will meet with the public to decide on the future of recreational marijuana businesses in the county. The board has scheduled a public hearing for 1:15 p.m. in the commissioners' board room. A representative from the Washington State Liquor Control Board will meet with commissioners prior to the hearing, at 10 a.m., in a meeting also open to the public.

The county's 15-month-long moratorium on recreational marijuana businesses expires the following day, on March 17. Commissioners extended a yearlong moratorium in December for an additional three months to allow them time to gather more information on the issue. They visited a retail marijuana store in Prosser last month as part of that fact-gathering process.

All three commissioners agreed that the field trip to Altitude, Yakima

Valley's first marijuana shop, was eye opening. None of the county leaders commented, at the time, on whether the trip had influenced their thinking regarding the issue of allowing marijuana businesses in Columbia County, but they each commented that the store was run in a much more professional, regulated and upscale manner than they had expected.

Washington voters legalized marijuana in 2012, but the state didn't begin issuing business licenses for more than a year. Columbia County placed a moratorium on marijuana businesses at the end of 2013. After a year-long moratorium of its own, the city of Dayton voted to ban marijuana businesses at the end of last year.

The cities of Walla Walla and Waitsburg have both passed ordinances addressing licensing and locating of marijuana businesses within their boundaries. Both Garfield and Franklin counties have placed moratoriums on marijuana businesses. Walla Walla County has banned them while other nearby counties such as Whitman, Adams and Franklin counties have ruled that marijuana businesses are allowed under existing zoning.

Dayton Man Arrested Following Retail Burglary

GARRETT WALTERMIRE CAPTURED AFTER A SHORT FOOT PURSUIT IN DAYTON

DAYTON - John Garrett Waltermire, 24, was arrested Saturday after a short foot pursuit near East Jackson Street in Dayton. Waltermire was a suspect in the burglary of the Inland Cellular store on East Main Street here last week.

Early on the morning of Monday, March

2, a burglar broke into the cellphone company's retail store at 151 E. Main St. A witness reported hearing what sounded like a loud crash at approximately 4:30 a.m. Shortly thereafter the witness saw a male with a backpack running north toward East Commercial Street, according to a Columbia County Sheriff's Office report.

The commercial burglary was reported when the store manager, Gina Wilson, arrived for work at about 8:15 a.m. and noticed that the back door to the business had been forced open. Missing from the shop were an HTC cell phone, a Samsung Galaxy tablet, a Bluetooth headset and a pair of small stereo

During the investigation, Columbia County deputies were able to develop enough information to determine that Waltermire was a person of interest in the burglary, according to the report. Deputies also learned that Waltermire was already wanted on a Columbia County District Court warrant for obstructing a law enforcement offi-

Deputies attempted to locate Waltermire for questioning. On Tuesday afternoon, following the Inland Cellular burglary, deputies conducted a traffic stop in the 800 block of East Main Street. Deputies spotted Waltermire in the vehicle, but he fled from the traf-





How Many Votes Do You Need to Raise Taxes?

ast week, the Washington State Senate approved a pretty significant gas tax increase for the state's drivers. If the bill is approved by the state house and signed into law, the new gas taxes will be phased



in over three years. You can read the details in the WNPA article on this page.

The money will go toward a bunch of high-profile projects, including the 520 floating bridge in Seattle, I-405 east of Seattle, I-5 near Tacoma and I-90 through Snoqualmie Pass. The east side of the state is not being totally left out. A long awaited north-south freeway in Spokane made the list, as did widening of Highway 12 west of Walla Walla. A chunk of the money will go toward public transit and bike paths.

This all sounds reasonable to me, I guess; if you want good roads, you gotta pay for them.

As the WNPA piece pointed out, the bulk of the support in the Senate for the gas tax increase came from Republicans. Most Democrats opposed it because it included language that would limit the state's ability to impose restrictions on greenhouse gasses. The Senate vote was 27-22, and our own state senator, Mike Hewitt, voted Yea.

But as I Googled around trying to learn more about the transportation bill, I found something interesting. It seems that, in January, the Washington State Senate passed a rule that any proposed tax increase must receive a two-thirds yes vote in that body to pass. Here's what the Seattle Times had to say:

'Shortly before the vote, (Lt. Gov. Brad) Owen (a Democrat, who presides over the Senate as its president) said he wouldn't enforce a Senate rule established by the GOP in January that would require a two-thirds majority vote for any new taxes.

'The president (Owen, referring to himself) has previously stated, the Senate cannot pass a rule that violates the state constitution,' Owen told lawmakers Monday. 'Perhaps that statement should be clarified to read, the Senate may adopt an unconstitutional rule, but the president will not enforce it.'

So let me get this straight: The Washington State Senate, which has a Republican majority, passed a rule that would make itself appear to be highly fiscally responsible. Then, six weeks later, knowing that the rule can't be enforced, they went ahead and violated it?

Hmmmm. I wonder if they knew that rule couldn't be enforced when they created it.



Senate Passes Transportation Bill, 11.7-Cent Gas Tax Hike

OLYMPIA - Just 18 days after its initial unveiling, Senate lawmakers have passed a \$15 billion transportation package that includes an 11.7-cent increase to the state gas tax over the next three years.

That package now moves to the Democrat-controlled House where Majority Leader Pat Sullivan, D-Covington, said that the package won't be considered until lawmakers address education funding, which they are under order from the state Supreme Court to substantially increase.

"In the end, our goal is to pass a transportation budget," Sullivan said. "But we can't do that until we get the operating side figured out."

For the Senators who have been working on the package for months, Monday's changeover is reason enough for excitement.

"I feel like I can breathe a little sigh of relief, like being in the eye of the hurricane before having to take a breath and head back into the storm," said Sen. Steve Hobbs, D-Lake Stevens. He and Sens. Joe Fain, R-Auburn, Marko Liias, D-Mukilteo, and Curtis King, R-Yakima announced what they described as a bi-partisan transportation package on Feb. 12 after 22 months of negotiating.

Ten of the package's 11 bills have now passed in the Senate and are scheduled to be introduced to their respective committees in the House. The package's revenue bill passed on a 27to-23 bipartisan senate vote Monday.

The revenue bill would fund 16 years worth of transportation projects by increasing the state's 35.7 cents-pergallon gas tax by five cents in July, 4.2 cents in July 2016 and another 2.5 cents in July 2017. That would bring Washington's combined state and federal gas tax to 67.6 cents-per-gallon, second highest in the country behind Pennsylvania.

Along with the gas tax increase, the revenue bill would also increase car-tab fees by \$15 in the program's first year and then by an additional \$8 in 2022. The classified skill examination fee for obtaining a commercial driver's license would increase from \$100 to \$250.

The package would fund \$8 billion in widening projects on I-405 east of Seattle, I-90 through the Snoqualmie Pass corridor and I-5 near Joint Base Lewis-McChord south of Tacoma. It would also fund a new north-south I-395 corridor in Spokane and allocate \$1.2 billion for completing the west side of the new Highway 520 bridge between Seattle and Bellevue.

The package also includes some funding for rural transit, vanpools, bike paths, pedestrian walkways and highway safety. However, Republicans have fought to include a provision in the revenue bill that would move all of these funds to the state highway account if Gov. Jay Inslee—or any other governor in the next 16 years-implements a low-carbon fuel standard. Committee staff have previously said that the language could be interpreted to also include any carbon emission reduction plans.

When asked what he wants to see happen with the package as it makes its way through the House, Hobbs said he and the other Senate Democrats would like to see the carbon language removed.

"I'm sure the other side would like to keep it in," he said. "Perhaps we can come to an agreement of some kind."

The revenue bill cleared the Senate on March 2 with 19 Republicans and 8 Democrats voting in support. The corresponding spending bill also passed that day in a 41-to-8 vote.

The package's eight policy bills were passed the week before on Feb. 27. While most of them received near-unanimous approval, two had the Senate split along party lines, illustrating that some aspects of the bipartisan package aren't bipartisan at all.

SB 5990 has been a focus of controversy since the package was announced. The bill's original language would have moved all revenue generated from sales taxes on transportation projects out of the state's general fund and into the transportation fund. Democrats and education groups opposed the bill, saying that moving money out of the general fund would only make it more difficult for the Legislature to meet its obligations for funding educa-

"We're under a contempt-of-court order for not funding our public schools, and I've heard over and over again that Senate Republicans don't want to raise revenue. But then they turn around and pass a gas tax," Sullivan said. "They've shown that revenue isn't the problem. They're willing to do it for roads, and yet they're blocking that money for kids."

Instead, the Senate passed the bill with an amendment from Sen. Doug Ericksen, R-Ferndale, that exempts all highway projects from the state sales tax until July 1, 2019. All highway improvement and preservation projects beginning after that date would also be exempt. Sales tax revenue made off of non-highway related projects would still be moved out of the general fund and into the transportation budget.

The bill passed 26-to-23. Sen. Tim Sheldon, D-Potlatch, was the only Democrat to vote in support and he sits with the Republican caucus.

SB 5991 also had the Senate split along party lines. It would require 20 percent of funds from the state's environmental legacy stewardship account be given to the Department of Transportation to finance their own environmental projects. The account currently finances water and environmental health monitoring, air quality programs, stormwater runoff reduction and hazardous waste management efforts, including oil spill cleanups.

SB 5991 passed 27-to-22. Hobbs and Liias were the only Democrats to vote in support. Ericksen, who is the chairman of the Senate Environment Committee, was the only Republican to oppose it.

"There are several aspects of the package that are not favorable, but we will try to negotiate them out in the House," Hobbs said. "So I think it's a good start. After two years we finally have something out of here."

Sullivan also has high hopes about the package's future.

"I'm always optimistic," he said. "We're not Washington DC. We'll find a compromise and get this done."

fic stop on foot and was able to evade capture.

While fleeing, however, Waltermire dropped some of the items allegedly taken in Mondav's burglary. Deputies continued looking for Waltermire around town; in the meantime, a felony warrant from a previous arrest was issued Thursday after Waltermire failed to appear in court on charges of possession of a legend (prescription) drug and possession of a controlled substance.

Then on Saturday, at approximately 3 p.m., deputies learned that Waltermire was in an apartment building on East Jackson Street. They responded, and with the assistance of Washington State Patrol troopers, went to the apartment to arrest Waltermire. New Fire Station Nearly Ready

Fire District 3 plans its move to the facility east of Dayton around the end of March

DAYTON - Members of Columbia County Fire District 3 are getting excited about the new fire station on Patit Road, with its 13,500 square feet and 16 truck bays, brand new living quarters for five firefighters, and enough offices for all the command staff.

General contractor Joe Christensen, with G2 Construction out of Tri-Cities, is planning to have the \$850,000 remodel of the old Columbia Rural Electric Association building complete by the end of this month. New Assistant Fire Chief Jeromy Phinney says the district plans to start moving equipment and supplies from the current station at 206 W. Main St. immediately.

"In my opinion, the only thing we're giving up by moving out to this building is location," Chief Rick Turner said. "The fire department will no longer have a physical presence in town."

But both Turner and Phinney believe the location just east of town will not hurt the district's response times; in fact, said Bob Allbee, it may improve the district's response since volunteers won't have to navigate through town to get to the station. "Most of our volunteers live on this side of town anyway," he said. "And the majority of our calls for service are located east of town." Allbee is a volunteer with Fire District 3 as well as the U.S. Forest Service's Umatilla Forest Fire Management Officer.

The new fire station, which Fire District 3 purchased from Columbia REA last May for \$750,000, has plenty of room for the district's current needs, with room for future expansion.

"This should meet the needs of the district for a long, long time," Turner said. "We built more capacity into this thing than we need immediately, trying to build for the future while staying within our budget. We would not fill this building with our current fire and EMS

resources even if we brought the equipment in from Turner, which of course we don't intend to do."

The fire district houses a few fire trucks on Turner Road in a garage as a sort of outstation or satellite station for quicker response to some of the wildland fires that occur in that area. The district used to have an outstation at Highway 12 and Tucannon Road as well, but it lost all its volunteers from that part of the county and so it became inefficient to continue storing a fire truck out there, Turner said. The new fire station on Patit

Road is located on a little under five acres; a few outbuildings will help with additional storage. CREA used the building for many years as a local warehouse and storage for line equipment.

The truck bays didn't require much in the remodel, but the 6,000 square feet of office space was a six-month job. What was once a plywood shell for storage and some repair and shop work is now a two-story sheetrocked. painted, well-lit fire station with

new flooring, cabinets, kitchen, dining room, living room, fitness room, three full bathrooms including showers, five bedrooms and five offices.

The fire district currently pays rent to remain in the building on West Main Street. The district sold that building about a year ago to a real estate holding company; they've been paying a couple thousand dollars per month since then to stay, Phinney said. They hope that April's rent will be the last they pay to stay in their current quarters.

DAYTON - Rick Turner has been the face of Columbia County Fire District 3 for nearly 20 years, but as of January 1, 2017, the chief will return to full-time farming and leave fire-

fighting to the next generation of heroes.

Taking his place as chief will be lifelong Dayton resident Jeromy Phinney. Monday was Phinney's first official day as assistant fire chief. He will shadow Chief Turner for the next 22 months, learning the full-time job of running this 45-person department with its four paid staff, 41 volunteers, and dual operations of firefighting and emergency medical response.

"Jeromy has been a tireless volunteer and has worked many, many hours and gone to a lot of training,' Turner said. "And because of all that, he has the respect of everybody in our fire department. In my opinion, he was the natural person to choose to take this department to the next lev-

Until this week, Phinney worked as a building official with the Columbia County Planning Department. He had been there for about 10 years. Before that, he worked in construction. He graduated from Dayton High School in 1993 and lives in Dayton

with his wife, Amber, and two children ages 1 and 12.

Phinney started as a volunteer with the City of Dayton's Fire Department in 1999. In 2000, when the city and county joined to form Fire District 3, Phinney stayed on. He's been a captain and a deputy chief, but has always worked in a volunteer capacity. Now he's taken the plunge and will carry

on in Turner's place, making the fire district his career.

Turner, who was selected to fill outgoing Fire Chief Steve Carlson's big shoes in 1996, has always been a half-time fire chief; he and his family have continued to work the Turner

'Now it's time for this department to have a full-time chief," Turner said. "Our intent is for Jeromy to be the next fire chief."

COMMERCIAL CLUB HOLDS COMMUNITY FORUM

GOBEL AND CALLAHAN TAKE THE FLOOR TO TALK CITY GOVERNMENT

WAITSBURG – Incumbent Mayor Walt Gobel and incumbent councilwoman Debra Callahan accepted the Waitsburg Commercial Club's invitation to address residents at a Community Forum during the club's March 3 dinner meeting. No new candidates were present at the Forum which precedes the upcoming April 6 city council elections.

Gobel took advantage of the opportunity to sing the praises of the current council and the city staff – in a speech punctuated with good-natured comments from the audience – rather than to promote himself.

"We have an awesome council. We all get along really well. We don't always agree, which I think is a good thing. And we get things done," said Gobel. He went on to express gratitude for City Administrator/ Clerk/Treasurer Randy Hinchliffe and Deputy City Clerk Kelly Steinhoff. "Our staff is irreplaceable. The job they do for the city is unbelievable," he said.

job they do for the city is unbelievable," he said.

Gobel said that Hinchliffe has applied for and received over a million dollars in grant funds during his tenure as City Clerk. Audience member and former Times co-publisher Anita Baker chimed in to point out she and fellow audience member Doris Huffman should take some of the credit, since Huffman had taught Hinchliffe and Steinhoff in second grade and Baker taught them in third.

Gobel gave kudos to the City Crew and drew attention to the fact that Jim Lynch spent eight years in training while obtaining the necessary credentials to take over for the recently retired Dan Katsel. Now Travis Newman is going to school for the certifications necessary to run the wastewater treatment plant, and John Langford just received his pesticide/herbicide licenses.

"They're really dedicated to Waitsburg. For the pay they get, we get double what we pay for. Those people are awesome," said Gobel.

Gobel mentioned several areas in which he feels the city is heading in the right direction. "Budget-wise, we've been in the black forever. Not a lot of cities in our state can say that," he said, again crediting Hinchliffe and Steinhoff for their work in the office. "It takes a lot of heat off of me. Financially, the city is really in good shape," he said.

Gobel said he recently met with a company that may allow the city to convert all of the street lights to solar power through a state grant that would cost the city nothing. It will be a matter of working with the company and coordinating with Pacific Power & Light, said Gobel. "Right now we're paying over \$3,000 a month just for street lights."

Gobel mentioned possibilities, down the road, for lighting fairgrounds outbuildings and heating the city pool with solar power. "We're definitely heading in the right direction and I'm excited that we could be

a model community for others to consider the same thing," he said.

The pool, while an expense to the city, is an asset Gobel expressed a great deal of pride in. "We are a community of 1,250 people and we have a pool!" he said. The city is currently working with a company from back east who will, hopefully, be able to install a spray-in liner – at a significantly lower cost than traditional liners – to replace the current leaking liner.

Gobel said the current council is very aware of the city's infrastructure and is working to keep city roads, water lines, and sewer lines up to date. They are also working to meet new EPA requirements for the water treatment plant and coordinating with the Corps of Engineers to maintain the Touchet River dike.

"I'm obviously very proud of our community or I wouldn't be doing the job that I am. I hope all of you realize I'm trying to do the best I can with the limited experience I have. And I've got an awesome council. We had a caucus Sunday night and chose the same council members and mayor we have now," said Go-

Deb Callahan spoke next, seeking support for her third term on the council. Callahan shared her history with Waitsburg: "My first visit to Waitsburg was in 1974 and I came here as the president of Highland High Future Homemakers of America Chapter and loved it," she said.

She visited again during the Days of Real Sport in

1980 – the year Mt. St. Helens blew -- and was struck by how the community worked together to light the corners of the track with trucks so the horses wouldn't spook. Callahan moved here in 1981 as "a young, adventurous, single mother – the widow of a Vietnam veteran. I'd already fallen in love with Waitsburg so it was like coming home for me," she said.

Callahan said her volunteerism has spanned three decades, beginning with sewing in Mrs. Henderson home-ec room in 1981 helping the handicapped students with their sewing projects. Callahan said she wants a safe, healthy community with families, schools, businesses and churches that will grow and prosper. She also noted the importance of maintaining Waitsburg's history and uniqueness in the midst of that growth.

Callahan said she is pleased that this year the fairgrounds will be the busiest it's been in decades. "Years of annual events have been a great benefit to Waitsburg and the surrounding communities. We need to continue to hold and to grow these events," she said.

As The Times went to press Tuesday, March 10, no new Declarations of Candidacy had been received at city hall. Current Waitsburg City Council members are: Mayor Walt Gobel and council members K. C. Kuykendall, Kevin House, Marty Dunn, Karl Newell and Debra Callahan. The deadline to file a Declaration of Candidacy with the Waitsburg city clerk is March 13

"Sophie," a mannequin Johnson received from her mother, is the vehicle for her amusements. Currently, Sophie is dressed to celebrate St. Urho's Day on March 16.

According to sainturho.com, the legend of St. Urho originated in northern Minnesota in the 1950s and has grown among North Americans of Finnish descent to the point where it is now celebrated throughout the U.S., Canada and Finland. "St. Urho's Day is celebrated on March 16," the day prior to the better known feast of some minor saint from Ireland, who was alleged to have driven the snakes from that island," according to the website.

St. Urho is credited with saving Finland's grape crops by chasing grasshoppers from the country.
