WALLA WALLA—Blue Mountain Land Trust partnered with the Umatilla National Forest to bring BioBlitz to children in the Walla Walla Valley.

This Nature Kids event was supported by Blue Mountain Audubon Society, Sustainable Living Center, Tri-State Steelheaders, WWCC Water & Environmental Center, US Army Corps of Engineers, Walla Walla County Conservation District, Whitman College, Walla Walla Basin Watershed Council, and Outside the Lines Art Studio.

The event, held at Rooks Park in Walla Walla on Saturday, June 3, was a chance for the community to learn about the Blue Mountain region's ecosystems, waters, and wildlife.

Weller Public Library update for summer

WAITSBURG—Weller Public Library began its Summer Reading Program on June 1, 2023, offering every K-12 student in the Waitsburg school district a summer reading kit. Students received a nylon drawstring backpack, a Bingo Summer Reading Activity sheet, a pencil, a booklight for reading, a journal notebook, and a quilt-square coloring page.

When students participating in the Reading Bingo activity complete a line across, up, down, diagonal, or a blackout they will receive a free book and be entered for prize drawings.

The library received several grants supporting this year's Summer Reading Program in purchasing new books and supplies. The Yancey P. Winans Community Grant provided \$4,000 for books and programs, and Lisa Libraries donated 328 new K-12 books. The American Association of University Women (AAUW) gave the library \$2,500.00 to purchase new non-fiction books for children and young adults.

The library purchased five Science Backpacks, now available to check out. The backpacks include Geology Explorer, Woodlands Kit, Pond Explorer, Insect Explorer, and Backyard Explorer, and they provide everything needed to get outside and explore.

Thanks to the Winans grant, a new Singer sewing machine and sewing supplies are available to be checked out by library patrons. Library patrons can now pick up a sewing Take & Make Kit and borrow the lending sewing machine.

The Weller Public Library staff thanks the Waitsburg residents for their continued support for this valuable community resource and asset.

The Rotten Tomatoes website critics did not care for this movie, as they rated it as 47% favorable, but audiences disagreed and rated it 84%. It is rated PG-13 for some strong language and suggestive material. Runtime is 107 minutes.

ndy was born in Dayton, WA, on February 12, 1976, to parents Lupe and Marva. He was the first grandson born on both sides. He attended school in Dayton and received his GED from Walla Walla Community College. Andy married Debbie Porter on May 30, 1998, at the Hitching Post in Coeur d'Alene, ID. Andy not only gained a wife that day but also a 2-year-old son, Daniel. In 2001, they completed their family by welcoming their baby girl, Bethany. Andy considered being a father to Daniel and Bethany his life's greatest accomplishment.

Andy was a born farmer; at the age of two, he pulled up a newly planted garden because it was in the way of his farming. He grew up spending time on his aunt and uncle's farm in Dayton, where he took his first ride in a Caterpillar Tractor at the age of four, wearing little headphones they bought him. Andy worked in the fields with his uncle every chance he got. At the age of 10, he started driving the tractor on his own. Andy was always thinking, and his uncle was amazed that he could read his mind and lay out the fields exactly as they should be. Andy also loved Red Angus Cattle; he loved going to cattle auctions. When he wasn't farming, Andy played football and wrestled. Many remember the game he made five touchdowns; he was so fast nobody could catch him.

Andy had an amazing work ethic. In addition to working for James Farms, he worked for Water Watch Irrigation, Washington State Penitentiary, Beechinor Farms and was proudly employed as an Equipment Operator at 2M Farms at the time of his death.

When he wasn't working, he was spending time with his family; it was everything to Andy. He attended every sporting event and all of their school activities. One of his proudest moments was watching Daniel's Babe Ruth Team win the City Championship 3 years in a row. He was beyond proud when he got Bethany in a tractor-driving bank out wagon starting at the age of 12. He continued to support his kids in everything they did as they got older, enjoying so many annual family vacations to Seattle Mariners games and trips to the beach at Lincoln City and Depoe Bay, Oregon. Andy took his family to Yellowstone Park, Bear World, and Dillon, Montana, sharing things he remembered from his childhood and time spent with Grandma and Grandpa Mortier. After the kids grew up, he and Debbie loved traveling all over Montana and spending time at Flathead Lake. But Andy's very favorite vacations were the ones spent camping in the travel trailer, playing in the lake, having BBQs, playing Yahtzee out on the picnic table, and just sitting around the fire laughing and joking with his kids.

Andy loved farming, music, singing loud in the car, wildlife, and babies. Andy had an amazing sense of humor, and his smile could light up a room.

Andy and Debbie became grandparents in October when their son Daniel and his wife Kylee had a son. In honor of the father Andy was, his grandson

was named after him. Papa Andy was so proud – the first thing he did was go out and buy his grandson a tractor, which is also the same thing he bought Daniel on his 2nd birthday. It was his dream to continue the farming legacy.

Andy was looking forward to the wedding of his daughter Bethany to her fiancé Tony Emineth this June. Andy proudly went with Tony (and Debbie) when Tony picked out her engagement ring. He was also there at Bethany's dress appointment when she found her wedding dress. He was very supportive of Bethany and Tony in their new life together.

Andy is survived by his wife, Debbie; son, Daniel; daughter-in-law, Kylee; grandson, Baby Andy; daughter, Bethany and Son-in-law, Tony. In addition, he is also survived by his parents, Lupe Benavides, Marva Thomas; brother, Nick (Jolene); sister, Angie; stepsister, Jennifer (Eric) Villaro; stepbrother, Dean Halter; brothers-in-law, Tom (Kerri), Jeff (Melinda), and Todd (Tammy); sister-in-law, Jennifer Porter; and mother-in-law, Lawana Porter; plus numerous aunts, uncles, cousins, nieces, nephews, great-nieces, and great-nephews.

The RV Park was near downtown, so we rode our bikes to see the area. At first, we thought Prosser was not bike friendly, but we found a bike path that led downtown.



1 cup mayonnaise 1/4 cup buttermilk 2 tablespoons Dijon-mus-

3 pounds small new red po-

2 tablespoons whole-grain mustard 2 tablespoons fresh dill, chopped (or 2 teaspoons dried)

½ cup chopped celery ½ cup chopped spring or red onion

1/4 cup fresh parsley, chopped

2 tablespoons fresh chives, chopped Salt and fresh ground black pepper

Spring greens More herbs for garnish

Place all the potatoes whole in a large pot of generously salted water. Set pot over high heat and bring to a boil. Lower heat and simmer for 10 to 15 minutes, until the potatoes are just barely tender when pierced with a knife. Don't over boil them. Drain the potatoes in a metal colander, then immediately place the colander back over the empty pot and cover potatoes with a clean kitchen towel. Allow potatoes to steam for 10 to 15 minutes.

Meanwhile, make the dressing. In a small bowl, whisk together the mayonnaise, buttermilk, Dijon mustard, whole grain mustard, dill, and 1 teaspoon of black pepper. Season to taste with salt and set aside in the refrigerator.

When the potatoes are still warm but cool enough to handle, cut them into quarters or halves, depending on their size. Place the cut potatoes in a large mixing bowl. While the potatoes are still warm, add half of the dressing and gently toss to evenly coat. Add the celery, onion, parsley, and chives. Pour in more of the dressing and mix to thoroughly coat. Toss gently to avoid overly smashing the potatoes. Season with more salt and black pepper to taste. Refrigerate for a few hours to allow all the flavors to meld.

When ready to serve, arrange a bed of spring greens in a serving dish. Taste the chilled salad and adjust seasoning as needed. Potatoes will need more salt than you think. Mound the potato salad over the greens and garnish the top with more chopped parsley and chives. Serve cold

Notes:

This bright and herbaceous potato salad is a perfect accompaniment to grilled meats for your outdoor summer entertaining. Play with the fresh herbs you have on hand such as tarragon, basil, or marjoram. If the dressing is too thick you could add a drizzle of olive oil.

To add more seasonal flavor try adding some chopped snap peas or pea shoots. We had some tender fresh arugula in our garden which was lovely as a green base for the potato salad. Any seasonal baby greens could be used. For a vegan version you could try using vegan mayo thinned out with a little lemon juice and olive oil in place of the buttermilk.


