Bluewood to Open Friday

SKI AREA SOUTH OF DAYTON WILL OPERATE DAILY THROUGH JAN. 3, EXCEPT CHRISTMAS

DAYTON - The southeast Washington ski season begins Friday, as Ski Bluewood opens its mountain to skiers and snowboarders.

According to a press release, the Skyline here," said Bluewood General Manager Kim Express and Platter Pull lifts will operate beginning Friday, with the Triple Nickle lift to be determined. The ski area will open at 9 a.m., with rentals, food service and snow sports available.

Ski Bluewood will operate daily from its opening Friday through January 3, except for Christmas day. Hours are 9 a.m. through 4 p.m. daily, except December 24, when the mountain will close at 2 p.m.

"We're stoked that opening day is almost

SCHOOL BOARD APPROVES LEVY, BOND MEASURES

If M&O levy and capital improvements bond passed, taxpayer costs would remain unchanged

WAITSBURG - After many months spent deliberating, seeking estimates, and soliciting community input, the Waitsburg School board approved resolutions to place both a replacement M&O levy and a school facilities upgrade bond on the February 2016 special election ballot.

The proposed replacement M&O levy

would collect \$559,000 in 2017 and \$570,000 in 2018. The estimated dollar rate of the levy is \$3.55 per \$1,000 of assessed value in both years. The exact tax levy rate may be adjusted based on the actual assessed value of taxable property within the district at the time of the levy.

"At the current tax rates, there would be no change to the taxpayers," said Superintendent Dr.





Republicans will avert a contested convention

neculation over a contested convention -- when no candidate enters with the majority needed for nomination -- has picked up steam again. The Washington Post's Robert Costa reported last week that Republican National Committee chairman Reince Priebus met with senior Republicans about procedures, should an open convention develop.

Smart analysts are on board: Sean Trende at RealClearPolitics believes the "most likely scenario is still that no one wins a sufficient number of delegates to claim the nomination," while Nate Silver puts the odds "at about 20 percent."

We go through this every time. The RNC is doing its job by preparing for unlikely situations, but it doesn't mean they will arise. Or, at least, nothing about this cycle suggests the extremely small chance of a deadlock is any more likely than it ever is.

In short, candidates who are losing drop out. Winnowing works.

Yes, three or more candidates could theoretically remain in the contest after the first few events, winning equal (or close to equal) shares of the delegates. But that balance is difficult to achieve: Winners gain momentum, and losers see their resources dry up rapidly.

Besides, any party would be nuts to wait until the party's nominating convention to try to manipulate the final results. To understand why, let's look at how that process works.

In a normal year, the winning candidate going into the convention works with the larger party to control everything. This is backed up by the votes of delegates loyal to that candidate.

A contested convention would oc-

cur if there is not a majority among the 2,472 state delegates in support of one

Once the GOP convention begins in Cleveland this summer, the delegates are not beholden to do what the Republican National Committee or any other party group tells them to do. They might be likely to follow the lead of their candidate on any votes over credentials, procedures or platform. But no one can force them to. Some are technically bound to vote as chosen on the first ballot. But with no majority to steer the proceedings toward one candidate, there is no pressure on the delegates to remain loyal to the contender who chose them in the first place.

The results would be unpredictable in such a situation, and could lead to chaos, with efforts to unseat some delegates or to change the rules along the way, among other irregularities. If there were multiple ballots, it's unclear what would eventually resolve any impasse. In the old days a handful of party bosses could cut deals and enforce them. Now all 2,472 delegates would be free agents.

If party leaders want to influence what the convention is going to do, their best strategy is to pick a candidate to support in the primaries and caucuses, and use their resources to persuade voters to support that candidate.

While they haven't completed that process yet, it's well along the way. Only a handful of candidates in the GOP race are likely to survive Iowa and New Hampshire out of what was originally a field of more than 20 possible contenders. It's far more likely we'll have a clear nominee by March 1 than that we won't have one in July.

Carol Clarke.

Clarke said the funds will be used for maintenance operations but she is also investigating, at the request of the board, the cost of an ECEAP preschool program.

If the levy is approved, the district will qualify for levy equalization funds – state funds provided to areas with lower property assessments - unless the legislature discontinues that program. Currently, the state matches at 28 cents

"If it doesn't pass, we don't get those funds," said Board Chair Ross Hamann.

The proposed upgrade and improvements bond of \$4.8 million would replace the 1999 \$1.62 million capital improvements bond, used for renovations of the high school, which will soon be

Taxpayer cost is estimated to be between \$2.12 and \$2.14 per \$1,000 over the next 20 years, and the bond would need a supermajority to pass, Clarke

"We need to be careful how we say this. In essence, we are raising taxes because we are expiring bonds that we've worked hard to pay off and we're going back to ask for more. But it's not any more than they (taxpayers) are paying now," Hamann said.

The proposition authorizes the district to improve the learning environment and school safety through the installation of air conditioning in the elementary, middle and high schools; a complete renovation of the district kitchen; construction of a field house with restrooms, storage and concession areas; improving high school parking and the addition of lighting and walkways; and construction of an all-weather track and amenities.

Board members considered removing one or more of the projects, for fear they would be unable to complete them all, but ultimately unanimously approved the resolution as written.

"We've had experts tell us we can do it. There is a tremendous amount in there that they allow for prevailing wage and soft costs and they even allow for the fact that it will be a year later before we start soliciting bids. We've always been very responsible," Hamann said.

"There's no way we can really know until the bids come in a year from now," said board member Christy House.

TRUMP'S ATTACKS ON MUSLIMS BROUGHT HIM MORE MEDIA COVERAGE THAN EVER

'ust over a month ago, I wrote about how Donald Trump seemed to have lost his media mojo. At the time, television news coverage of his campaign had plateaued for more than six weeks, falling to either equal or below that of his GOP rivals.

But now he seems to have recovered from that lull. In fact, on Dec. 9, he reached a new record for the 2016 presidential race, accounting for 76 percent of all mentions of candidates of either party on national television news networks and 82 percent of mentions of the GOP candidates.

On Dec. 9, Trump received 3,919 total mentions on national television, setting an all-time record for his campaign. This was almost 750 more mentions than he received after his much-anticipated first debate performance on Sept. 16.

The massive surge in mentions of the candidate began Dec. 8 as he spent the morning defending his proposal to forbid Muslim immigration to the Unit-

But his surge actually can be traced

back further. It wasn't after the Nov. 13 Paris attacks - no GOP candidate received a substantial increase in coverage after the attacks.

Instead, it was after his Nov. 19 proposal to create a national Muslim tracking database. The timeline below shows the same data as above, but instead of raw mentions, it displays each candidate's percentage of all mentions of GOP candidates.

After Trump offered this controversial proposal, he went from 24 percent of all mentions of GOP candidates (which placed him under Jeb Bush) to 50 percent in just 48 hours. He then rocketed further - to 82 percent as of this past Wednesday.

This demonstrates, once again, how Trump has used inflammatory proposals and sound bites to dominate media coverage of the 2016 presidential race. The resulting outrage creates wall-towall Trump coverage. What remains to be seen is whether this will ultimately help or hurt him in the polls.

Nolan-Beasley Gains More Recognition

Presidential Award-winning teacher is now a semi-finalist for Shell Science Teaching Award

WAITSBURG - Kindergarten students in Waitsburg now have even more to brag about when they describe their classroom teacher. Presidential Award-winner Pam Nolan-Beasley is now a national semi-finalist, being recognized as a cream-of-the-Nol;an-Beasley crop science teacher.



Nolan-Beasley was one of two Washington teachers awarded the Presidential Award for Excellence in Mathematics and Science Teaching in 2012, She received a \$10,000 cash award and a trip to Washington

Last week Nolan-Beasley was notified that she is a national semi-finalist – one of ten – to receive the Shell Science Teaching Award. The award recognizes one outstanding classroom science teacher (K-12) who has had a positive impact on his or her students, school, and community through exemplary science

Nolan-Beasley has over 30 years teaching experience and has taught in Waitsburg's high school, junior high and elementary schools. She's been teaching Waitsburg kindergarten long enough to see her first classes graduate high school.

Nolan-Beasley has a special enthusiasm for science and says it is something she does with her students every day. She believes in introducing science as early as possible because it is natural for young students to engage in inquiry - a characteristic she capitalizes on to get them excited and passionate about science and learning in general.

"I believe we are missing an opportunity, not only to inspire America's budding scientists, but to teach reading, writing, math, language, the arts and social studies though our students' love of science. The use of nursery rhymes, poetry, guided reading sets, songs, read aloud drama and design accelerate learning for both literacy and science," she said, describing her teaching philosophy.

Nolan-Beasley incorporates science into subjects such as reading, writing, language, and social studies, and makes it relevant to everyday events. For example, during the holidays, she will read students the story of "The Gingerbread Man," and have them hypothesize, and then experiment on what will happen if a gingerbread cookie really does get wet.

Nolan-Beasley believes science should be D.I.R.T.Y., with the acronym representing: D-Discovery, I – Inquiry-Inspired and Ingegrated, R – Real and Relevant, t-Tactile, and Y – for the young.

Last year, she got permission from the administration and custodial staff to use the school's outdoor courtyard - which was slated to be covered in ornamental rock - as a learning lab. Her students planted carrot and pumpkin seeds, studying life cycles and learning about plant needs through first-hand experience. Her students collected data in notebooks and shared their scientific learning on the hallway wall so that other students could benefit.

"This fall, my current class had a Carrot Snack Party with the (now) first graders after harvesting last year's crop. In the future, I am hoping to write a grant for an irrigation system, with the work completed by local engineers and technicians, along with assistance from our kindergarten apprentices," Nolan-Beasley wrote, in her award application.

Nolan-Beasley believes in involving the family and holds a Kindergarten Family Science Night each year with nearly 100% attendance.

"My students love teaching their families, and the parents and siblings love the challenge and involvement," she said.

In an award recommendation letter, Waitsburg Schools Superintendent Dr. Carol Clarke praised Nolan-Beasley for her support of colleagues, as well as her students.

"While in the classroom, Mrs. Beasley models exemplary science instruction. However, her willingness to share her expertise, knowledge and skills in teaching other elementary science teachers set her above her peers. She is a highly sought after 'teacher of teachers' in our region," Clarke wrote.

Nolan-Beasley is a member of the Next Generation Science Standards Facilitators' Cadre, an elite group of teacher-leaders who represents the district for science education reform, and develops original lessons, materials and resources that align with Next Generation Science Standards.

She is also a Science Fellow for the Waitsburg School District, serving as a science contact for colleagues and learning providers. She has present-

ed 'Science for Our Youngest Learners' twice at the Washington State Preschool through Third Grade Starting Strong August Institute, and is looking forward to presenting at the NSTA National Conference in Nashville, Tenn. in 2016.

Nolan-Beasley's next step in the award process is to submit a 30-minute teaching video that demonstrates the teaching practices she described in her application. Judges will select three finalists from the submissions. They will visit the classrooms of the three finalists in late January and mid-February to see the teachers in action.

All three finalists will receive an expense-paid trip to attend the NSTA National Conference in Nashville this spring and will be honored at the teacher awards banquet. The award recipient will receive \$10,000.



Practice Makes Perfect

County and city employees reenact hazardous waste leak

DAYTON—Here's the scenario: At 8:00 a.m. a pick-up truck pulling a 1,000-pound tank of anhydrous ammonia down South Cottonwood Street in front of Kyle's Towing is backed into by another vehicle, causing the fertilizer tank to overturn. A small leak occurs from a valve at the back of the tank, coming out of the pump.

What happens next?

It is likely that most of us don't know; but it is a sure bet that there are people who do.

On Dec. 9, Columbia County **Emergency Management Planner** Mike Spring led representatives from Dayton General Hospital, the Columbia County Public Health Department, the City of Dayton, Columbia County Fire District #3, the Columbia County Sheriff's office, the Columbia County Dispatch office and the McGregor chemical company in a role-playing reenactment of the above situ-

According to Columbia County Fire District #3 Chief Rick Turner, there are several reasons for the "table top" exercise.

Turner said the exercise was designed as a self-test of each individual system, and is a useful tool to assess any shortcomings in

He said the primary concern is for the safety of the people directly involved, as well as for the public,

"We want to put the most efficient plan in place," he explained.

What is anhydrous ammonia, and why should we care?

According to the National Center for Disease Control anhydrous ammonia is made up of one part nitrogen and three parts hydrogen. It is a fertilizer.

Anhydrous ammonia is pungent, with suffocating fumes that can cause difficulty breathing, irritation of the eyes, nose, and throat. It can also cause burns, or blisters.

When released, the vapors initially move close to the ground, causing greater risk of exposure. High concentrations of it can lead to death.

Trevor Johnson, who represented McGregor Company at the exercise, said that 850 gallons of anhydrous ammonia can expand to 540 times that amount, if it leaks out. He also said that the vapor will boil if it leaks into the atmosphere, and that the vapor is drawn to water.

Chief Turner said that in a scenario like this one, the ammonia vapor could overcome people on the river levee. It could also get into the Touchet River, which would create problems for fish, potentially requiring involvement of the Environmental Protection

"It also has the potential to get into the city storm drains," he said.

"This is a good one to start with," said Spring. "There are ammonia trucks traveling on Main Street all day and all night at certain times of the year," he added.

During the reenactment exercise many steps were taken between the time the accident was called in to the Dispatch Center at 8:06 a.m. and the time McGregor Company could safely pump the

"It could take as long as seven or eight hours," Spring said.

At the end of the exercise, the representatives discussed and evaluated the exercise.

An After Action Review meeting is planned for December 16, according to County Emergency Management personnel.

There are to be other full-scale. multiple, and limited, table top exercises in 2016, according to Spring. Two of those exercises will emphasize hospital hazmat protocol and wildland fire, he said.

2016 Budget Adopted by **Dayton Council**

CODE ENFORCEMENT TOP PRIORITY

DAYTON—At their meeting on Dec. 7, the Dayton City Council approved a \$5,765,300 budget for 2016 that places hiring of a part-time code enforcement officer at the top of the list.

The code enforcement officer would be the primary contact for land use complaints, and would actively pursue and enforce city health and safety codes and ordinances, according to city officials.

City Clerk Trina Cole said that she is receiving more and more complaints from the public about people being out of compliance with the code ordinances.

We've had many complaints. People are not happy," said Cole. "There is a problem when it starts affecting neighbors and devaluating property," she added.

Mayor Craig George agrees. "Our number one priority is better code enforcement," he said.

George said there will be a six-month to oneyear educational component for the public, so that their rights and obligations regarding the codes are well understood.

\$33,400.00 is has been budgeted for hiring a code enforcement officer, working between 28 and 32 hours per week. An opening for the two-year position should be posted by the end of 2015, and hiring will be done in March or April next year, according to Cole.

- Utilize Department of Corrections personnel in the cemetery and parks for routine maintenance and cemetery tree trimming
- Design engineering for levee improvements
- Replace wood chips in the city park playground with an alternative material
- Implement Phase III of new sprinkling system in the park
- Implement power efficiencies at the sewer plant
- Perform a water-utility-rate study Make further contributions to the Commercial
- Street development project Focus on re-conditioning city alleyways
- · Create a community-wide street capital improve-
- ment funding package
- Reserve funding for a city dog park
- Make city hall electrical and plumbing improve-
- Update rolling stock for various utility departments
- Install a new shut-off valve at the reservoir
- Install a new park slide
- Begin work on the 2016-2018 Comprehensive Plan Update
- Update Title 5, Chapter 18 DMC, Historic Preservation
- Create a water splash pad park



After weeks of waiting, the Richards' finally learned that the estate would be sold as one piece, which included the home located on 10th Street in Waitsburg. They eventually received a letter asking them to move their animals and possessions from the pasture by Dec.

In the meantime, the Richards' had begun looking at a homestead owned by Mary Ballard, just east of Prescott. They placed an offer, had it accepted, and have been working steadily to get the pasture ready for Izzy and his

The Richards' say the new location is ideal and, though less visible, has several advantages over the Waitsburg

"It will be safer for people, safer for the animals, and there is a lot more room," said Tawnya.

Tawnya said the 21 fenced acres give

the animals a lot more room to roam. Izzy will be visible from Highway 124, but his visitors will turn onto Hart Road

The Richards' plan to create a large parking area along Hart Road, which will be much safer than the small turnaround where visitors currently stop, off Highway 12.

Tawnya said the house on the property needs extensive remodeling, which they have already started, but they hope to put their Waitsburg home on the market and move to Prescott this

She says they can't wait to finally be on the same property with their animals, rather than traveling back and forth several times a day to feed, water, and break ice in the winter.
