## Ambulance Honors Naumann with Building Name

### BOARD HONORS AEMT'S MANY YEARS OF DEDICATED SERVICE WITH WAITSBURG

WAITSBURG – Several local companies worked together to improve the driveway and move the flagpole outside the Waitsburg Ambulance Service last month. The chores will help beautify the lot for the future dedication of the building to longtime Waitsburg Ambulance Service Advanced Emergency Medical Technician (AEMT) and Chief of Operations Richard Naumann, who died in April.

Naumann, who passed away following a four-year battle with cancer on April 10, requested that his family not hold a service or place an obituary after his death. That request was honored, but the Waitsburg Ambulance Service Board felt it was fitting to pay tribute to the dedicated employee who had provided emergency medical care so faithfully in Walla Walla and Columbia counties for the last 20 years.

"The board really wanted to do something and couldn't think of anything better, because he spent so much time there (at the ambulance service office) and did so much for us and did so much for the community," said board president Jack Otterson. "He was

there all the time. We're definitely going to miss him, that's for sure."

According to fellow AEMT Sharon Brooks, Naumann had a true passion for EMS work which traced back to Vietnam, where he cross-trained as an army Medic/Med-Evac Crew Chief/Corpsman/Combat Medic in 1968.

When he returned stateside, he attended the University of Georgia where he earned his Bachelor of Science degree. "From the stories I heard, he was part of the beginning of EMS in Georgia," said Brooks.

In 1971, Naumann returned to his home state of California where he worked in cancer wards. He then went on to earn his Surgical Technologist, Licensed Practical Nurse, First Responder, Emergency Medical Technician, Senior Emergency Instructor and Advanced Emergency Medical Technician certifications.

After moving to Waitsburg, he worked full time at the Walla Walla VA Medical Center and spent 20 years providing and teaching emergency medical care in the Touchet Valley.

"He loved to teach and loved when the light came on in his students' eyes," said Brooks. "He probably instructed hundreds of students through the classes he taught at WWCC."

"Before he passed away, we told him that the building would be named after him. He was definitely surprised and very, very pleased," said board member Nancy Otterson.

## Memorial Honors Son, Dayton Grad

DAYTON – When their son, 41-year-old Dayton High School graduate Robert "Rob" Anderson, died unexpectedly on July 31, 2013, Carol and Andy Anderson wanted to find some way to honor his memory permanently in his own hometown.

Those who drive by or visit the Smith Hollow Schoolhouse, on N. Front Street, can now see this memorial – a combination bike rack and hitching post installed on the historic school's grounds.

"We didn't want to do some big elaborate thing, but we thought this would work well," Carol Anderson said. Rob Anderson was very athletic. "He rode his bike a lot, especially in college, and he was an avid skier and snowboarder. He almost grew up at Ski Bluewood."

At 15, he became passionate about wind surfing and traveled not only to the Snake River but also Hood River, on the Columbia, to pursue his favorite activity.

The hitching post, constructed around the metal bike rack, created not only a look that worked with

## Hospital Moves Forward with Upgrade

### CCHS executives will seek architect, plan to use Stroudwater Associate's concepts

DAYTON – Directors of the Columbia County Health System are moving forward with upgrades to Dayton General Hospital. The board unanimously agreed on Thursday that hospital district executives should secure an architect to draw up plans for the project using the Stroudwater report submitted to the board by an independent consultant firm in April.

"It makes sense given the information we have," Director Lisa Naylor said, and other members of the board agreed.

Financial reports prepared for the board indicated, as expected but not previously documented, that the hospital's imaging, lab and physical therapy departments contributed most significantly to the district's profit in 2014, interim CEO Jon Smiley explained.

The facilities plan created by Stroudwater Associates emphasizes development of these departments. "Community needs for core services, particularly emergency, diagnostic and outpatient services are not forecasted to decline," according to the report.

The board contracted with Stroudwater earlier this year to help determine the community's hospital needs after voters approved a \$5.5 million bond levy to improve Dayton General.

### Physical Therapy

Board members agreed on the importance of concentrating on urgent care, swapping emergency room and administrative entrances, but insisted on constructing a physical therapy pool despite Stroudwater's recommendation to hold off on that project.

"I think we will have a huge public relations problem if we don't move to the top of the list both increased services for physical therapy and the therapy pool," Director Jim Kime said, explaining that in many of his public appeals for support on last year's successful hospital bond levy he – and other board members –

The group, spearheaded by Kate Reeve of Waitsburg, took out a half-page ad in The Times seeking support from the public.

### Twenty-Five Years Ago June 7, 1990

Waitsburg Lions Club will hold its final meeting of the 1989-90 year at the cookshack on Monday (MONDAY) evening, June 11. This is a change from the normal Tuesday meeting night, primarily because of conflict with softball/Little League schedules. the historic school but also a place to mount the three plaques honoring not only Rob but also the friends, family and generous supporters who made the memorial possible.

The Andersons hope to also install a bench and a tree near the bike rack/hitching post in the near future; they are awaiting approval from the Blue Mountain Historical Society, which owns the Smith Hollow Schoolhouse.

Rob Anderson graduated from DHS in 1991 and went to college at Gonzaga, in Spokane. After college he moved to San Francisco and got involved in theater and film, attending graduate school and specializing in theater lighting and videographics.

"He met a lot of famous people and had a lot of exciting stories," Carol Anderson said. "He was in good health. We never expected this. After his death, we received letters from many people we didn't know."

His plaque ends with the words: "The wind changed directions, the stage lights dimmed, and he was gone too soon. His story unfinished."

"He was writing a film script before he died," Carol Anderson said. "And so, of course, he didn't get to finish it."

In addition to the supporters mentioned on the memorial plaques, Carol wanted to thank Sue and Don Rittenhouse, Ron Ashley, Steve Radebaugh, Larry Fairchild and Bill Clarys among others who helped with construction and installation.

"I just want to give a big thank you to everybody who put it together," she said. "The love that came through as they were helping with this project really helped us out."

Rob Anderson is buried in the Dayton Cemetery. The Andersons have two surviving sons: Brad Anderson and his family, who recently moved to Walla Walla, and Ken Anderson, M.D., in Lewiston.

## Swim Season Is Just Around the Corner

### Waitsburg Pool Update

The Waitsburg City Pool, with a newly replaced liner, will open for business at 1 p.m. on June 15. Lifeguards for the 2015 swim season are Paige Wood, Devin Newman, Caitlyn Jones, Cameron Terry and Tayler Jones.

Pool Hours are Monday through Friday from 1 to 5 p.m. and 6 to 8 p.m. Lap swim is Tuesday and Thursday from 5-6 p.m.

An anonymous donor has provided funds to cover staffing so that the pool can be open on Saturdays from 1-5 p.m. The donor hopes to provide an opportunity for parents, who work during the week, to enjoy the pool as a family on Saturdays.

The daily swim fee is \$2, which includes both daytime and evening swim sessions. Individual passes are \$40 and a family pass is \$80. Family passes are limited to five people, with additional family members added at \$10/per person. Passes may be purchased at City Hall (147 Main).

Swim lessons are offered in two-week sessions, running Tuesday through Friday from 11 a.m. – 1 p.m. The first session will run July 14 through 24.

Times for lessons are: Level 4: 11-11:30 a.m.; Level 3: 11:30 – noon; Level 2: Noon-12:30 p.m.; Level 1: 12:30 p.m. – 1 p.m.

Classes are limited to 10 participants and are filled on a first-come, first serve basis. Register at City Hall or call Kelly at (509) 337-6371.

Children must be at least 3 years old, able to hang onto the edge of the pool for an extended period of time, and able to follow instructions.

A second session, if demand warrants, will be held July 28 – Aug. 7. An endowment from Friends of the Waitsburg Pool keeps lessons free for all Waitsburg residents.

## Longtime Dayton Elementary School Librarian Retires

MRS. EDWARDS SPREAD HER LOVE OF READING TO STUDENTS AND STAFF OVER THE LAST TWO DECADES

DAYTON – Watching Roslyn “Roz” Edwards read aloud to a group of children at the Dayton Elementary Library, where she has worked as librarian since the ‘90s, is like seeing her on the stage of the Liberty Theater, where she has performed in various roles for more than a decade.

“She’s funny because when she reads a book, she actually sounds like the characters,” said Dayton third-grader Cami Martin. Exactly. She does *all* the voices. She interacts with her audience: “What is happening here? What’s that silly cow doing now, Jack?”

“With her friendly smile and her theatrical talent, Roz makes the library not just a library, but a fun and entertaining place for students and teachers,” said elementary teacher Brenda Henderson.

After 22 years at the Dayton School District, Edwards is retiring at the end of this school year. She will be sorely missed.

“Mrs. Edwards is theatrical, creative, prayerful, caring and funny,” said Zaraheth Griffen, a secretary in the elementary school. “She’s easy to get along with and fun to be around. She will most definitely be missed.”

Edwards first came to the district as a volunteer in 1993. She then became a substitute para-educator in roles throughout the school district, including working with the Seneca migrant program each spring and helping with music in the classrooms.

When the previous elementary librarian, Terri Viola, decided to return to college to earn her teaching degree, she asked Edwards if she would substitute for half of her shift in the library.

“In the ‘90s, it was still a full-time job,” Edwards said. “With the nod from the administrator, after I said ‘Sure!’ I stayed there for about two years until she (Viola) moved away, then just stayed, since I loved the kids and of course children’s books so much.”

Edwards, whose mother was the elementary school librarian in her hometown, had books, children and libraries in her blood even before she came to Dayton with her children and her husband, Steven Edwards, who was pastor of the Dayton First Congregational Church from 1993 until his death in 2010.

Edwards was a student helper in her own high school library; as an adult she was a parent co-op preschool facilitator in Kettle Falls in the 1980s, reading program volunteer in Portland in the ‘90s, and circulation desk employee at her husband’s graduate school, George Fox University, from 1990 until they moved to Dayton three years later.

“I have enjoyed the kids, the books, the gentle power I have in spending budget money on new books (It always feels like Christmas!) and my very supportive co-workers,” Edwards said. “But most of all, above all, the excitement in the eyes and voices of the emergent readers who feel like they just walked in to Disneyland or a candy store. That’s how much they love books. On tough days they are the ones who restore my faith in the love of reading.”

Co-workers and students have said they will miss everything about Ed-

wards, from her energy and passion to the way she genuinely cares about people.

“Roz has one of the most important qualities for a being a librarian – she is an avid reader,” said elementary teacher John Lindsey. “She always has a new book that she has read, and she knows if you will like it. She knows each student’s reading habits and what genre they like, that is if *they* are avid readers! She gives gifts to people. When she knows you have a favorite book, you might just find a copy of it on your desk because ‘she thought you should have your own.’ Roz has gone the distance in promoting reading. Her retirement will be a loss to our school children because of her infectious love of reading.”

One student put it quite simply: “She believes in you,” said third-grader Mallory Dowdy.

It hasn’t all been rosy days of read-alouds and sparkling, excited school children. “One of the biggest challenges has been trying to get everything done well with limited time,” Edwards said.

“I think about my job, books and kids all summer, and even in the middle of the night,” she said. “I don’t think that will stop just because I am retiring. It is also hard to act perky when I am tired or not feeling well. But hey, those kids don’t deserve a crab in the library, so I just put on my best smile (thanks, Mom!) and act the part. Pretty soon I don’t have to act. Kids are so darn loving and forgiving. I really don’t have any bad days.”

And hey – acting is also second-nature for Edwards. She and her husband were some of the original members of the Touchet Valley Arts Council and helped restore the old Liberty Theater to its new glory. She’s a well-known figure on the stage.

“The theater is a huge part of my life and passion, and always will be,” she said. “Steve and I helped to open the Liberty doors back in 2001, and I have been in every play since then. I had to miss a couple of variety shows due to knee surgeries, but I did ‘melt’ as the Wicked Witch with a torn meniscus! I will do just about anything to be on that stage!”

“The people are a true extension of my family,” she said. “The theater is also a safety net for the youth and young adults who often march to a beat of a different drum. I only wish I had had such a place when I was growing up.”

Edwards plans to continue doing all the things she loves and has always done away from school, “but more gently and slowly,” she said. She hopes to volunteer, substitute, travel, garden, write, minister, act, “and, for a while, sleep!”

“I will miss the hugs, smiles and excitement from the children,” she said. “On days when I didn’t feel like I looked so great, there were always kids who thought I was pretty, or loved what I was wearing, or told me, ‘You’re the best librarian ever!’ Imagine what our world would be like if we all treated each other like that. I know how good it made me feel.”

Edwards leaves a legacy of enthusiasm toward books and reading, and a great collection of books, Superintendent Doug Johnson said. The district has already lined up a new elementary librarian, who has been training with Edwards and is excited to get started – local woman Ashley Kilts, who will begin in the fall.

“Mrs. Kilts is bringing new, fresh ideas that will continue to encourage kids to read and love books,” said elementary Principal Pam Lindsley.

# School Board Update

May 13, 2015

Board of Directors: Ross Hamann, Christy House, Marilyn Johnson, Randy Pearson, Greg Zuger. Randy Pearson was absent.

## Facilities/Transportation/Maintenance Supervisor's Report (Colter Mohny):

Updated board on motor pool and suggested the district surplus two older buses and purchase a smaller GM bus, with handicap accessibility, with 80,000 miles, available for \$2,500. Mohny provided quotes for two new, two-wheel drive busses, and requested the board approve him a purchase amount. The board approved up to \$65,000 toward the purchase of a new, larger bus and board members will check out the \$2,500 used, smaller bus.

## Superintendent's Report (Dr. Carol Clarke):

Enrollment is 291.4 students. Clarke updated the board on a visit from Washington State Schools Superintendent Randy Dorn and Assistant Superintendent Dan Newell.

Updated on new grade level assignments following the upcoming retirement of 4<sup>th</sup> grade teacher Margie Douglas. Elementary teachers are: Pam Beasley, kindergarten; Dinah Lindsey, first grade; Wenda Parr, second grade; Marne Henderson, third grade; Deanna Coulston, fourth grade; Gabe Kiefel, fifth grade. Sarah Reser will teach all sixth grade classes at the middle school. Lynnsey Bailey will teach middle school social studies and language arts. A high school social studies remains open.

## New Business

### Technology:

Ken Beasley provided a technology update and suggested a plan for updating/upgrading current computers and infrastructure.

### Instrument Rental Fees:

Clarke commented that she receives complaints from parents required to pay the \$50 annual instrument rental fee for sixth grade band, which is required in the district. She said parents didn't feel they should have to pay extra for required classes and suggested the board drop the rental fee for sixth grade students. Marilyn Johnson said she would like to see the fees dropped, or made optional, for all band students. Greg Zuger felt the rental fee held parents accountable to care for the instruments. Christy House motioned to drop the rental fee for sixth grade students but the motion died for lack of a

second and the fee structure remains the same.

## 2015-16 School Calendar:

Clarke presented the 2015-16 school calendar which begins Sept. 8 and ends June 10. Christmas vacation begins Dec. 18 and ends Jan 4. Spring break would be April 4-8 with no snow days built in. Clarke said the community would be advised that any snow days would extend the end of school date. Christy House said she couldn't, in good faith, approve a calendar with no snow days because parents make plans and would be frustrated when school didn't end when they assumed it would.

Clarke said the Tues. after Labor Day in 2015 is the latest it will ever be and, with two buildings without air conditioning, the desire was to get students out as early as possible, so snow days were dropped. Board Chairman Ross Hamann said that snow days were added fairly recently and have only been used twice. He commented that the community appreciates including the snow days and view it as prudent planning. He suggested that, if the board approves the calendar without snow days, it not be precedent-setting. The board approved the calendar as presented, with House in objection.

Following the vote, Wooderchak expressed concern with the two full weeks off at Christmas. "As I see our community poverty rate increase, I envision students from Dec. 18 to Jan. 4 without nutrition – breakfast and lunch programs – at a time when finances may be directed more toward heating and holiday expenses." She said she would like to voice that concern so that it could be considered in future years. Zuger expressed frustration that the issue wasn't brought forward earlier and Wooderchak said it wasn't her place to participate in discussion prior to the vote, but reiterated that she would like the issue considered in future years.

## Board Meeting Change:

Board approved moving June's meeting from June 10 to June 17 to accommodate a retirement party for Mrs. Douglas on June 10.

## Personnel:

Board approved hire of Troy Larsen to replace Jeff Bartlow as high school football coach.

promised these very services.

Smiley, with Chief Operations Officer Shane McGuire, told the board they think a two-person pool with a submerged treadmill, which offers the same physical therapy as a regular PT pool but in a much smaller space, could be constructed for no more than \$200,000. This idea was well-received by the directors.

Plans to relocate food service close to Booker Rest Home, however, were criticized. The board agreed with both Smiley and Stroudwater Associates on their recommendation that this relocation, estimated to cost nearly \$500,000, be put on the back burner at this time.

"What happens if we go ahead and move food service closer to Booker, and the state drops reimbursement to 16 percent, as they're looking at now, and we end up losing Booker," Director Ted Paterson said. "Then we've relocated food service to a part of the building where it's not needed."

### Next Steps

The board has directed Smiley and McGuire to begin the process of finding an architect to turn the Stroudwater recommendations into a remodel design. These plans, once approved by the

board, will still have to go through the Department of Health, McGuire said.

"And they don't say it will take 90 days; it takes as long as it takes," he said. He and Smiley predicted the entire planning process could take until mid-October or November.

All of the redesign work, except for the pool, is inside work, however, and shouldn't be hampered much by weather.

"The biggest challenge with this type of work is how to phase it so that services in the hospital can continue without interruption," Smiley said.

The board hopes to keep a tight rein on the project and participate in decisions made along the way as far as which phases of the project are completed when. "My biggest concern is sequencing," Kime said Thursday.

### Information Technology

One particularly nasty fly in the ointment for this project, however, is information technology. The board, together with Smiley and McGuire – who also holds the title of IT Director for CCHS – discussed IT at length prior to the hospital redesign discussion.

"We have to get everyone on a universal system," Smiley said. "We need to consolidate all patient records into one common system."

One indication of the problem with

software systems not communicating with each other was the length of time it took for staff to produce profit and loss statements for each hospital department so the board could decide on the best way to redesign the hospital.

Currently, between the hospital departments and the two clinics, four different computer systems are being used for tracking and storing patient records and all other types of documentation, McGuire said. The hospital spent thousands of dollars five years ago for a new records system, but that system is now outdated and doesn't produce the records needed or even required.

"Five years is a long time in terms of technology," McGuire said. And now the more robust patient software systems are becoming affordable.

He predicted that \$300,000 - \$450,000, plus monthly service fees, would cover the cost. The system installed five years ago cost \$1.2 million and didn't meet everyone's needs, he said.

The IT problem isn't integral to the hospital redesign plan, and the board has not indicated any plan to address the problem or use levy money for this purpose, but board members agreed it would need to be looked at soon.

"If we're going to enhance the system with this remodel, does it make sense that the IT system has sent us

back to a clipboard hospital?" Paterson questioned.

### Other Concerns

During Thursday's board meeting, Interim CEO Smiley mentioned several other ways of improving not only performance at CCHS but also increasing revenue. One issue was billing.

"We're in a good position, with our size, to do billing here," he said.

He recommended that the board consider a phased return to local billing (CCHS billing was outsourced several years ago), which could save the district over \$200,000 annually.

The first thing to bring back, he said, is Medicare and Medicaid billing. Secondly, the hospital district should do its own group and private insurance billing.

"We could then contract out the private pay," he suggested; stating that this would relieve local staff in billing from potentially having to contact someone they know in the community about overdue medical bills.

Another idea Smiley shared with the board is a renegotiation of contracts with insurance companies. "Most contracts are paying at 40 to 45 percent of what's billed," he said. "One future thought is to see if we can get a bigger percent on these."

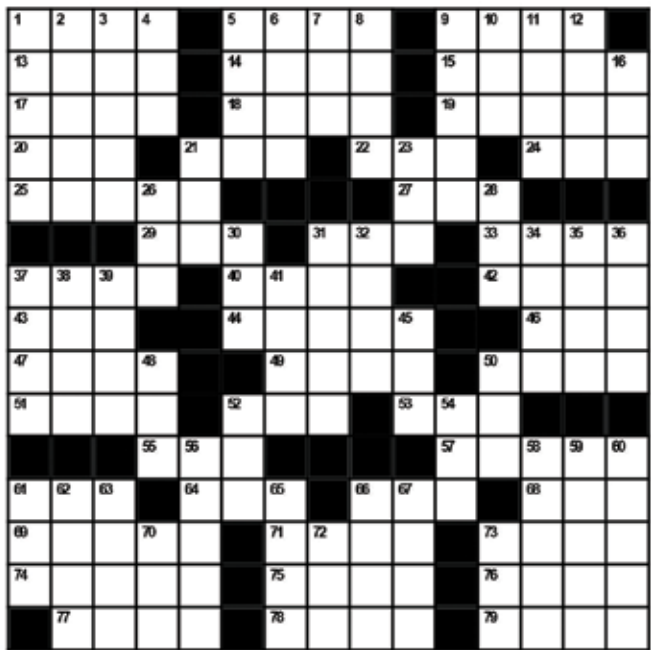
