He graduated from Waitsburg High School with the Class of 1970. Marie's great-grandmother's family settled in Milton-Freewater after enduring hardships as they traversed the Oregon Trail. Marie grew up in Walla Walla. She graduated from Wa-Hi with the Class of 1974. Growing up, she was a member of 4H and has always loved horses and gardening.

Marie and Louie married in 1977 and began their life together in Waitsburg, completing the construction of their custom home in 1986. They welcomed their sons Jarod in 1983 and Mitch in 1985. Marie worked at the Waitsburg Post Office as a rural route carrier, retiring in 2015. Louie retired from the Port of Walla Walla as a Water Distribution Manager at the Walla Walla Airport in 2017. He also worked for the City of Waitsburg and volunteered at the Waitsburg Fire Department.

Over the years, the Gagnons proved two are better than one. They are at their best working and volunteering together, whether driving wheat trucks and pea combines, serving on boards, cleaning, landscaping, or supporting area non-profits.

The Gagnons have been on the Waitsburg Town Hall board since 2019 and are active members of the Waitsburg Presbyterian Church. The couple were honored by the Waitsburg Commercial Club with the 2020 Citizens of the Year Award after being nominated by Jim Davison.

Louie has been in the Lions Club for over 35 years, served as Lion's Club President, and is a board member. He was awarded the prestigious Lions Club's Melvin Jones Award for outstanding service. Marie serves on the Weller Public Library Board of Trustees.






Ruppenthal selected for council seat

Changes to the uitility late fee waivers, concerns about community drug use discussed.

WAITSBURG — The Waitsburg City Council met at the city hall conference room on April 17, 2024. Council members Jim Romine, Jennifer Bishop, Juliian Henze, Keven House, Mayor Marty Dunn, and City Administrator Randy Hinchliffe were present. The council discussed and approved the annexation of property owned by Timothy, Patresa, and Nancy Mathews into the city.

The council approved amending Chapter 1 of Title 9 of the municipal code to add hardship relief for late fees on utility accounts due to compromised bank accounts.

The council interviewed Karen Gregutt and Court Ruppenthal for the vacant council vacancy. Both candidates previously served on the council, with Ruppenthal recently serving a two-year term. Gregutt is the chairperson of the Waitsburg Planning Commission.

The council appointed Ruppenthal to fill the remaining two-year term vacated by Randy Charles.

Bart Baxter from Parks and Recreation asked if Ruppenthal would return as the council representative since there has not been one since the beginning of the year.

The council members gave their reports. Henze told the council that the library received a grant for City council member the summer reading program, and Walla Walla Electric donated an installed heater.

Henze reporting for the Community Health and Protection Committee said a portable AED device and Narcan will be provided to the Waitsburg Grocery. An AED, or automated external defibrillator, is used to help those experiencing sudden cardiac arrest. It's a sophisticated, yet easy-to-use, medical

Narcan is the brand name for Naloxone, a lifesaving drug to treat overdose from opioids, including heroin, fentanyl, and perscription medications.

The store's staff will be trained in the use of the system and the drug which will be available to the community for emergencies during the stores oper-

Romine shared reports from concerned parents that the soft lockdown at the Waitsburg High School was due to Fentanyl use by two students. After the meeting, in a post on Facebook, Romine corrected the information after one of the student's parents contacted him, saying the substance was not Fentanyl.

Romine apologized for the error but reminded residents that as one of two council members on the Community Health and Protection Committee, he is tasked with bringing health and safety concerns to the city council.

In the post, he said, "As a parent and grandparent, I strongly urge every Waitsburg resident to be aware of challenges facing family members, especially our youth. We may not know all the facts, but knowing there is a problem is vital."

He offered to sit down with anyone with concerns, saying he wouldn't put himself out there if he

didn't care. House reminded the council of upcoming events, including the Lions Club Rib Feed on May 4, Celebration Days on May 17-19, and the Junior Livestock Show on June 1.

Bishop asked if the Mi Pueblito food truck was allowed to sell food in the city. Hinchliffe said they are welcome to do business as long as they have passed County Health Department requirements.

DAYTON SCHOOL BOARD APPROVED LEASE, **RESCHEDULES MAY MEETINGS**

DAYTON - The Dayton School Board met in the High School Library at 6:30 PM on April 17, 2024. School Board members present were Chair Jeffrey McCowen, Zac Fabian, Ryan Paulson, Aneesha Dieu, and Grant Griffin. Superintendent Rich Stewart was also present.

The board approved the consent agenda, which included the approval of Kelly Steinhoff as a middle school track volunteer, Adam Puckett as MS Head Baseball Coach, and Carlos Norris as MS Assistant Baseball Coach. The consent agenda also included the resignation/retirement of Terry Lambert as a bus driver.

Athletic Director Sam Korslund said the HS baseball and softball teams were likely to qualify for the district tournaments, with the baseball team at 9-0 and softball at 6-2. He also reported that the MS baseball team has nine students participating, MS softball has 12, and MS track has 14. Korslund said that Dayton restaurant R&B Barbecue will start selling food at some sporting events.

Elementary School Principal Amy Gillick said Cinco de Libro Night is scheduled for May 1, 2024. She shared her time as the dunk tank target for students who met reading goals.

Guinevere Joyce, the secondary school principal, reported on the

school's progress in climate, communication, and academic excellence goals.

Stewart presented the maintenance, operations, and grounds report for John Delp. He said the HVAC project is well underway. New ducting is being installed, and six classrooms have had HRV (Heat Recovery Vessels) installed so far. Electricians are installing new distribution panels in the boiler room and two other locations.

Stewart asked to reschedule the board's May meetings to avoid conflicts with Cinco de Libro Night on May 1 and the Hidden in Plain Sight event at The Liberty on May 15. The new dates are now May 8 and 22.

Jana Eaton gave the financial report saying that everything is on target in the general fund, and she is considering a budget extension because revenue may come in higher than expected. Stewart said the district was applying for grants to improve some classrooms.

The board conducted the first reading of several policies. The board approved the new 50-year lease agreement for the sports fields with the City of Dayton.

The meeting went into executive session to discuss an individual's qualifications for public employment for 15 minutes with no action to follow. The next meeting is scheduled for May 8, 2024.

CARDINAL TRACK AT COLFAX

WAITSBURG — The Waitsburg High School track team competed against twenty-two schools in Colfax in its last big invitational meet on Saturday, April 20.

Teegan Kenney placed 7th in the long jump (18' 61/2"), and Blake French placed 8th in the triple jump (35' 91/2").

Alyssa Hollingsworth had a PR of 2:52.23 in the 800-meter for 12th place and tied for 15th in the long jump (12' 9 /12"). Makenna Barron placed 8th in the high jump (4'2").

The last meet of the regular season will be on April 30 in Pomeroy, with nine District 9 schools attending.

This year, the district qualifying meet was eliminated. For each event,

the top 16 athletes from District 7 (Northeast 1B) and District 9 (Southeast 1B) will combine to move on to regionals. The placement will be based on the season's best performances. (PRs from any meet during the season). The Cardinal men's 4x100 relay team is number one so far this season.

Qualifying athletes will then train for regionals, held on May 15th and 18th in Ritzville. The top five boys and top four girls from each event at Regionals will advance to the state championships.

Caraway Snickerdoodles

While experimenting in the kitchen, I love when the addition of a single extra ingredient can elevate a classic recipe in exciting new ways. Here the homey snickerdoodle, a buttery cookie steeped in childhood memories, has crushed caraway seeds added to the cinnamon coating for a sophisticated twist on the warm-spice notes. Delightfully chewy, and not too sweet, these lovely morsels have an addictive flavor.



Ingredients:

1 cup unsalted butter (2 sticks), softened

34 cup granulated sugar

34 cup light brown sugar

2 large eggs

2 teaspoons vanilla extract

2 3/4 cups all-purpose flour 1 ½ teaspoons cream of tartar

½ teaspoon baking soda

1 teaspoon fine salt

For spice coating:

¼ cup granulated sugar

1 ½ tablespoons ground cinnamon

1 teaspoon caraway seeds, crushed Turbinado sugar

Directions:

Preheat the oven to 350 degrees. Prepare baking sheets by lining with parchment paper.

In a large mixing bowl, combine the butter and the two sugars. Using an electric hand mixer (or a stand mixer), cream the butter and sugars for 4 to 5 minutes until light and fluffy. Scrape the sides of the bowl and add the eggs and vanilla. Cream for another 2 minutes, until well mixed and fluffy.

Stir in the flour, cream of tartar, baking soda, and salt until just combined. Cover the bowl and let the dough rest in the refrigerator for 20 to 30 minutes. Meanwhile, in a small bowl combine the ¼ cup sugar, cinnamon, and crushed caraway seeds.

Use a heaping tablespoon to scoop out about 24 equal size lumps of dough. Then with clean hands, roll the dough into smooth round balls. Roll the dough balls into the bowl of spiced sugar, pressing as you go to make sure the dough is completely coated in mixture.

Place dough balls on prepared baking sheets 3 to 4 inches apart from each other. If you want a flatter cookie you can gently press down at the center of each ball. Sprinkle a little turbinado sugar over the top of each cookie. Place baking sheets in the hot oven and bake until cookies are just set, about 9 to 11 minutes. Snickerdoodles will not brown and might look slightly underdone when you pull them from the oven. Allow cookies to cool on the baking sheets for at least 10 minutes before removing with a spatula. Serve warm or at room temperature and store in an air-tight container.

Notes:

The caraway seeds add a delicious and unexpected earthy, floral flavor to this classic cookie recipe. Crush caraway seeds in a mortar and pestle or with an electric spice grinder. You want them to have a little texture, so don't crush to a fine grind. You could also place the seeds between two pieces of parchment paper or plastic wrap, and crush with the back of a heavy pot or with the flat side of a meat tenderizer. Try experimenting with other interesting warm spices such as fennel seeds, star anise, or cardamum. A pinch of fresh ground black pepper can also add a unique

This cookie dough freezes beautifully, if you want to have them ready to bake for unexpected guests. I like to scoop the dough and freeze on a sheet lined with parchment until totally frozen. Then they can be placed in a freezer bag or other container. Before baking, roll the frozen dough into the spiced sugar mixture, then allow the dough to sit at room temperature while you preheat the oven.

Lovely with tea, or a scoop of ice cream, these homey cookies are a favorite in our home. Enjoy.




