## Marne Henderson Takes a Step Forward

### RETIRING WAITSBURG THIRD-GRADE TEACHER WILL BE NEW YOUNGLIFE AREA MANGER

WAITSBURG – For Marne Henderson, this will be the first August in 15 years that she hasn't spent time setting up her classroom at Waitsburg Elementary School. Henderson exited her position as third-grade teacher in June and says she feels the time is right to pursue her passion as YoungLife Area Manager.

Henderson is a fourth generation Waitsburg High School graduate. She attended Eastern Oregon College and Walla Walla Community College for one year each, playing basketball at both. She then went on to earn her Bachelor of Education degree at Eastern Washington University.

Henderson said her own third-grade teacher, Anita Baker, ignited her desire to teach.

"I enjoyed her tough love. She was caring but held us accountable. It was in third grade that I learned I was an OK reader and that reading was enjoyable," Henderson said. "I fought the desire for quite a while and took business courses in college. But my first year at Eastern I realized I really wanted to be with kids and changed by major."

Henderson worked as a substitute teacher in Dayton, Waitsburg, Prescott and Walla Walla for two years before taking a full-time job teaching grades 4-8 at the Blue Mountain Christian School in Dayton, where she taught for eight years.

She was hired in Waitsburg in 2003 to teach a grade 4/5 combination class. Over the years, she taught grades two through eight, and ended teaching third grade. Henderson said she can't pick a favorite grade when it comes to teaching.

"In a small school you get to watch kids grow and I love watching their personalities

change through the years. It was fun to see them learn, gain new interests and relate to different subjects," she said.

Henderson said she is known for her silliness. An example is her title as Champion Cupcake Eater. When a child had a birthday, they could bring a cupcake for Henderson and she would regale the classroom with her unique ability to down the entire thing in one mouthful.

"Being silly is a good way to help kids relate to you. I like to bring fun and silliness to the classroom and balance it with serious learning," she said.

Henderson was also known for her frog decor.

"When I left the Christian school, I knew it would be hard to teach somewhere that I couldn't share my faith. So I started collecting frogs. The acronym FROG stands for Fully Rely on God. When kids asked why I had so many frogs, I could share that with them. By the end of last school year, I had 160 frogs in my classroom!" she said.

## Dayton Alumni Association Provides Funding for Students

### ASSOCIATION IS LAUNCHING NEW FUNDRAISING EFFORTS TO HELP WITH SCHOLARSHIPS AND STUDENT ACTIVITIES

DAYTON—Newly elected Dayton High School Alumni Association President Cara Watts has some ideas about how to infuse the association's coffers with some much-needed cash so that giving back to DHS students can continue.

"I don't think people understand how much the Dayton Alumni Association gives back," she said.

Historically, the association has provided funds through membership dues, donations and memorials, for Youth and Government, FBLA, uniforms for Dayton cheerleaders, and scholarships for higher education.

This year DAA was unable to provide money for any new scholarships, due in part to dwindling membership, Watts said.

"It was the smallest alumni parade I think they've had in a long time," she said.

Watts has some ideas to help. She wants people to know that anyone can donate to the Dayton Alumni Association.

"Anyone can; you don't have to be a Dayton Alumni. It can be anonymous or not," she said.

She said memorials can be set up through the association, as well.

Watts showed off examples of plaques the Alumni Association is selling engraved with the Dayton bulldog mascot and graduation year. Former DHS students are encouraged to buy one with their graduation year as a memento, and to support the Alumni Association scholarship fund. The price is \$36, or more if the purchaser would like to add a donation.

The plaques were made locally by Stephen Gregg, of Stephen's Woodcraft, in Dayton, out of wood milled by local resident Steve Radebaugh. Gregg and Radebaugh will donate a portion of the sales to the Alumni Association.

## PIONEER PORTRAITS

### Ten Years Ago-August 7, 2008

Nearly 30 volunteers gathered at Ye Town Hall to talk plans to "Paint the Town" and more volunteers will be needed, say project directors Leroy Cunningham and Jim German. The project entails giving every building in the business core of Waitsburg a fresh paint, Cunningham said. The informal organization has already procured a donation of paint from Columbia Paint in Walla Walla, he told the group.

Lydia Roberts, a member of the Waitsburg International Order of the Rainbow for Girls, journeyed to Chicago in July to attend Supreme Assembly. Roberts, 19, is the daughter of Ken and Dawn Roberts of Waitsburg. Roberts was one of the 35 girls from Washington State and the only Waitsburg member to travel there with a group from the Tri-Cities.

Harvest operations in the Touchet Valley and southeastern Washington are in full swing, and a better picture of the crop is coming into focus, reports J. E. McCaw, local manager of the Northwest Grain Growers Waitsburg office. The late heat may have helped protein levels in Dark Northern Spring Wheat crops locally, McCaw noted. He hasn't heard any remarks about spring wheat yields as of early this week, but the general expectation is for some decline there.

On the instructor's count, we did pushups until we were exhausted and he was satisfied. He ordered us up, took a softer tone and explained. "Guys, competency in these skills may not just to save your life, but the life of your partner or a citizen. It doesn't matter what task it is in your job; you have to know your stuff." It was a very simple lesson, we had to be competent. The pushups were so we never forgot.

During my career, I have seen sheriffs elected or appointed solely off a familiar name or "good ol' boy" endorsement. Though well-meaning or a nice guy, it is no guarantee of competency. When likeability is the only qualification considered, the results are disastrous. Likeability alone will not help a Sheriff when the tough calls come.

# Bicycle Rodeo Coming to Waitsburg

“BIKES ON THE ROAD” WILL GIVE KIDS CHANCE TO IMPROVE BIKE SKILLS

WAITSBURG – For years, summer in Waitsburg has been an excuse for residents of all ages to pump up their bike tires and two-wheel their way through the streets. But this year, Waitsburg’s youngest cycling enthusiasts are getting a little extra incentive to use pedal power: the Bicycle Rodeo is coming to town.

The event, called Bikes on the Road, will be held August 16, from 9 to 11 a.m. It is sponsored by the Walla Walla County Traffic Safety Task Force.

Bikes on the Road will give kids of all ages the opportunity to challenge their bike skills on an obstacle course in the Preston Hall parking lot. But more importantly, they’ll have the chance to learn facts about bike safety, get a complimentary bike tune-up, and even be fitted with a new helmet – all free of charge.

The program, according to Nancy McClenny-Walters, the task force’s Target Zero manager, has been widely successful in Walla Walla and College Place. While the event is largely geared towards grade-school children, she adds that the whole community is welcome: “We have fit older kids with helmets, and we have even fit parents with helmets.”

The bike rodeo will be held in the parking lot of Preston Hall and on the adjoining blacktop area of the elementary-school playground. Participating young-

sters will need a signed permission slip from a parent to participate – these forms can be obtained at the event itself or at Waitsburg Christian Church during registration for vacation bible school on August 13.



Once signed in, participants will be able to “spin the wheel” and answer age-appropriate questions in a bike-safety trivia game. Afterwards, volunteers will take a look at their bikes and perform minor repairs if necessary, ranging from bolt-tightening to tube replacement.

After participants’ bikes are road-ready, riders move on to another “checkpoint,” where other trained volunteers will adjust their helmets to ensure a proper fit. If a participant’s helmet is the wrong size – or if they don’t have one in the first place – free helmets are available in sizes small through extra-large.

After completing these activities, young racers can try their hand at the obstacle course before accepting a goodie bag containing a certificate of completion, a card containing information about Washington State’s bicycle laws, and stickers. To help participants beat the heat during the event, water and popsicles will be provided.

Volunteers, especially those with cycling or bike-repair experience, are still needed to help make the rodeo a success. Those interested in lending a hand should contact Pam Conover at (509) 337-8876.

Walters, for one, is particularly hoping to see the community get involved.

“It’s really...exciting to see everyone pitch in and do all of those things,” she says, but she hopes that the program has an impact even beyond the volunteers and participants.

“Educate the kids,” she says, “and they will educate their parents.”

Henderson also brought some of her competitive spirit into the classroom. She once promised her students that if her class won the cookie dough sale contest, she would give them something they had never experienced.

The students pulled through for the win and Henderson transformed the classroom into an enchanting rainforest.

“My class was studying plants at the time. The rainforest took nine-and-a-half hours to set up and three hours to take down!” she said. It is something her students will never forget.

These days, Henderson doesn’t need to wait to be asked to share her faith. She has accepted a full-time position as Area Director of YoungLife, overseeing the Dayton High School, Waitsburg High School and Dayton and Waitsburg Middle School ministries.

Henderson said she knew four years ago that she was called to full-time ministry. Three years ago, she knew it would be with YoungLife.

“It just feels right. I’m doing what I should be doing to be obedient,” she said.

Henderson worked along with Jan and Terry Nealy when they started YoungLife in Dayton in 1998 and has remained active in the organization ever since. Her passion for the ministry is evident.

“YoungLife is based on answering three questions for kids. Do I matter? Do I have a purpose? Am I loved? We meet kids where they are, spend time with them, let them be who they are. We don’t judge them, and we take the opportunity to share our faith with them,” Henderson said.

“YoungLife is all about relationships. I love people, both adults and kids. I love spending time with kids and letting them ‘do life’ with me. There is no pressure other

than to build a friendship. That’s what Christianity is – a friendship with Jesus, not religion,” she added.

Henderson said she knows the time is right to make the change this year, even though she is required to raise a good chunk of her own salary, through sponsorships, which takes a leap of faith.

She said the community has been very supportive of YoungLife. Twenty-two middle schoolers and six leaders from Dayton and Waitsburg will head to Washington Family Ranch, August 5-9, to attend camp.

Henderson said they are still raising camp funds. YoungLife has received a donation from the Warren Fund and community members have supported the kids with carwashes and hiring them for odd jobs.

Henderson said the two main challenges local YoungLife groups currently face is the need for lead-

ers and a need to raise \$60,000 through donations and/or sponsorships to cover administration salary and related expenses.

“Anyone can be a leader. It takes about two to three hours a week and all you have to do is hang out with kids and invite them into your life. People shouldn’t be intimidated. If someone has an interest, they can just call me and we’ll find a fit for them,” Henderson said.

Henderson said there is a need for up-front leadership, sponsors, behind-the-scenes helpers, donors and prayer warriors. Anyone interested in participating in YoungLife in any way can contact Henderson at marne69@gmail.com, or (509) 386-2365.

“I was offered a full-time YoungLife job away from here last year. But I knew at that this is where I belong and where I have the support I need. I’m excited to move forward,” Henderson said.

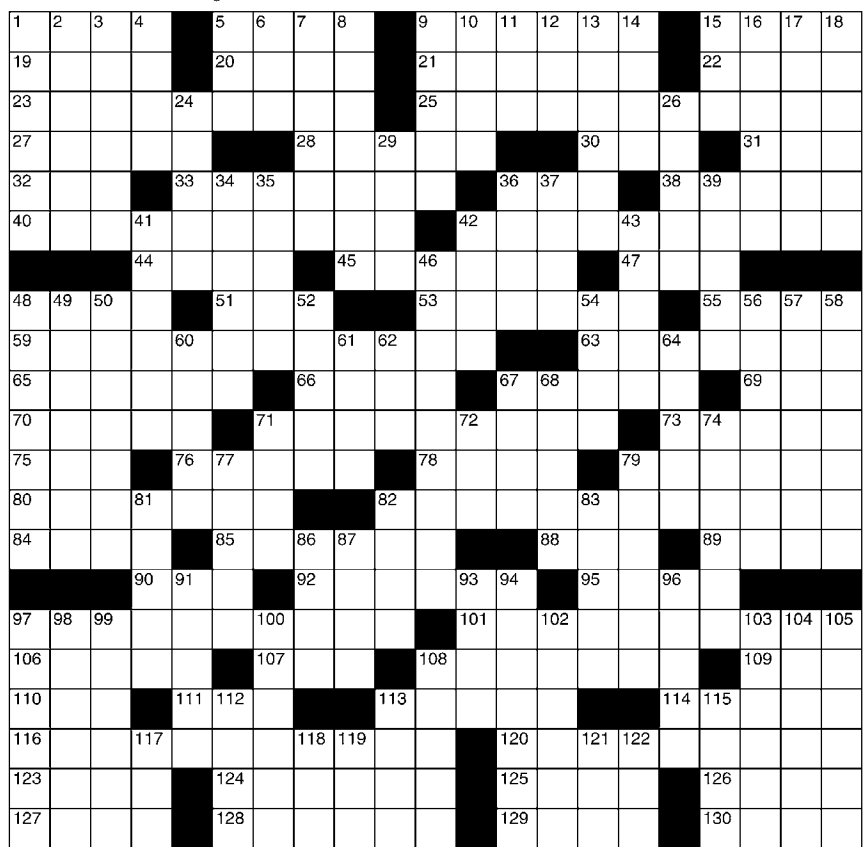

## Nana's Ever Ready Bran Muffins

One of our recipe readers, Suzy Cowdrey, emailed me and asked me for the Pecan Sandies recipe, as she had misplaced hers. In doing so, I asked her if she had any recipes she would like to share, and she sent three. This is one of them, and when she mentioned that Nana (Gertie Dorsey) made these for her harvest crew, I thought it might give another harvest cook an idea for breakfast.



I did not make these, but I know it's an old recipe, as I remember making them a very long time ago. It has also been called refrigerator bran muffins. The batter can be refrigerated up to a month and brought out to bake however many muffins you would like: hot and fresh out of the oven or baked all at once to be frozen for later.

If you are one who does not have much time for breakfast or would rather not eat a lot, then these are a good healthy choice.

I am going to type the recipe as it was sent, but I questioned Nabisco 100% bran in the first part of the recipe and the Kellogg's All Bran, wondering what the difference was. I googled it and this is what I found: "Nabisco 100% Bran was bought by Kraft Foods so the box was re-labeled Post 100% Bran, then the product was discontinued June of 2006, which was confirmed by calling Kraft." Suitable Substitute is Kellogg's All Bran Buds.

Some of the similar recipes call for bran flakes. There are many variations of the recipe with most using double the ingredients. The basics stay the same, though.

I received feedback from another reader on the Snickerdoodle Bars: She said the edges got a little brown so she trimmed them to eat herself and then shared the rest. She said they were great! I'm making them in a few weeks.

### INGREDIENTS AND DIRECTIONS:

Pour 1 cup boiling water over 1 cup Nabisco 100% bran (see note above) or Grape Nuts and let set in separate bowl to cool.

Cream: 1/2 cup plain yogurt (Suzy said she substituted yogurt for oil)

1 1/2 cup sugar

4 eggs

2 cups buttermilk

Add Bran mixture

Add: 2 1/2 cups flour (I use half whole wheat and half white)

2 1/2 teaspoons baking soda

1/2 teaspoon salt

Stir in: 2 cups Kellogg's All Bran cereal.

Bake at 350 degrees for 15-20 minutes. Check at 15 minutes

Store leftover batter in fridge for later use.

### MY NOTES:

When I make this, I will add raisins and walnuts.

## FIRE REVEALS HEADSTONES

No living person was injured, but the eternal slumber of several people in this cemetery was disturbed last week when fire swept through it. The cemetery is located on a hill at milepost 39, between Prescott and Waitsburg, on State Route 241. Mike Ellsworth, a volunteer firefighter with Columbia County Fire Dist. 3, said fire crews had to cut a road through and drop trees to extinguish this fire, which burned roughly 50 acres into a wheat field. The fire revealed several headstones from the 1800s. Surnames on the headstones included Hart, DeWitt, Hayes, Painter, Thompson and Zuger. They are likely people who lived and farmed in the area early on. Ellsworth said that on July 24, firefighters from Walla Walla County Fire Districts 2, 4 and 12, along with Columbia County Dist. 3, responded to a cluster of six fires, along SR 124, which started about 5 p.m. "We don't know whether they were caused by cigarettes or sparks from equipment, or what," he said. The fires have been characterized as "suspicious" in nature, said Ellsworth.
