CCHS Finances Improving According to Auditor

DZA AND ASSOCIATES REPORTED ON ANNUAL AUDIT AT MAY CCHS COMMISSIONERS' MEETING

DAYTON—The overall financial picture for the Columbia County Health System is positive, according to Tom Dingus, with DZA and Associates, an independent auditing firm that works with the Hospital District. Dingus outlined the 2017 audit report with the CCHS Commissioners, and administrators at their regular meeting last week.

The challenge for smaller Critical Access Hospitals, like Dayton's, is getting the cost to provide patient care to not exceed payments, and CCHS is trending in the right direction, said Dingus.

Dingus said there will be future positive impacts to the financial bottom line because of the aggressive swing bed program now in place at DGH, and the daily average census, which is rising. There are also increased patient volumes in both clinics.

Dingus said at the end of 2017, the District had 40 "days cash in hand," and the industry standard is 90.

"I think you are starting to position yourselves where it starts to be a realistic goal," he told the commissioners.

Days cash on hand is a measure of total short term and long-term liquidity, and measures how many days the system can operate.

Borrowing capability

Commissioner Bob Hutchens asked Dingus about the District's ability to borrow funds for future projects.

"You are at the top end of what you can borrow for a while," he replied. "You have more flexibility than what you had a couple of years ago, just not wide open."

Dingus added, "You do have significantly leveraged operations, but less leveraged than it was five or six years ago, and every year you are in a little better spot. And as you pay down the debt service without adding more debt to the bottom line, you are showing good trends."

The District has an Unlimited Tax General Obligation Bond in the amount of \$775,000, paid for through a voter approved levy seven years ago, and Limited Tax General Obligation Bonds in the amount of \$295,000 each year, which are secured by the \$529,000 yearly M&O Levy, along with debt for the new equipment in the Diagnostic Imaging Department.

Dingus said the good news is the levy funds are not just going to service debt, but are going for current operations. However, the long-term debt ratio to net position percentage is still high, at 83%.

Ten Years Ago-June 5, 2008

"The single biggest thing is the almost \$1 million in taxation for the bond principle and interest related to the Unlimited Tax General Obligation bond," said Dingus.

Payment structures

Dingus also spoke about the District's dependency on multiple government payers. "There are so many non-routine revenue streams in rural health care," he said.

He said 67% of the revenue comes from Medicare, 5% comes from Medicaid, 4% comes from Pro-Share, and a smaller amount from the federal government's 340B contract pharmacy program.

Medicare comes up with a cost per patient per day, for nursing home residents, but Medicaid pays a lesser amount than cost per day. Pro-Share covers half of the gap between the actual cost, and what the District is paid, Dingus explained.

He said Medicare pays a scheduled amount for patients who are seen in the clinics. There is also an enhancement rate provided from the state, which is based on the numbers of patients enrolled.

Payments for 2014, 2015, 2016, and 2017 are just now being reconciled, said Dingus.

"What you got paid for those patients is now getting compared to the number of encounters you had, times the Medicaid rate, and then you either pay back the difference, or get more money, if it was less.

"Having a cost-effective system to estimate Medicare and Medicaid and Pro-Share on a monthly basis is not viable, and as a small organization it changes so fast," Dingus explained.

"If your swing bed patients go way up you are getting overpaid, and if it goes down, underpaid," Dingus explained.

All of this causes accounting nightmares for the district's fiscal agents when trying to complete cost reports and establish budgets.

The Centers for Medicare and Medicaid reimbursed the District \$368,000 in September 2016, after the 2015 cost report settled, according to CCHS CEO Shane McGuire.

The interim cost report performed in the fall of 2016 showed a payment of \$415,000 was due from

CCHS to CMS, which was paid off in April of 2017.

But the 2017 August/September interim cost report shows that CMS owes a payment to the District in the amount of \$607,000, said McGuire.

Payments from Pro-Share have been ongoing since December 2016, for a total of \$346,498.00.

Pro-Share will make its payment announcement based on the 2017 cost report sometime in the fall of this year.

"We may go months being underpaid for services, perform an interim, and eventually be caught up, but it is always 9-10 months into the year. Conversely, if costs go down and we are overpaid for services, we will catch it in our interim, and CMS will want payment 30 days after submission of the interim," McGuire said.

McGuire said that the district performs the interim cost reports because its cash position is sensitive. The need is to know sooner rather than later if there is a payable owed to CMS or the other way around, and an immediate adjustment to the rates can be made.

Financial trends based on the DZA report

Other positive trends for 2017 occurred in the current assets to liabilities ratio, as well as the capital equipment expenditures and annual equipment depreciation ratio.

Dingus said net days in patient accounts receivable showed a positive trend last year over 2016, and gross days in patient AR was "trending positive."

The contractual adjustment percentage, or the percentage of gross patient revenue that is discounted to third-party payers, is lower, at 18%, which is favorable. The percentage of bad debt was 2.6% in 2017, and the charity care percentage was 0.3% in 2017.

Dingus said bad debt was a little higher in 2013 and 2014, as the Affordable Care Act and Medicaid expansion came into play. But it went down in states that expanded Medicaid.

"We are seeing it edging up a little bit in people who have insurance, but out of pocket payments are rising and adding to the bad debt," he said.

Salaries and benefits are the district's largest costs, Dingus said. "FTE's went up, but your revenue went up way more this year, so that is a positive factor," he said.

Net income compared to revenue is 4.1%, in 2017, compared to 3.9%, in 2016. The goal is to be in the three to six percent range, said Dingus.

"You have to be financially sustainable, generate revenue, keep moving along and build reserves, and be flexible for the future. So the right direction," said Dingus.

Golf Course Irrigation Grant Delayed

SPEED LIMIT CHANGES, ENGINEER POSITION ALSO ADDRESSED BY COLUMBIA COUNTY COMMISSIONERS

DAYTON--A discussion about what steps to take regarding funding the much-needed irrigation system at the Touchet Valley Golf Course took place between Dayton Country Club Board President Roger Trump, board member J. E. McCaw, state Representative Terry Nealey, and the Columbia County Commissioners last week.

A grant application through the Recreation Conservation Organization missed the May 1 submittal deadline and can't be considered until the next grant cycle in 2020-21.

Commissioner Norm Passmore said to submit the application now would be premature, based on a number of issues he had with responses to questions in it.

J. E. McCaw expressed his frustration over this latest news. "We've been trying to get that going for years and years," he said.

McCaw said their organization has also hit a stumbling block over plans to organize as a nonprofit 501 3C, because "pay for play" doesn't quite fit the qualifications for that.

Rep. Nealey asked, "What's next?" He said he would be willing to help in any way possible.

The county treasurer is looking into whether or not the county will receive a one-time bump in sales tax revenue from the new Columbia Pulp mill near Starbuck. The commissioners have been anticipating an amount of around \$750,000, from that. But if the pulp mill is sales tax exempt, no funds will be available for any special projects.

In the meantime, other grants will be pursued to help with the irrigation project, said Commissioner Passmore.

Speed limit changes on county roads

After hearing from the public that there should be no changes made to speed

limits on county roads, and after some discussion with Deputy Prosecuting Attorney Dale Slack and Sheriff Rocky Miller at last week's meeting, the commissioners approved changes to speed limits on only two county roads.

For safety reasons, the speed limit on Weinhard Road will be reduced to 35 m.p.h. The dual speed limit posted at Cemetery Hill will be removed, and the speed limit will be reduced to 35, making ATV travel into the mountains safer. There will be no change to speed limits on South Touchet Road, for now.

South Touchet Road Project

The South Touchet Road project, which was slated for this summer, has been delayed until 2019. This spring the county received two bids for that project, both of which exceeded the county engineer's estimate, and the project will be need to be rebid next year, said Robert Yates, lead Inspector for Columbia County Public Works.

That project consists of widening the roadway, going from a few hundred feet past the Star Bridge through the intersection with Robinette Mountain Road.

County officials have also deemed it necessary that the "Y" intersections with Harting Grade and Robinette Mtn. Road should be reconfigured, to a "T" intersection for functionality and safety reasons.

Yates said the remaining 1,000 ft. of roadway(s) prior to and through Robinette Rd. intersection, would be raised and expanded to meet each roadway better, and Harting Grade's new intersection will be repaved to match and meet the existing pavement a few hundred feet away from the new intersection.

Additional funds, over and above the fixed available state matching funds pledged to the project, will more likely be available, when planned within next year's budget, said Yates.

The commissioners will take speed limits into consideration when the South Touchet Road project is finally underway.

County Engineer Position

The commissioners appointed Garfield County Engineer Grant Morgan as acting county engineer until the county can hire a replacement for Andrew Woods, who has taken a job in Olympia.

Public Works Department Business Manager Lisa Ronnberg will serve as the Acting Public Works Director.

lasts one to two hours each," she said. "Other than attending those, I'll do the rest of the work off hours."

Culwell's work for College place will be strictly on the criminal law side. The city has a contract with a separate law firm for its civil law work, handling things such as contracts and employee issues.

Culwell is finishing her third four-year term in Columbia County this year and is not seeking reelection. She and her husband plan to move from Dayton to Walla Walla early next year, where she will go into private practice.

Deputy Columbia County Prosecutor Dale Slack has filed to run for prosecutor in the upcoming election. He is running unopposed.

"Their current prosecutor quit, and they needed someone right away," Culwell said of the College Place position. She met with the City Council last week, and the contract was finalized.

"Sometimes it is very difficult for cities to engage prosecutors on a contract basis when the job market is relatively good for attorneys and the pool of candidates is not very large, as is the case in Walla Walla County," she added.

Waitsburg Music Teacher Brad Green Retires on a High Note

AFTER 22 YEARS IN WAITSBURG, MUSIC AND MATH TEACHER LOOKS FORWARD TO TIME WITH FAMILY

WAITSBURG – After 22 years teaching at Waitsburg High School, music and math teacher Brad Green will retire next month on a high note.

“Just this year, my seventh-eighth grade band got a superior rating at the band festival in Palouse, we had a great Christmas concert, my Knowledge Bowl team came in fifth in State, and my math classes are awesome! Plus, I get to play jazz with my high school band every day. These are things I’ll remember, plus some really special students along the way,” Green said.

Green grew up in Huntsville, Ala., where he graduated high school before attending college at Knoxville State University in Tennessee. He earned a degree in English. He married his wife of 38 years, Aimee, in 1980 and the couple had three children: Paul (1983), Carrie (1986) and Tyler (1988).

It was through teaching a gamut of subjects at two small Christian schools, one in New York and one in Colorado, that Green discovered his love for teaching math. He returned to New York, where he earned his master’s degree in math education in 1985.

“I always knew I wanted to teach. I thought I would be a college professor, but it didn’t end up that way,” Green said.

In September 1996, the Waitsburg School District hired a new band teacher who ended up leaving after only a couple of weeks on the job.

“They needed a band teacher and I needed a job! I had never taught band before, so it was a gamble for both me and the school. But Dan Butler gave me a chance, and 22 years later, here I am!” Green said.

Green said he was always musical. “I played band through high school and played guitar and a variety of instruments, so it was a good fit. They made me a long-term sub at first until I could get the classes for my certification. The school has been really good to me and gave me the time to learn how to become a band director. I’m grateful to be here,” he said.

Over the years, Green has taught a wide variety of math classes and music classes, ranging from guitar to chorus to band. For many years he was the advisor for the high school annual, and also taught journalism. One of his favorite

roles has been as Knowledge Bowl coach, a position he has held for 20 years.

“Knowledge Bowl was absolutely great. Band is often a blast. And I still love teaching math of any sort,” Green said when asked about his favorite duties.

So why retire?

“I’ll be 65 in September, so I can! I’m just tired of all the busy-ness associated with being the band director. It’s time for me to work part-time,” Green said. “I will really miss the kids at Preston Hall and the high school. I will miss my dear friends on staff. I’ll miss Knowledge Bowl meets. I won’t miss football or concerts, or bus rides!” he added.

When asked if he has any special traditions, Green said his “ruts” are probably his traditions.

“I started the practice of the high school band playing at graduation back in 1997, for instance,” he said.

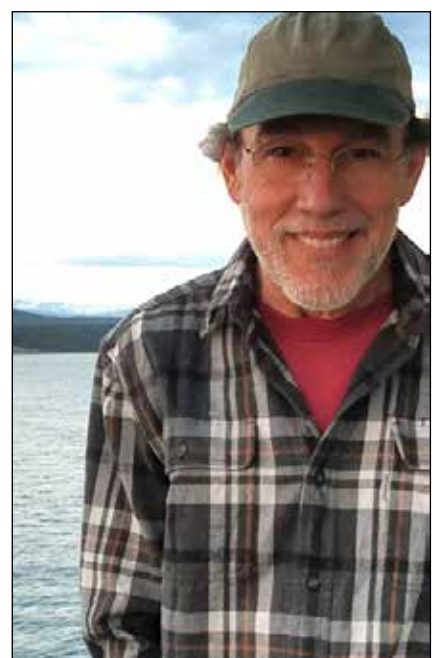
Green said he is looking forward to spending more time with family, especially his eight grandchildren who live in the area.

“I’m going to help in the education of my wonderful grandchildren, which gives me great joy. And I won’t be quite so busy,” he said.

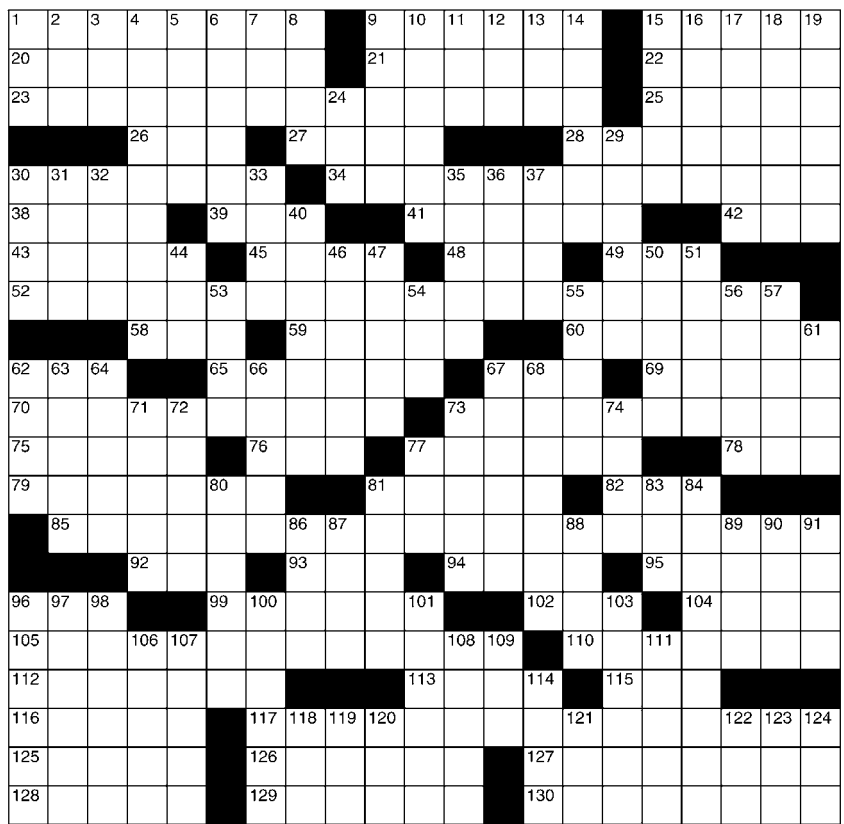

TEENY MCMUNN: MY RECIPE BOX

Rhubarb Upside-Down Cake

I guess I'm on a roll for desserts. I've made this before and thought it was in my recipe folder, but it must have been before my time at The Times.

Thank you for those who give me feedback on my recipes. Katheryn sent me a note on the Pecan Sandies and said she eliminated the nuts and used all butter instead of part oil and part butter and they turned out delicious.

This one I did all sorts of things wrong but it still turned out great. I read the ingredients for the topping and put it together, as I didn't need the directions. Then I started putting the ingredients together, thinking they were talking about the cake. I put the flour, sugar, and butter in a bowl. THEN, thinking for a cake that was odd. Yep, the butter needed to be blended with the sugar, and part of the sugar was supposed to be tossed with the rhubarb, so I had to fish out the butter, try to separate as much of the sugar and flour as I could, then start over. Sometimes I amuse or amaze myself.

The recipe calls for a nine-inch pan. If you have one of those truly two inch deep, no edge nine inch pans, it will work. My round nine inch pan has edges and is not quite two inches deep, therefore the cake baked onto the edges making it harder to get out of the pan. I do have a nine inch square pan that is deeper I wish I would have used, or a smaller oblong pan.

Plus, read the directions for the cake before putting it together, as the butter and sugar get divided.



INGREDIENTS:

Topping:

- 4 Tbsp unsalted butter, melted
- ½ c. all-purpose flour
- ¼ c. sugar

Stir together butter, flour, sugar, and ¼ tsp salt until moist and crumbly.

Cake:

- 1 ½ sticks unsalted butter, (divided) room temperature
- 2 large eggs, plus more for buttering pan
- 1 ¾ c. sugar (divided)
- 1 c. sour cream
- 1 ½ c. flour
- 1 ½ tsp baking powder
- Coarse salt
- ½ tsp finely grated orange zest plus 1 Tbsp fresh orange juice

DIRECTIONS:

Preheat oven to 350 degrees. Make the topping, set aside. Butter a nine-inch round pan (see note above). Dot with four tablespoons (half stick) butter cut into pieces. Toss rhubarb with ¾ cup of sugar, let stand for two minutes. Toss again and spread in pan.

Whisk together flour, baking powder and 1 ½ teaspoons salt. Beat remaining stick of butter and cup of sugar with a mixer on medium speed until pale and fluffy. Beat in zest and juice. Beat in eggs, one at a time, until incorporated, scraping down sides of bowl. Beat in flour mixture in three additions, alternating with sour cream until smooth. Spread evenly over rhubarb. Crumble topping evenly over batter.

Bake until a toothpick inserted into the center comes out clean and top springs back when touched – about an hour. Let cool for 10 minutes. Run a knife around the edge of cake and invert onto a wire rack. Let cool completely.

Cook's note—Martha Stewart: Let the cake cool for 10 minutes before removing it from the pan. The rhubarb will be too hot to handle safely right after baking, but if the cake sits too much longer, it may stick.

Variations:--Martha doubled the amount of crumb topping and used one teaspoon finely grated lemon zest and one tablespoon freshly squeezed lemon juice instead of the orange zest and juice.

MY NOTES: I put in four cups of rhubarb, which also made the cake dough higher in the pan. I also doubled the topping as suggested, but couldn't use it all as I ran out of room. I didn't have either the orange or lemon zest and/or juice so added a teaspoon of vanilla.

It is a delicious cake, and even with all my goofs it was great. ENJOY!

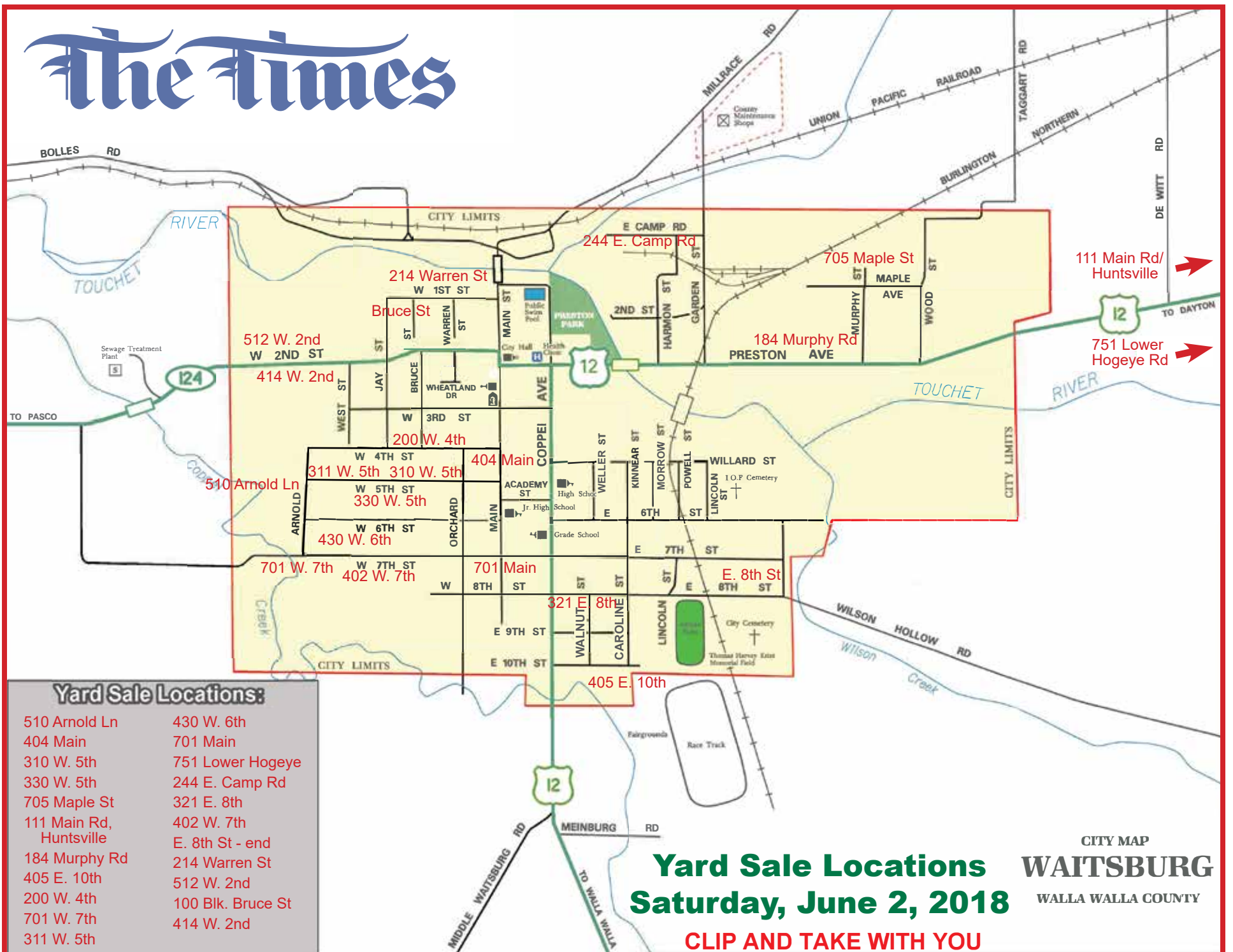
