2025 budget

DAYTON - The Dayton School Board met for its monthly work session at 6:31 p.m. on June 5, 2024, in the high school library. School board members present were Chair Jeffrey Mc-Cowen, Zac Fabian, Ryan Paulson, Grant Griffin, and Superintendent Rich Stewart. Aneesha Dieu attended using Zoom.

Dayton School Board tackle 2024-

The board approved the consent agenda, which included approval of two overnight trips and approval of the 2024-2025 contract with Amy Cox for K-12 Principal. One trip is for students to attend the FFA National Convention on October 23 through 26 in Indianapolis, Ind., the second is a GEAR UP Summit on July 16-18 at WSU.

The district's business manager, Jana Eaton, gave a presentation on the 2024-2025 school year budget and four-year enrollment projection for adoption by the board at the June 19, 2024, meeting. Eaton described the district's funds, which act as individual accounts that are managed separately. The funds are:

- General Fund–Accounts for all financial resources of the school district except for those accounted for in a separate fund.
- Capital Projects Fund-Used to acquire or construct major capital facilities, technology upgrades, or small capital upgrades.
- Associated Student Body Fund-Revenues and expenditures specifically related to and approved by the student body.
- Transportation Fund-Used for purchase of student transportation buses.
- Debt Service Funds-Used to manage bond-related obligations.

Eaton said the district's budgeted enrollment, including Running Start, Dropout/Open Doors, and ALE students is 330.76. The enrollment numbers impact the General Fund budget.

Revenues for the General Fund Revenue are budgeted for \$8,067,814 from property tax, federal and state funds, special education, local grants, and the majority from OSPI allocated state funds.

Identified expenditures for the General Fund are \$8,128,267 and is allocated as follows:

- Programs \$2,134,281
- Salaries \$4,162,380
- Benefits \$1,833,123

The Student Body Fund has budgeted revenue of \$211,450, and planned expenditures of \$196,005.

ed revenue of \$2,775,971 and expenditures of \$2,850,000. Projects identified include an air filtration system, refreshing the exterior, and updates to the auditorium at the secondary school.

Elementary school projects include carpet, library furniture, a security gate, and a lift update. Projects in general include fencing, new technology, underground sprinklers, and Vocational-AG doors.

The Transportation Fund balance is \$89,225 before a depreciation payment of \$83,047 in August. The district is in the process of ordering a 40-passenger bus, and possibly an additional bus in the 2025-2026 school year.

Stewart gave an overview of projects planned for the next four years with capital levy funds. These include some classroom remodels, improvements to the auditorium, repairing the gym floor, fencing, technology, and repairing the ventilation system at the high school. The scope and precise cost of these projects are undetermined at this point.

The district plans to move forward with the fencing, some of the concrete work, and possibly the underground sprinklers this summer. Pruitt Flooring walked through the gym and gave ideas for repairs that could extend the life of the current floor a few more vears.

The board discussed the need to add more door security, cameras, and security at the athletic complex.

Board member Griffen asked for prioritized list, project proposals, and quotes before projects begin. He said he would like to see updates on the projects at each of the work sessions. Griffen said he wanted to make sure there were not too many projects at the same time which could lead to running out of funds if there are overages in one of the project areas.

Head Custodian John Delp said he is working on getting at least three quotes for each of the proposed projects. Robust discussion ensued on projects and how they will be carried out, the bidding process, and making sure the board is well informed on what the district is doing with the levy funds.

The meeting adjourned at 8:15 p.m. and the next school board meeting is scheduled for June 19, 2024.

Identify Birds by their Calls - Yes you can

One of the things I truly enjoy about Waitsburg is that because of our oasis of trees and water in a normally dry environment, we are provided with a litany of bird songs at any time of day. For example, when I sit on my front porch on a weekend morning drinking my coffee, I can hear up to 20 different types of birds calling to each other. Sitting on my back porch at dusk, I hear the evening songs as the birds go to bed. And when I let the dog out one last time for the evening, I regularly hear male and female owls calling back and forth to each other across town.


While I find it easy to identify species like American Robins, California Quail, and Ring-Necked Pheasants by their call, there are many birds that I struggle with in the cacophony of tweets and twitters (much like human's online social media). It amazes, and frankly baffles me, that some avian biologists can identify hundreds of birds by their call alone. I know this is something I may never be able to do, however, Cornell University has put out an app to do just that.

The "Merlin Bird ID" is free on the Google Play or Apple's App Store. After downloading the app, users can set the map to their location, (I used the Northwestern United States.) Now the phone is initiated to listen for bird calls and identify the species of birds it "hears."

I was pleasantly surprised when my phone listened for ten minutes on my front porch and recorded 18 species of birds. While I cannot be sure that every bird it detected was identified accurately, it did seem as though it is really good. Many of the birds identified were very common to this area, while other birds I had not heard of or did not know were here.

The birds I hear during June from my house include the American Robin, House Finch, Eurasian Collared Dove, House Sparrow, American Goldfinch, Lesser Goldfinch, California Quail, Ring Necked Pheasant, Black Chinned Hummingbird, European Starling, and the wild turkey. Less common birds the app has identified included the Cedar Waxwing, House Wren, Warbling Vireo, the Chipping Sparrow, and Black-headed Grosbeak.

Birds reported that leave me questioning the app's 100% veracity include the brightly colored Yellow Warbler, Vaux's Swift, and the White Breasted Nuthatch. I would also like to know what type of owl



I was hearing at night in town and determined that it was indeed the Great Horned Owl.

The app also allows users to click on the identified bird's picture for more information, and save it to a list if users are so inclined. One can also act as an amateur naturalist and keep track of those birds for their research. A recent post on ebird.com reported that the app's users and everyday citizens helped Cornell University determine the number of Bald Eagles in the lower United States was more than double what it originally thought. Not bad results for amateur birders. If you have a curiosity about the types of birds you are hearing and want to do a little research, this app is a fun way to identify birds by their calls. So, wonder no more.



Moroccan Kefta Kebabs

As we move towards the summer solstice, many of our meals will be enjoyed on the back deck. From all-American cheeseburgers or Mexican carne asada to Korean bulgogi, the art of grilling is a culinary skill that brings people together all around the world. In fact, there is something quite primal in the communal experience of gathering around a meal sizzling over an open flame. A reminder of the universal commonalties of the human experience that far outweigh the differenc-



es. Here, ground beef is exuberantly flavored with North African spices and aromatic fresh herbs before being grilled to perfection on skewers.

Ingredients:

- 1 small yellow onion 1 pound ground beef (15- to 20-percent fat) 1/2 cup packed flat leaf parsley, finely chopped ¹/₂ cup packed cilantro, finely chopped ¹/₂ cup fresh mint leaves, finely chopped 2 heaped teaspoons sweet paprika 1 teaspoon ground cumin 1 teaspoon ground coriander 1/2 heaped teaspoon kosher salt (or 1/4 teaspoon fine salt) ¹/₂ teaspoon fresh ground black pepper Pinch of ground cayenne
- Olive oil

Directions:

With the large hole side of a box grater, grate the onion directly into a large mixing bowl, collecting all the onion juices. To the onion add the beef, parsley, cilantro, mint, paprika, cumin, coriander, salt, black pepper and cayenne. Using your hands or a large spoon, combine the ingredients until evenly mixed together.

In a small skillet heat a little oil over medium-high heat. When hot, add about a teaspoon of the beef mixture to the pan and cook until seared on both sides and cooked through. Taste the sample for seasoning, then add more salt as needed to the meat mixture.

Take between 2 to 3 tablespoons of the mixture and use your hands to mold it onto a skewer to form a log. Be sure to press the meat firmly around the skewer. Repeat with the rest of the mixture. If using long skewers form two logs on each skewer. Place the formed kefta kebabs on a plate and cover with plastic wrap. Refrigerate for about 30 minutes to allow the kebabs to firm up.

While the kebabs are chilling, heat your grill and prepare your side dishes. Heat grill to medium-high and brush the grate with oil to prevent sticking. When ready, brush both sides of the kebabs lightly with olive oil. Cook the kebabs for about 3 to 5 minutes per side, allowing the meat to get defined grill marks. Use a meat thermometer to check for doneness. Be careful when flipping not to break the kebabs off their skewers. It is helpful to use a metal spatula to turn them. Arrange cooked kebabs on a serving platter and sprinkle with a little finishing salt. Serve immediately with your favorite sides and garnishes (see notes).

Notes:

These kefta kebabs are fabulous with ground beef, but traditionally can also be made with ground lamb. I have seen versions made with ound turkey or chicken as well.

Instead of kebabs on skewers, you could also shape the kefta mixture into patties and grill them like a burger. If you don't have an outdoor grill, you could use a grill pan or even a regular cast-iron skillet on your indoor stove. However you cook them, you want to get a good sear or char on the outside to enhance the flavor.

Serve these kefta kebabs with your favorite mezze accompaniments, such as hummus, olives, pickled peppers, or my garlic tzatziki sauce (below). This week, I also served these with a Moroccan spiced rice pilaf, warm flatbread, and a simple salad of romaine lettuce, tomato, feta, and pickled red onion.

My Tzatziki recipe:


Grate 1 English cucumber into a strainer and set over a sink. Sprinkle with a pinch of salt and allow the cucumber to drain for a few minutes then gently squeeze out the excess moisture. In a bowl, combine the cucumber with 1 1/2 cups plain Greek-style yogurt, 2 tablespoons minced fresh dill, 1 tablespoon minced fresh mint, 1 garlic clove minced, juice of half a lemon and 2 tablespoons of extra-virgin olive oil. Season to taste with salt and pepper then allow to chill in the refrigerator for at least one hour.
