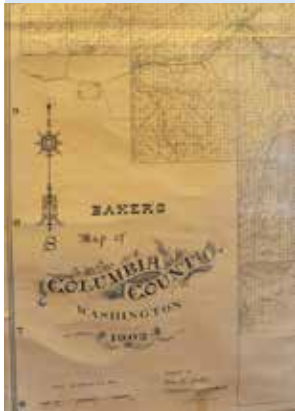

Dayton Youth Facility to Open in Sept.

DAYTON BOYS AND GIRLS CLUB HAS RECEIVED MANY THOUSANDS IN GRANTS AND DONATIONS

DAYTON--“Yes, that is our bowling alley,” said Dan Butler showing the County Commissioners the architectural drawings for the new Boys and Girls Club in Dayton, at the Feb. 6 commissioners’ meeting.

Butler and his wife, Ginny, bought the former bowling alley on W. Cameron St., in Dayton, last May. Construction on the Boys and Girls Club is due to begin this month, and the facility will be open for business on Sept. 4, said Ginny Butler.

She said the Wolfe Architectural Group in Spokane donated \$15,000 for the building design. Donations are coming from a variety of sources, she said.

Cathy Lee and Michael Haight, of Day-

ton, have donated \$10,000. \$2,000 was donated for surveying the property, and the security system will be donated by the president of the Spokane Boys and Girls Club, who owns a security business.

\$2500 for kitchen upgrades has been raised through local fundraising efforts. An \$18,000 grant from the Wildhorse Foundation will be used for the auxiliary heating system. The Exchange Club of Walla Walla has donated \$500, and Dayton Kiwanis has donated another \$500. There are other individual donations totaling \$5,000., and there are roughly eight grant applications to vari-

ous other organizations, still pending.

Ginny Butler said half of the money from the \$150,000 endowment that has been set up in the Blue Mountain Community Foundation will be spent on renovations. The other half is coming from grants from Umpqua bank, the Inland Northwest Foundation, and State Farm Insurance.

“After that we will have this building for \$50 per square foot,” Butler said. “You can’t build a garden shed for \$50 a square foot.”

Waitsburg Council Gives Nod to Park & Ride

LOT WOULD BE LOCATED AT OLD COUNTY SHOP SITE NEAR MAIN STREET BRIDGE

WAITSBURG – At the regular Jan. 17 meeting, Waitsburg City Council members gave City Manager Randy Hinchliffe the go-ahead to explore development of a Park & Ride lot on the north end of town.

The Park & Ride would be located on the site of the old county shop, just west of the newly replaced Main Street Bridge. Hinchliffe explained that the city is limited on how that space can be utilized.

“After the 1996 flood, FEMA bought various parcels of land throughout the city and gave them to the city with the condition that they remain open so there is somewhere for water to

disperse should water come over the top of the levy,” he said.

The idea of a Park & Ride has been on the city’s six-year-plan for approximately 10 years but hasn’t moved forward. Currently, Columbia County Public Transportation (CCPT) serves Waitsburg, making multiple stops around town. A centralized location would increase efficiency.

Hinchliffe said the site is well-suited because it is an open area with an existing concrete slab left over from the county shop. He told the council that Walla Walla Valley Transit is willing to give Waitsburg a bus shelter.

Hinchliffe said adding a bus shelter to the site would be allowable under FEMA guidelines because the sides don’t reach to the ground and it is not a permanent structure.

He said the cost to install the Park & Ride would be minimal, but there would be some ongoing maintenance,

S. 410 number was dropped by the American Association of State Highway Officials because almost entirely within the State of Washington. The new number, U. S. 12 begins in Detroit and now continues westward through Minneapolis to the Gray's Harbor area. Part of the change included the naming of U. S. 830 as State Highway 14. The remaining portion of the U. S. 410 has changed to State Highway 410 from Naches Junction over White Pass to Enumclaw, Tacoma, and Olympia.

One Hundred Years Ago February 22, 1918

A juvenile band is being organized in this city with Harry Buroker, a cornet player in the Waitsburg Band, as leader. The organization will be affected within a few days as soon as a number of now instruments ordered for the boys arrive.

Wesley Lloyd, one of our prominent farmers, has at last finally succumbed to the auto game and this week purchased a Buick "four" though the McKinney Auto Co.

From 750 to 1000 farm laborers are needed at once in the Walla Walla Valley and when obtained will be given continuous employment until next winter and many of them will be kept over even at good monthly salaries.

The little building across the street from the Preston Shaffer Milling Co. and formerly used as the business office of the mill, burned Monday afternoon. The burning of this building destroys an old land mark one of the older buildings to town.

One hundred Twenty Five Years Ago March 3, 1893

Robert Loundagin will leave in a short time, probably about the first of April to join his brother, John, and Albert Hollowell, who are now in Kansas with their photograph car and are making a barrel of money.

Married in Walla Walla, March 1, Samuel B. Sweeney and Miss Adna Fudge. The happy couple started immediately on a wedding trip to the Sound, San Francisco, New Orleans, and Chicago, and will return in May. They have a host of friends in this city where best wishes go with them

Busy Season Ahead for Columbia Co. Projects

CREWS HAVE BEGUN MAINTENANCE; SEVERAL ROAD PROJECTS ARE SLATED FOR THIS SUMMER

DAYTON--Warmer, milder weather is going to allow county crews to start spring maintenance, earlier than usual, said Public Works Director Andrew Woods at last week's meeting of the Columbia County Commissioners.

County crews are to begin digging ditches, cleaning culverts, cutting brush, and applying herbicide to the shoulders of paved roads in the next few weeks.

Road grading has begun in the north part of the county, which is pretty typical, Woods said.

He said the county is going to purchase dry calcium chloride and use county labor to apply it, in place of magnesium chloride, as used in years past. "We want to try a couple of roads and see, do we save costs, or not."

While there are additional costs to the county, county residents can call the Public Works Department to be placed on a list for that application.

Bidding will begin for contracts for rock crushing, for a second rock rake for crews to use on the bigger roads, and for chemicals for county road needs, along with use at the fairgrounds and golf course.

Woods said the county needs a new sand shed, because some cracked timbers are causing damage up into the trusses. "It has done its duty. It's been there a long time," he said.

Replacing the old sand shed with a standard metal building, which will be a little more than twice the size of the current shed, will cost around \$125,000. Funds have mostly been identified for that.

The county is wrapping up plans for the South Touchet Road Project, with a few minor tweaks. Construction should begin in the middle of June. The public can expect 10 to 15-minute delays due to construction, Woods said.

Woods said work has begun on grant applications for the rural arterial program, specifically for Kellogg Hollow Road, Starbuck Bridge, Hatley Gulch Phase I and Hartssock Grade.

He is also requesting a bit less than \$1 million for the proposed North

Touchet Road overlay project from a Federal Lands Access Program grant. The plan is for the city of Dayton to partner with the county on that project. The overlay project will begin on S. Fourth St., from Main St, to milepost 7.2 on the North Touchet Road.

Woods said \$86.5% of the \$1.8 to \$2 million project will come from those federal dollars. The city and county will share the other 13.5%. Project management will stay with the county.

The state has obligated PE funds and is moving forward with the Whetstone bridge project on Highway 12. Woods plans to meet with the representatives from the state to ask if the state can perform additional work.

Action was taken by the BOCC at that meeting to approve:

Certification of the 2018 Road Levy and Estimated Revenue Produced.

Resolution 2018-03, authorizing minor updates to the Planning Commission Rules and Procedures.

Resolution 2018-04, authorizing the Public Works Director to solicit bids and award a contract through the small works roster to install ventilation fans and a heating/cooling system in the weigh shack at the transfer station with an estimated project cost of \$15,000.

Resolution 2018-05, authorizing the purchase and installation of a new dispatch console in the county's dispatch center in the estimated amount of \$190,000.

Resolution 2018-06, authorizing the Public Works Director to solicit bids and award a contract for replacement of the dispatch center carpet and furniture installation at the two dispatch consoles. The estimated cost is \$40,000.

Resolution 2018-07, authorizing the Public Works Director to solicit bids and award a contract for installation of bullet-resistant paneling, partitions and doors in the office of the Clerk of the Superior Court. The estimated cost of the project is \$25,000.

Resolution 2018-08, adopting the Washington State Department of Transportation Standard Specifications for Road, Bridge, and Municipal Construction, 2018 Edition.

Approved the 2018 Community Wildlife Protection Plan.

Approved the 2018 Fairgrounds Facilities Fee Schedule and the 2018 Touchet Valley Golf Course Fees. Copies are available for inspection at the Columbia County Office during regular business hours.

such as snow removal and regrading. "All we would need to do is get some gravel, smooth it, clean the pad, set the shelter, put up signs and you've got a new Park & Ride lot. I talked with CCPT and they said if it's there, they will use it," Hinchliffe said.

Commercial Club President Joy Smith said there are often several cars belonging to people who use the Vanpool left parked in front of Main Street businesses all day. "If those people could be redirected to the Park & Ride lot that would be a really great thing," she said.

"I can see us starting out small and if this becomes more used we can add concrete bumpers, a bike rack, and a designated entrance," said council member Kevin House.

Waitsburg resident Jim Romine said it would also make a good parking spot for tour busses. "People from Walla Walla already rent a bus to come to the rib feed. Maybe this would encourage groups to get together and charter a bus for events like the Brewfest," he said.

With the council's agreement, Hinchliffe said he would be in contact with CCPT to determine how to best move forward with the project.

Depot and Boldman House Have New Exhibits

EXHIBIT AT DAYTON HISTORIC DEPOT FEATURES HISTORIC MAPS OF DAYTON AND COLUMBIA COUNTY

DAYTON— Tamara Fritze, Museum Director of the Dayton Historic Depot Museum is putting the finishing touches on an exhibit of early maps of Columbia County, which are open for public viewing now through the end of the year.

Three Sanborn Fire Insurance maps from 1898, 1909, and 1916, military road maps, and maps of Huntsville, Starbuck and Columbia County produced by George Baker, who owned the title company in Columbia County in 1900, and many more will be on display.

One of the most interesting maps is an amateur map produced by John R. White of Waitsburg, dated October 3, 1948. The key to the map identifies the location of many interesting historical places, including the burial location of "Taylor and Gaston and others, after the Steptoe Defeat". This refers to the May

1858 attack of a force of Coeur d'Alene, Spokane, and Palus Indians, that defeated a force of 164 US military troops at Pine Creek near the present-day community of Rosalia, Wash.

Fritze said the maps are on loan from the City of Dayton, the Dayton City Shops, Columbia REA, Broughton Land Company, Columbia County Public Works, the Port of Columbia, Larry Fairchild, Katy Wamble, Garry Snyder and Christy's Realty, and Fred and Genie Crowe.

She would like to thank the Wildhorse Foundation and the Blue Mountain Community Foundation for grants that have expanded the space for hanging artifacts in the upstairs gallery where the maps are on display. The grants also provided for a fresh coat of paint on the walls, she said.

The Dayton Historic Depot Museum is located at 222 E. Commercial St. The current hours of operation are; Wednesday through Saturday from 11-4 p.m.

Cameras used by the Boldman Family sisters are in a special exhibit at the Boldman House Museum through the end of 2018.

According to Museum Director Sylvia Beuhler, the oldest camera in the exhibit is the 1909 Brownie Camera # 2A, belonging to Minnie Boldman, and

it has been placed next to an endearing photo taken of Gladys Boldman, holding the camera, sometime in the 1920s.

The cameras range in age from 1909, to the early 1980s, and include the Brownie Camera # 2, a 1929 Folding Autographic Brownie Camera, a 1940 Spartus Folding Camera, a 1950s Kodak Duaflex II Camera, a 1968-71 Kodak Instamatic, and the 1980s Kodak Disk 6000, which used microcomputer technology.

The Kodak Disk 6000 could have been the camera taken by sisters Gladys and Goldie Boldman on their 1982 European tour.

The display also includes Kodak Dark Room tools, featuring a dark room lamp, plates, trays, and developing paper and postcards, which indicate the Boldmans were experimenting with developing photos, said Beuhler.

"We have a whole lot of the same photo. Some are not very good," she said. There is also a double exposed negative, which points to some experimentation by the Boldmans.

Beuhler said she found the cameras and other artifacts stored in boxes beneath a stairwell, in the house, and she can't wait to see what else will turn up.

The Boldman House Museum, located at 410 N. 1st St, in Dayton. The current hours of operation are Wednesday through Saturday from 11-4 p.m.

DAYTON RECYCLING TO RETURN SOON

Bins will be placed at transfer center as soon as DOE gives thumbs up

DAYTON—When the Columbia County Commissioners met last week, Public Works Director Andrew Woods gave an update on progress toward reinstating the county's recycling program.

"The grant funds are there," he said. Woods said his department is waiting for the "thumbs up" from the state Department of Ecology so bids can be solicited for some fencing that needs to be done, before the county can accept recyclables at the new recycling station at the county's transfer facility.

"We're waiting to hear back. As soon as they say 'yes' we will get the fence installed and get the containers down there, ASAP," Woods said.

Woods said Basin Disposal, Inc. will provide separate containers for each type of recyclable, and there should be adequate signage explaining which containers to use. BDI will take the recyclables for processing, Woods said.

Going forward, the county will not get paid as well as it was, Woods said. Until recently, China has been buying the lion's share of recyclables, but it is no longer buying them in the same quantities.

“China is not purchasing, and what they are purchasing they have put such stringent contamination rules on it, nobody can meet it,” he said.

For instance, China will only take cardboard containing 2.5% or less of contaminant. In the past the amount the county got paid for corrugated cardboard has made up for any financial losses, Woods said.

The county relies on the DOE's solid waste/ecology grant, which pays for 75% of the total costs of the recycling program. But the county is on the hook for the remainder.

The recycling program was suspended in 2017 when the DOE said there would be no reimbursement of costs associated with it, as long as the state was operating without passage of a capital budget. The state's \$4.2 billion capital budget was signed by the governor last month.

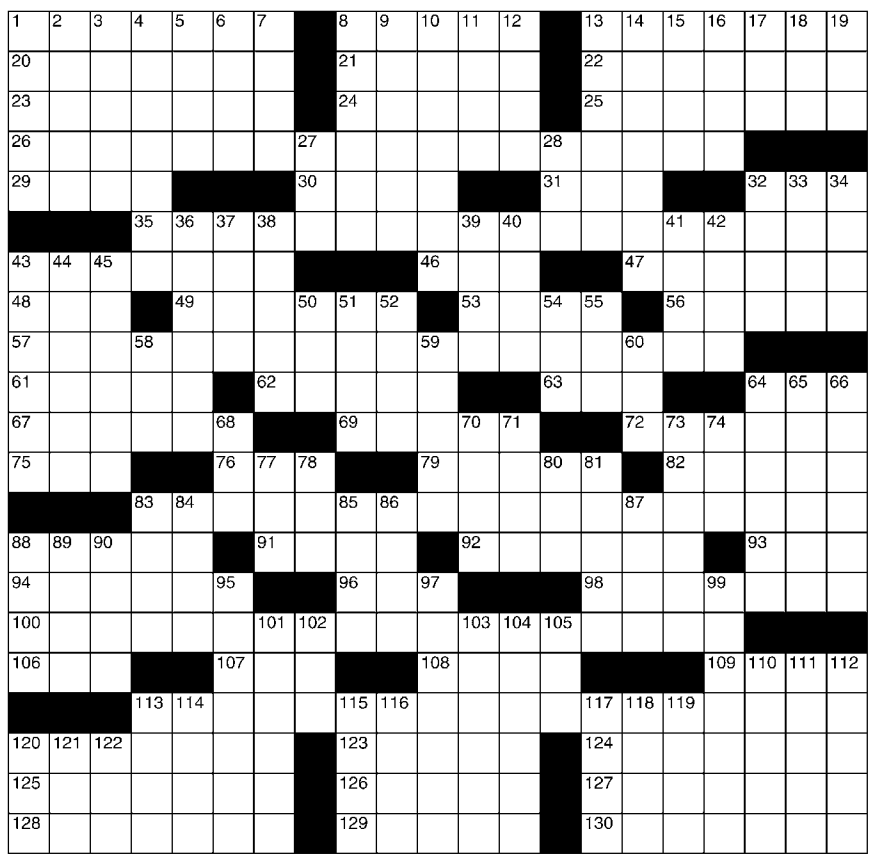

No-Bake Energy Bites

These were served at our church coffee hour and were very tasty. The comment was that these could replace sugary desserts and also have nutritional value. I am a confessed sugar addict. I plan my nighttime tea and desserts like some do their drug addiction. If there is no dessert, then there is always plain ol' chocolate chips.



So the goal is to reduce the sugar intake, and these seem to be a good start. I have all the ingredients and I like everything in them.

The recipe says it makes 20. There are many different recipes, but the base seems to be peanut butter, honey, and oatmeal. I bought some peanut butter protein powder (which I haven't used but it sounded healthy) and that seems a natural to add that to the recipe.

INGREDIENTS:

- 1/2 cup creamy peanut butter
- 1/3 cup honey
- 1 tsp vanilla extract
- 1 cup old-fashioned oats, raw
- 2/3 cup toasted, sweetened shredded coconut
- 1/2 cup ground golden flaxseed meal
- 6 Tbsp chocolate chips (mini chips may be better)

INSTRUCTIONS:

In a mixing bowl, stir together the peanut butter, honey and vanilla extract. Add remaining ingredients and stir until evenly coated.

Transfer mixture to the refrigerator or freezer and chill until mixture has firmed up a bit – about 30 minutes. Remove from refrigerator and shape into one-inch balls.

Store in refrigerator in an air tight container.

MY NOTES: I like nuts, so I will add walnuts and/or almonds and some sesame seeds. Also, if you have one of those cookie dough scoops, it might make them easier to roll.

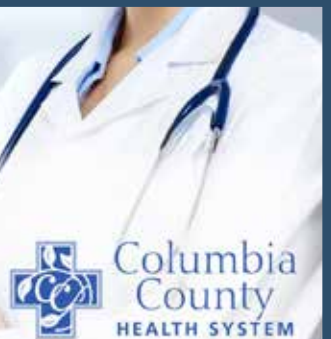
