WAITSBURG—Scouting is about kids, family, and community. Waitsburg and its surrounding area, including Dayton and Prescott, are fortunate to be the home of Scout Troop 337.

Scoutmaster Justin Stegall, Assistant Scoutmaster Tim Hollingsworth, and Troop 337's committee members Jon Roberts, Sarah Roberts, Paul Mantz-Powers, and Brandi Hollingsworth have run the troop since restarting it in the spring of 2023.

On Monday, September 30, 2024, the troop will host a Court of Honor ceremony and an Open House for the community at the Lions Club Building at the Waitsburg Fairgrounds.

"Community members can encourage our current scouts as we celebrate rank advancements and recently earned merit badges," said committee member Sarah Roberts.

The event is an excellent opportunity for boys and girls between the ages of 11 and 17 to learn more about scouting and the Waitsburg troop.

In the past year, the scouts have enjoyed campouts and hiking trips where troop leadership introduced pioneering, orienteering, cooking, fishing, and good citizenship. The scouts have had opportunities to earn multiple merit badges as they gain these and other skills. On a recent campout, scouts tested their strength, agility, and balance on the Flying Raven Adventure course, an aerial-adventure at Crystal Mountain Resort.

It takes a lot of support from parents, community, and local organizations to help scouts earn their merit badges. Roberts recognized The Lions Club who acts as the troop's charter organization, sponsors and helps with troop activities, and provides its building for many troop meetings. In return, the troop volunteers at the Lions Club Salmon BBQ, assisting with the event's parking. The BBQ is on Saturday, September 21, at 6 p.m. at the Don Thomas Building at the fairgrounds.

Troop 337 plans more council events this year, including offering a bigger scout camp next summer. Leadership hopes to expand troop membership, allowing more kids to participate in scouting. Kids from the Waitsburg, Prescott, or Dayton areas who cannot access local Scouting America (formerly BSA) troops are welcome to join Scout Troop 337.

AT THE LIBERTY: "Reagan"

DAYTON — From dusty, small-town roots, to the glitter of Hollywood, and then on to commanding the world stage, this is Reagan's cinematic journey of overcoming the odds. Told through the voice of Viktor Petrovich, a former KGB agent whose life becomes inextricably linked with Ronald Reagan's when Reagan first caught the Soviets' attention as an actor in Hollywood, this film offers a perspective as unique as it is captivating. Dennis Quaid brings to life a story that transcends the boundaries of a traditional biopic, offering a profound exploration of the enduring impact of the power of one man who overcame the odds, sustained by the love of a woman who supported him in his journey.

Rotten Tomatoes critics only gave this an 18% favorable rating, but audiences thought much better of it and gave it a 98%. IMDb rates this movie as 6.4 out of 10. The movie runtime is 136 minutes and is rated PG-13 for violent content and smoking. However, the IMDb parent's guide indicates all categories as considered mild or none, except for the amount of alcohol and smoking.

Don't miss the 27th Annual Manhattan Shorts Film Festival, which begins at the Liberty Theater on September 27. The Liberty Theater is one of four theaters in the state and the only one in eastern Washington hosting this unique film festival.

The festival selects ten short films as finalists to be shown at these events. Daytons screenings are one of over 500 venues across six continents between September 26 and October 6.

Best Film and Best Actor awards will be determined by ballots cast by the audiences in participating venues, including The Liberty. The top ten films in the Manhattan Short Festival are also automatically Oscar-qualified. DAYTON CITY COUNCIL MEETING HEAR CONCERNS OVER COUNTY CONTRACT

DAYTON- Mayor Roger Trump called the Dayton City Council meeting to order at 6 p.m. on September 10, 2024. Trump and council members Teeny McMunn, Michael Smith, Kyle Anderson, James Su'euga, and Shannon McMillen were present at City Hall. City Council members Laura Aukerman and Joann Patras were absent.

During the first public comment period, Dayton resident Theresa Eier spoke on concerns over the city's contract negotiations with Columbia County for policing services by the sheriff department. Sheriff departments in Washington state are more autonomous than city-run police departments and more challenging to regulate and reform by elected bodies, said Eier.

According to Eier, the contract with the county allows amendments to obligate the sheriff's department to better reflect the city's needs and make them more accountable. She recommended community involvement in developing these amendments to help shape the services provided by the city's contracted law enforcement.

County Commissioner Ryan Rundell gave the county, emergency management, and sheriff's reports to the council. He said the city had 332 law enforcement calls, one fire call, and 31 EMS calls. The commissioner said the county had 183 law enforcement calls, 14 fire calls, and 19 EMS calls.

Rundell said the county still had a vacancy on the county's board of health, and applications are being accepted. He also reported that the state legislature was considering adding another Superior Court Judge to the district, including Columbia County. The county's share for the new judge would be approximately \$30,000, the rest being paid by the State, Asotin County, and Garfield County.

The council approved Ordinance 2012 to change the due date for city utility bills from the tenth of the month to the fifteenth. The ordinance also changed the grace period from the twenty-fifth to the twentieth to allow city staff time to prepare the following month's bill sooner.

The council repealed Ordinance 994, passed in 1946, which placed responsibility for utility bills on the owner of a property, not the tenants. Ordinance 2013 makes the utility customer liable for payment, whether the owner or a renter.

The council approved Resolution 1551, awarding a contract to ESF Solutions for phase one of the

Fourth Street sidewalk improvement project.

In the mayor's report, Trump addressed the BDI surcharge, which is applied toward the state's variable carbon emissions tax, making the surcharge a variable rather than a fixed amount.

Trump said the next council workshop will be on October 1, 2024, at 3 p.m.

Su'euga congratulated the city staff for the fine job they did putting together the booth at this year's County Fair.

The council meeting adjourned around 6:49 p.m. The next city council meeting is scheduled for Tuesday, October 8, 2024, at 6 p.m.

Return of Friday Night Lights in Waitsburg

WAITSBURG — I closed my eyes and encountered the lovely, musty smell of a wet wheat field. I opened them and saw a waning blue sky with the half-moon rising through wispy clouds and jet contrails. Behind me, I could hear the delighted screams of prepubescent youth hitting each other with sweaters and chasing each other around. Some young ladies wore subtle face paint. Temperatures were in the high 60s. I shook hands with a few friends and colleagues. Friday night lights returned to the Waitsburg School District Athletic Field on September 13, as the Cardinals hosted the Touchet Redhawks in their first home game of the season.

The air was full of anticipation, even though it was unclear what to expect after the Cards lost to Desales, 62 to 8, in the season's first game in Walla Walla. The Redhawks may have had a slight size advantage over the Waitsburg team. The average height and weight of the Cardinals this year is 5'10 (5'4 to 6'3) and 160 pounds (95 - 201), while the Redhawks' average is 5'10 (5'7 to 6'3) and 180 pounds (150 - 303). Regardless, the Waitsburg handily defeated their opponents 56-0.

The Cardinals started with a solid ground game with an opening drive down the field. Koyen Fortune scored a touchdown at 9:36 of the first period. A failed conversion attempt left the score at 6-0. Touchet struggled to make yardage, and after the punt, on the next possession, the Cardinals scored again behind an 80-yard pass from Isa Reyes to Lucas Van Hoose at 4:58 of the first period, with Brenton Segraves making the 2-point conversion, making the score 14-0.

The Cardinals scored again on the first play of the second quarter, with a 29-yard run by Martin Vasquez and a 2-point conversion from JJ Gleason, making the score 22-0. Martin Vasquez scored another touchdown at 8:11, and another conversion resulted in a score of 30-0. With 2:30 left in the quarter, JJ Gleason made a 56-yard touchdown, and the conversion made it 38-0 at the half.

Waitsburg changed tactics in the second half, from a balanced passing and running game to a primarily passing effort. After Reyes had difficulty connecting, Isaac Mahre came in as QB. He ran down the field on a keeper for about 60 yards, ending up on the 2-yard line. Lucas Van Hoose punched in the touchdown, and Koyen Fortune made the conversion for a score of 46-0.

The clock ran continuously as the Cardinals scored an additional touchdown by JJ Gleason after an athletic recovery of his own fumble. Isaac Mahre scored his first points as a Cardinal on the conversion. The Redhawks gave up a safety in the final period, and the score ended at 56-0.

The Cardinals' defensive line had greater speed and agility, frustrating the Redhawks all night. In the first quarter, the Cards made several clean, hard tackles on two of Touchet's top players, Tyler Pumphrey and Thads Krumbah, which seemed to have affected the outcome. Unable to score, the Redhawk team was clearly frustrated by the end of the game. The previous week, they lost 46-0 at Dufur and have yet to score this year.

The next home game for the Cardinals will be on September 27, against a powerful Dayton Bulldog team that defeated the Yakima Nation tribal team 94-0.

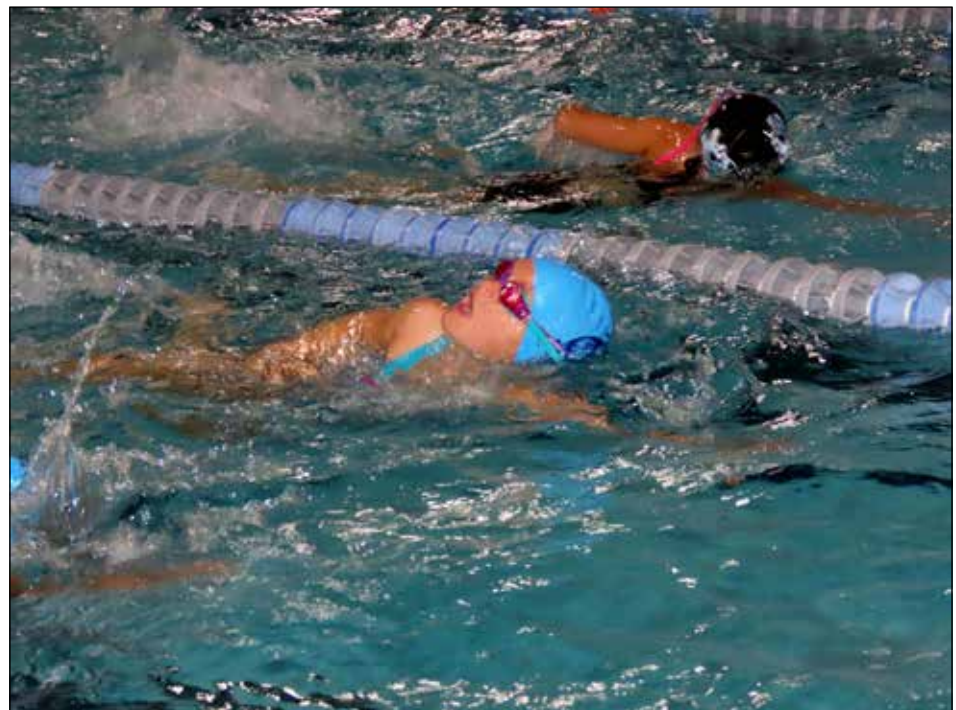

Ten Years Ago
September 18, 2014



[Photo Caption] Jim and Geraine Hansen, Waitsburg's 2014 Pioneers of the Year, reside on a picturesque plot near the top of what their daughter Mary calls "the Hansen version of Walton Mountain." Mary lives just a half-mile up the road; daughter Karen Yager is three miles up; and son Norman lives in the original family homestead on top of Coppei Mountain. In addition to the mountain-dwellers, the immediate Hansen clan includes daughters Cheryl in Pullman, Jeanette in Walla Walla, and son John in Bellingham. Jim's Waitsburg family ties hark back to the late 1800's. His great-great maternal grandfather, Robert William Leid Sr., was a stonemason and music teacher in Scotland before emigrating to Canada where he raised his family. His son, Robert Leid, Jr., moved from Canada to Waitsburg and settled in a log cabin atop Coppei Mountain in 1888.

Twenty-Five Years Ago
September 16, 1999

In the 1930's, Marge Turley's father Dale McCullum took on a second ranch to farm and, there being no money to pay for a hired hand, did what every farm family did back then: put their children to work. So Marge worked in the summerfallow, driving a mule team pulling a harrow or rod weeder. "What used to get me was we had to get up at 3 o'clock in the morning to feed the mules and everything so we could get into the field by 6," Turley remembers. Back then the labor-intensive farming practices meant long days and plenty of to do for all members of a farmer's family. That important work was put before schooling and it was no different in Marge's case. Fall work delayed her entering school with her peers and could've put her behind in her studies except for school superintendent George Reissner, who kept a desk in his office and tutored Marge and two others, Harold Reavis and Clayton Records, she recalls. Thanks to Reissner, Marge graduated from Prescott High School with her class of 1935.

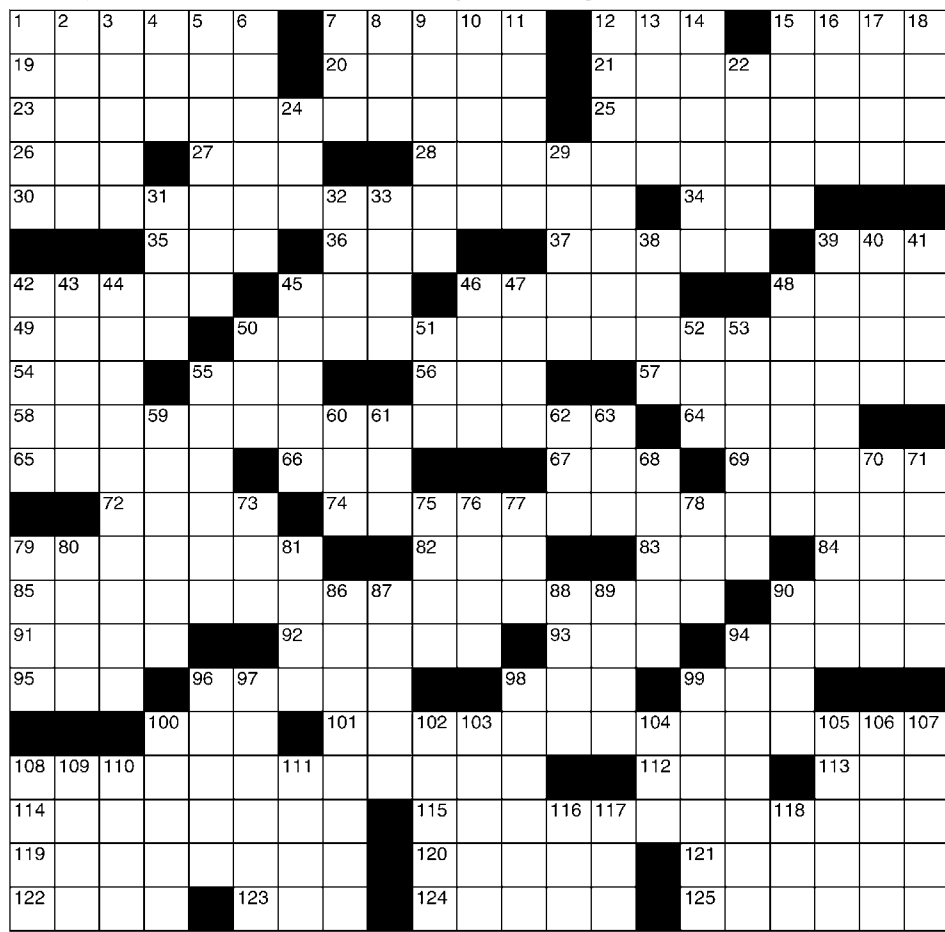

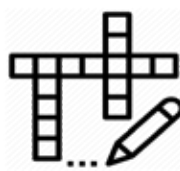

Stuffed Zucchini Boats



This is on my dinner menu tonight so I will be able to tell you if it's any good. Or if it isn't, find another recipe. It has all the ingredients that go well together and I have an over-large zucchini that needs to be used. Then I will be out of zucchini and I will have to resource more.

I don't do a lot of baking with zucchini but I do have my favorites. Chocolate Zucchini Cake, because it's moist enough not to need frosting and Chocolate Zucchini Bread, which I have put into the column. What are your favorites?

I thought about some cooking bloopers I have done and thought it would be fun to share some of your bloopers. One time a recipe called for wax paper on the bottom of a cake pan, for a baked cake. I didn't have any on hand, so substituted Saran wrap. Yep, that didn't work, the plastic wrap baked into the cake, creating a crispy bottom. It was inedible, unless one wanted to eat plastic. My son was going to surprise me with baked cookies one time and instead of 3/4 tsp salt, he put in four teaspoons. It was also not edible.

Ingredients:

- 4 medium zucchini
- 1/2 tsp dried Italian seasoning
- Salt and pepper to taste
- 2 tsp olive oil
- 1 pound mild Italian sausage
- 1/2 c. onion, finely diced
- 1 tsp minced garlic
- 2 cups marinara sauce
- 3/4 c. shredded mozzarella cheese
- 1 Tbsp chopped parsley

Directions:

Preheat oven to 400 degrees. Coat a large rectangular baking dish with cooking spray. Cut the zucchini in half lengthwise, then trim off the stem ends. Use a spoon to carefully scoop the flesh out of the zucchini. Sprinkle the Italian seasoning, salt and pepper over the zucchini shells. Arrange the zucchini in the baking dish

Heat the olive oil in a large pan over medium high heat. Add the sausage and cook for 4-5 minutes, breaking up the meat with a spatula. Add onion and cook for additional 4 minutes or until onion is softened. Add the garlic and cook for 30 seconds.

Season the sausage and vegetable mixture with salt and pepper. Pour the marinara sauce into the pan and simmer for 5 minutes. Spoon the meat mixture evenly into the zucchini shells, top with shredded cheese.

Bake for 25 minutes, until zucchini is tender and cheese is melted and golden brown.

** On the site there is a variation for a vegetarian recipe, Mexican, and they note that the pork sausage can be substituted for turkey sausage or hamburger. Different cheeses can be used.

My Notes: I used a can of marinara sauce that could have been a little more flavorful. The mild Italian sausage was bulk which had been in the freezer too long. The article had mentioned using the Italian sausage in casings, which I will try next time, or Bratwursts. I used a combination of mozzarella cheese and parmesan cheese. My zucchini was very thick and it could have used a bit more baking time or perhaps a prebake. I also put in some fresh cherry tomatoes. Would I do it again? Yes.

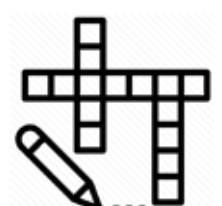
