

### **Port Commissioners** meet at Lyon's Ferry Marina

DAYTON - The Port of Columbia Commissioners held their regular meeting at 5 p.m. on June 14, 2023, at the Lyons Ferry Marina restaurant and on Zoom. The commissioners typically hold the June meeting at the marina, which is leased from the port. Commissioners present were Genie Crowe, Seth Bryan, Johnny Watts, and the Executive Director, Jennie Dickinson.

Dickinson reminded the commissioners that they had budgeted for a new staff position, an Economic Development Coordinator. At the time of the meeting, the port had received two applications, and applicants would be interviewed the following week.

Discussing the Rock Hill Industrial Park, Dickinson said the gravel on the roadways had been graded, and she hoped to have some areas of heavy traffic treated with lignin. Lignin is derived from plants and has been used to control dust and stabilize road gravel for over sixty years.

# Dayton City Council look to fill position vacated by Dieu

DAYTON- The Dayton City Council held its regular meeting on the evening of June 13, 2023 at Dayton City Hall. Mayor Zac Weatherford and council members Teeny McMunn, James Su'euga, Laura Aukerman, Kyle Anderson, Dain Nysoe, and Shannon McMillen were present; Tiger Dieu resigned on May 16, 2023, and his post remains vacant.

Sheriff Joe Helm gave his report in which he covered call statistics and mentioned some past and planned activities, but summarized his report by saying, "no major changes."

Director of Emergency Management Tina Bobbitt emphasized the need for everyone to make and maintain emergency preparedness kits. For citizens who do not have the financial means to create a complete kit, she suggested building one by adding necessary items once a month.

County Commissioner Marty Hall reported the county was in the early planning stages for a new law and justice center. According to Hall, the cost of running the center was more intimidating than the cost of building it. He said the estimate for the labor cost to run the center is approximately \$800,000 annually. Hall said the county hired a new building inspector, Robert Stearns, and a facilities manager, Tyler Huff. He also announced two public hearings, one for the proposed pool district will be held on July 3, 2023, at 10 a.m., and another for the proposed abolishment of the flood control zone district at 9 a.m. on June 26, 2023. After the consent agenda, minutes, and vouchers were approved, the council convened a public hearing on vacating the public right-of-way on Touchet Street south of Second Street. Following the hearing, the proposal to vacate the right-of-way was approved unanimously. An ordinance (no. 2000) to grant a franchise to Spectrum Pacific West, LLC (Charter Communications), allowing the operation and maintenance of telecommunications facilities in Dayton, was approved unanimously. The ordinance had previously been postponed to avoid interference with the Port of Columbia's broadband project. Ordinance 1514 was approved, authorizing the mayor to execute a professional service agreement with SCJ Alliance, Spokane, for consulting services and land use planning services. Next, the council discussed authorizing the Waitsburg Times as the official newspaper of record for the city. The City of Dayton put the contract out for bid and received responses from the Dayton Chronicle and the Waitsburg Times. The Times submitted the lowest bid.

The Lyons Ferry managers reported renting out the cabins and Conestoga wagons almost daily.

The commissioners discussed plans to add ten pull-through RV sites at the campground, which are required as a KOA campground. Anderson Perry is working on the preliminary design and cost estimate. The sites will be constructed near the overflow parking area, between the existing campsites and the entrance.

The cost for the new sites, including new bathhouses, is estimated at one and a half million dollars for design, permitting, and construction. Dickenson said the port would investigate funding, including grants for the project.

Dickinson said many food vendors signed up for this year's FoodStock at Blue Mountain Station, scheduled for 11 a.m. to 4 p.m. on July 15, 2023.

The construction of the community broadband project is fifty-eight percent complete and on target to be finished in September. A fiber lighting ceremony is scheduled for September 20, 2023, at Blue Mountain Station.

After the meeting was adjourned, the commissioners continued with their series of workshops in preparation for developing the Comprehensive Plan.

The mayor pointed out the Dayton Chronicle's bid was 75 percent higher. The council voted unanimously to approve the resolution naming The Times as the city paper of record.

The agenda listed interview time for the vacant city council position 7, which was vacated last month by Tiger Dieu. The position was advertised; however, at the time of the meeting, the city had not received any letters of interest for the seat. The city will advertise the position again.

Public Works Director Ryan Paulson talked about vandalism at the City Park and Caboose Park. A security system, magnetic lock system, and new steel doors will be installed in the park restrooms. The restrooms were damaged three times since the last council meeting, including one set on fire on June 5.

Paulson said many remote-read meters are on order, with 250 expected to be installed by the city this year.

First and Second Streets between Main and Commercial Streets will be closed from 7 a.m. to 7 p.m. between June 22 and 23 due to a film production led by Walla Walla Community College

The meeting adjourned after 8 p.m., with the next meeting scheduled for 6 p.m. on July 11, 2023.

#### **DAYTON VOTERS WOULD BE EXCLUDED FROM POTENTIAL LIBRARY VOTE**

DAYTON-Columbia County Prosecuting Attorney C. Dale Slack requested and received an informal opinion from the Washington State Office of the Attorney General clarifying the voter eligibility to petition and vote on the issues concerning the Columbia County Rural District Library.

A group of residents dissatisfied with the library's Request for a Reconsideration of Materials policy, are circulating a petition to place a proposition on the ballot to dissolve the library district. Should voters decide in favor of dissolution, all of the books and printed materials "shall" be sent to the State Library under RCW 27.12.320. According to Slack, "shall" means there's no alternative or way around that provision. The library board would then need to dispose of the remaining property that is not "books" or printed materials. The proposition would close the only public library in the county.

The petition must be presented to the library board by August 1, which then must forward it to the THE TIMES Columbia County Auditor's Office to be placed on the next general election ballot.

The library district must pay the cost of placing the proposition on the general election ballot. Library Board Chair Jay Ball said he would meet with the county auditor this week to determine the price.

The Auditor's Office will verify the signatures to determine if the proposition can be included on the ballot for voters in the county's unincorporated areas.

Slack said the AG's opinion clarified what he feared was the case; only county voters outside of Dayton or Starbuck can petition or vote on whether to dissolve a rural library district under the procedure set by the RCW.

"I am expecting that at least one City voter will file suit to stop the measure under the theory that the RCW is unconstitutional as applied here, as it denies the voters of the City (who pay the taxes and use the library) a say in the dissolution," wrote Stack in an email response to "The Times."

The Columbia County Rural Library District was created in 2005 to take over the library from the City of Dayton. Library Board Chair Jay Ball said the library became derelict after the city couldn't afford or diverted funds needed to operate and maintain it.

Ball credited Dayton resident Tanya Patton for saving and rebuilding the library, saying, "Tanya invented it."

Since the formation of the rural library district, the board and staff have added to the collection and services, and updated the building and facilities, and established professional library standards.

After a little over two years, Director Todd Vandenbark gave his letter of resignation to the library's board of trustees on June 14.

"I am writing to inform you that I am resigning my position effective Thursday, July 13, 2023, at the end of the workday," Vandenbark said in the statement.

Ball said the board would appoint an interim director while they look for a qualified replacement for Vandenbark. The candidate must have a master's degree in library science.



### Stopping for coffee

One of the advantages of owning a coffee shop in Waitsburg is meeting visitors who come to town, visiting relatives and friends, exploring, or passing through on bigger adventures.

This weekend, I met Laurent and Patricia Zirotti of Coeur d'Alene, Idaho, who were in town to take the Two-Day Intensive Course at the Monteillet Fromagerie outside Dayton.

The fromagerie's owners, Joan and Pierre-Louis Monteillet, raise French Alpine goats and East Friesian-Lucaune sheep on their 32-acre farmstead. They use the milk to produce small batches of artisan cheeses using traditional techniques and inspiration from the Roquefort region of France, where Pierre-Louise Monteillet was born. The couple also offers workshops on cheesemaking, farm-to-table events, and farm stays at the dairy and cheese facility.

The two-day workshop is one of several offered and is for anyone interested in milk-to-table-cheese production and maintaining an aging cellar. Laurent said he would be taking back what he learned to share with his students at the Spokane Community College Culinary Program, where he is an instructor. Patricia said they would also use the workshop's information in their kitchen.

The Zirotti's found common ground with their instructor Pierre Louis. All are immigrants from France with shared interests and histories. Like Pierre-Louis, they have brought French cuisine and techniques to their community. The couple said they felt welcomed when they moved to pursue their American dreams.

Two years ago, the Zirottis chose to close their restaurant Fleur de Sel, in Post Falls, Idaho, known for its French techniques and European menu. After 13 years, the couple wanted to reduce their workload and have time to pursue other interests.

Chef Laurent Zirotti for a prestigious James Beard Award for his work at Fleur de Sel. As an example of how small the world is, he was a semi-finalist in the same category as Mike Easton, owner of Waitsburg's newest restaurant, Bar Bacetto. Easton was nominated for his Seattle restaurant Il Corvo.

Finishing their coffee and scones at Ten Ton Coffee in the morning before driving home, Patricia and Laurent said they enjoyed visiting the Walla Walla Valley, impressed by the Americana landscape, the new businesses, and the diversity they experienced here. They noted that at American 35 the previous evening, five out of eight diners at their table were immigrants.

#### **Ten Years Ago**

#### June 20, 2013

Though their numbers have declined over the years, the dedication and patriotism of Waitsburg's American Legion members has not. Current club members, mostly World War II vets, are hoping younger generations of men and women will join them in their quest to support veterans and families. One of Waitsburg's oldest service clubs, the Samuel W. Southard Post #35 was chartered in August 1919. The post was named in honor of 23-year-old Samuel W. Southard, the first Waitsburg serviceman to make the supreme sacrifice in World War I, in 1918. In 1921, a large group of Waitsburg citizens donated personal funds of \$6,000 to buy a meeting place for the Legion. They purchased a hotel building that was located between Main and Coppei, near what is now the Waitsburg Business Center. After being destroyed by fire in 1928, the \$5,000 insurance payout was used to build a new Hall on Main Street.

## **Strawberries and Cream Pretzel Pie**

Every June, I anticipate the first batch of ripe strawberries in our backyard. Checking the patch each morning I look for the bright red fruit, like little ruby gems, peeking out from under the shade of their leaves. In time for our family Fathers' Day celebration, we had a bounty of gorgeous strawberries ready to pluck last week. This delightful pie with a cloud of creamy filling in a sweet and salty pretzel crust, acts as the perfect vehicle for highlighting the beauty of sun-ripened strawberries. A celebration of the season!



**Ingredients:** 

14 tablespoons unsalted butter, softened, plus more

2 cups plus 2 tablespoons un-sifted confectioners' sugar 3 cups (120 grams) mini pretzels, finely ground

- 1 cup all-purpose flour
- 1 teaspoon baking soda
- 1 teaspoon kosher salt
- 12 ounces cream cheese
- 1<sup>1</sup>/<sub>2</sub> cups heavy whipping cream

1 pound fresh strawberries, hulled and thinly sliced lengthwise Fresh mint or basil, thinly sliced for garnish

#### **Directions:**

Preheat the oven to 400 degrees. Prepare a 9-inch, deep pie dish by generously greasing with butter.

First make the crust. In a mixing bowl, combine the 14 tablespoons of butter with 1/2 cup of the confectioners' sugar. Use an electric mixer to beat the sugar into the butter, then add the ground pretzels, flour, baking soda, and salt. Continue to beat on low speed until just combined, then increase the speed to high and beat until a soft, cohesive dough is formed. Gather the dough and transfer to the prepared pie dish. Use your fingers to press the mixture into an even layer across the bottom and sides of the dish. Allow the edges to be thicker and crimp like you would a regular pie crust. Make sure the corners and bottom are not too thick. Place in hot oven and bake until crust is slightly puffed and a deep golden-brown color, about 12 to 15 minutes. Remove and allow to cool completely while you make the filling.

Next prepare the filling. With an electric mixer beat the cream cheese on high speed for 1 minute to soften. Turn the mixer off then add 1 ½ cups of the confectioners' sugar. Continue to beat on low speed until combined. Use a rubber spatula to scrape down the sides of the bowl, then beat on high speed until fluffy, about 2 minutes. Next, with the mixer on low, add the heavy cream, a splash at a time, beating the cream evenly into the mixture before each addition. Scrape down the sides of the bowl and then increase the speed to high. Beat until mixture is whipped and billowy, about 2 more minutes. Will resemble a firm whipped cream or merengue.

When the crust is completely cool add the cream mixture and spread with a spatula. Cover and place in the refrigerator to set. Chill for at least 2 hours, or overnight to allow the cream filling to fully firm up. Shortly before serving, combine the sliced strawberries and 2 tablespoons of confectioners' sugar in a small bowl. Set aside and allow to macerate for at least 30 minutes. When ready, remove the pie from the refrigerator and spoon the strawberries over the top. Garnish the top with chiffonade of fresh mint or basil leaves. Serve immediately.






