

## **Two Dayton Homes Lost** to Fire

Investigators are still searching for the cause of a fire late Sunday night that destroyed two homes on East Washington Avenue in Dayton.

"Honestly I don't know if we'll ever find out what started it," Fire Chief Rick Turner, of Columbia County Fire District 3, told me on Monday afternoon. "We're still working on it, but the fire completely destroyed the house, and any little bit of evidence there was is probably gone."

Nobody was injured in the fire, which started at 11:25 p.m. in an unoccupied, derelict home on the corner at 203 E. Washington Ave. That structure and the house next door, owned by Dan and Rosy Nechodom, were both unoccupied that night. The Swan family, who had

## Council Considers Fairgrounds Plan

EQUESTRIAN CENTER BOARD IS READY TO RETURN REINS TO THE CITY

WAITSBURG – Two years ago, Councilman K.C. Kuykendall approached Waitsburg's city council with a proposal to transfer management of the horse facilities at the Waitsburg Fairgrounds to a nonprofit organization that would oversee the creation and development of what he hoped would become the Blue Mountain Equestrian Center.

That agreement was approved, with the city agreeing to a five-year commitment. At last month's council meeting, Kuykendall announced he was ready to call an early end to the agreement.

The original plan was to generate revenue that, over the course of five years, would fund nearly \$40,000 in improvements to the fairgrounds horse facilities, while removing responsibility for the facility's maintenance and management from the city.

The proposal provided for renovation of 10 to 12 stalls each year, with additional improvements starting in 2014. The \$40,000 in improvements planned for years one through five included the addition of a round pen, a 150' X 240' roping arena, a wash station, lighting and electrical upgrades, speaker upgrades, foaling stalls and turnouts, and a tack room as well as the stall renovations.

While not a total failure, Kuykendall said the plan failed to come to fruition.

"We ended each year in the black and had more cash on hand at the end of each year than budgeted, but that's purely because we never did really get the thing off the ground as far as the number of tenants that we wanted," Kuykendall said. "Revenue was lacking, and therefore the investments in projects are lacking, so all we were able to do were the very basics with spraying, raking, cleaning stalls, and running power to one of the barns," he added. "It didn't cost anything other than my time, but we never achieved the occupancy we wanted." Kuykendall said the group's advisory board was unable to get events scheduled and that boarding horses alone couldn't carry the financial burden. He did name several positive outcomes of the endeavor: positive feedback from the community, the board didn't have to tap the city for funds, and the group put paperwork in place for liability, rental forms and stable rules. "We just stopped short of being able to launch any kind of a real marketing campaign. A number of the folks that initially committed to try and help stand this thing up couldn't follow through with those commitments. At the end of the day, this type of an effort would require a much more strategic partnership with the city," he said. When asked his recommendation for facilities management, Kuykendall indicated he was ready to move on. "At this point, I'd like to say I gave it a yeoman's try," he said. "We got \$3,200 we can throw in the city coffers for a barbeque or something. I'm done with trying to stand it up as a separate stand-alone entity. "I think if we as a city and a council wanted to make it (the fairgrounds) a success like the Salmon Bakes and Celebration Days and other things, then we could probably turn what is currently a big eyesore into a pretty cool community asset," Kuykendall said. "But I think it would require commit-

## 'Breaking the Code'

War hero Murray Fisher will be honored by Mariners at Safeco Field



SEATTLE – It may be a challenging trip, but 94-year-old Murray Fisher didn't hesitate a moment when he was invited to be honored by the Seattle Mariners at Safeco Field as part of their "Salute to Those Who Served" program.

Fisher will be recognized on July 25 for the role he played during WWII as a top secret code breaker – secrets he's now free, and proud, to share.

Fisher attended school in Waitsburg until his senior year, when his father, who worked for the railroad, was transferred to Dayton. Though he graduated from Dayton, Fisher, who now lives in Walla Walla, is always included in the Waitburg reunion list.

"He's very proud of his small-town heritage and still speaks of the Waitsburg area as his home," said Fisher's daughter, Karen Fisher-Alaniz.

Karen played a key role in Fisher's upcoming recognition. Growing up, she knew her father had been in the war, but was unaware of the role he played and the pain he suffered. She had been told that he spent the war sitting behind a desk and never saw battle.

When Fisher began suffering from post-traumatic stress disorder (PTSD) at the age of 81, Karen began asking questions. She also started transcribing a stack of letters Fisher had kept from the war, which led to even more questions.

Over time, she learned that, far from sitting behind a desk, her father had spent his enlistment copying a Japanese code, while aboard ships and submarines in the battles of both Iwo Jima and Okinawa. She also learned that Fisher held his best friend, Mal, as he died – the experience that later triggered his PTSD.

Karen eventually wrote a book about her father's experience and the secrets he'd kept for over 50 years. *Breaking the Code: A Father's Secret, a Daughter's Journey, and the Question That Changed Everything,* was published by Sourcebooks in 2011.

Shortly after, Fisher was interviewed by NPR's Audie Cornish. Today, he remains eager to share his tale with younger veterans who face the same







## EMMA PHILBROOK: STUDENT LIFE My Exotic Species Research

I've always loved studying environmental science for two basic reasons. One is the large amount of impressive vocabulary you pick up and can use



in everyday contexts– e.g., "That's eutrophication for ya!"

and, "I sense the formation of a positive feedback cycle here".

The second is how much of it applies to life and society in general. High school is an ecosystem, and it's much easier to navigate when one thinks of it in terms of resource niches, apex predators, and keystone species, as opposed to attempting to reconcile it with the behavior of rational humans.

I have not yet entered college, but from what people tell me, the social ecosystem there is rather different from in high school, particularly because it contains several species with which I have had little experience:

• The Freshman is the lowest form of life on a college campus. They strongly resemble humans, the main difference being that they lack navigational skills. They spend a good deal of their time in chrysalis-like structures known as "firstyear dorms" which would make most insects claustrophobic. Upon exiting the first-year dorm, freshWhackjob and the West Coast Liberal Whackjob. These creatures are amphibious and dwell in saltwater, hence the higher population density in coastal areas. ment on our part and would definitely have an impact on the staff."

Following a brief discussion by the council, Mayor Walt Gobel suggested putting the topic on hold. "Can we put this on the burner for awhile, let it heat up, and then we'll come back to it again as time goes by?" he asked.

The discussion did result in the council approving the hire of a penitentiary work crew, as needed, to help maintain the facilities. The penitentiary will provide a work crew of 10 men for a full day for \$200. With the city crew spread thin, the council directed City Administrator Randy Hinchliffe to utilize the crew as often as needed.

"The fairgrounds is the orphan in the city due to a lack of manpower," said councilmember Kevin House. "This could help prep it for events if we take it off the city's shoulders. Schedule it (maintenance) regularly, plan for that, and keep the facility up."

## NEWS BRIEFS FIREWORKS SAFETY URGED

WALLA WALLA COUNTY – With high temps and a burn ban in effect, Walla Walla County commissioners and fire officials are urging citizens to take extra precautions this 4<sup>th</sup> of July. Statistics state that the 4<sup>th</sup> of July results in more than \$35 million in damages annually, nationwide. "Although last year we thought that the fire severity issues couldn't get any worse, this year, with the lack of snow pack in the Blues and the extended triple-digit forecast for the county, we are definitely in extreme conditions for the upcoming 4th of July holiday," Walla Walla County Fire Protection District No. 5 chief Mick Wickstrom said. County officials offer these tips for preventing firework fires: Don't set off fireworks near dry materials such as fields or roadsides. Make sure the area is clear of hazards such as trees, streamers, flammable helium and balloons. Never throw or point fireworks toward people, animals, vehicles, structures or flammable materials. One the fireworks are over, make sure all items are heat-free before leaving the area and disposing of the debris. Don't use illegal fireworks. Keep a fire extinguisher and/or hose nearby. In Walla Walla County, fireworks may be discharged only between the hours of 9 a.m. and 11 p.m. on July 1,2, and 3 and then on July 4, from 9 a.m. to midnight. Within the city limits of Walla Walla, fireworks may only discharged on July 4 and only between the hours of 9 a.m. and midnight.

Wren had forgotten some items she needed in the house and was inside grabbing them while I waited in the truck, windows rolled down. I was sending an email on my iPhone. It was 11:24 p.m. Something caught my eye on the corner of the block. It looked like a flicker of light. There were no other lights down there, other than the street lamp. No smoke. No people around. No sounds.

I opened the door to the cab and climbed out to see better. Fire! I could see a single tongue of flames at the front of the dark, dilapidated house. In a matter of seconds, flames erupted from several sides of the building and engulfed the entire structure. Swallowed it whole.

### **Race to Action**

I don't remember well the next few seconds. I remember seeing my daughter locking the front door, her back to the street, with a bundle of belongings in her hands. I remember screaming at her. "Get Chase. Tell her to get Maggie and get out of the house. Now!" My voice is still hoarse as I write this, from all the hollering I did that night.

In the confusion that followed – Wren not understanding why I was in a panic, then panicking herself and trying to get her sister to comply with the evacuation – I could feel the oven-heat of the fire from my yard.

I dialed 911 on my phone and looked up to see thick clouds and flying, burning embers streaming over my head toward all the hot, dry and unprotected yards of my neighborhood. My hands were shaking and my stomach was in knots. This was my first house fire. And I was sure all the homes in the block were going to ignite from the burning embers.

The Swans! I looked back to the dark house next door, between me and the inferno. I had no idea if Michelle and Scott Swan were asleep in the house with their family. I knew they were in the process of moving out as well, but there were a number of cars in front of the house. I raced to their front porch, holding my phone as the line to 911 rang in my ear.

The heat was nearly unbearable in the neighbor's yard. Embers were raining down everywhere. And the gusting wind was blowing flames onto the Nechodom house, at 205 E. Washington Ave., where the Swans had been renters for several months. It was already catching fire on the west side.

The house had a glass-paneled front door. I banged on the door with my fist and hollered as loudly as I could. I could see my own front yard from the porch, and I yelled at Chase to get the dog and get in the truck. The 911 operator wanted to know the address of my emergency. I tried to give her the information and continue pounding on the door, hollering, at the same time. She said she was having computer problems and told me to stay on the line. Chase came up on the porch with me. Wren and the dog were getting in the truck. Chase was on the phone. She yelled to me: "They're not home. I have Michelle on the phone, and they're staying at their new place. They're not here."

er neighbors while we waited for the fire trucks. The rain of embers was thick.

It then occurred to me that my house was going to be next. What was left in there? I thought about all the boxes and furniture stacked in the living room ready for the big haul planned for the next day. Books, mementos, photos, camera, computer, piano, kitchen stuff. Goldfish, frogs and turtle. Chase was going to be so upset by the loss of the pets.

When Chase was back from alerting the neighbors, she and I took Maggie in the truck and raced off to wake Chris Ver Valen, my former husband. I was going to need help. We left Wren to take photos on my phone and keep in touch with me should things change. As I drove (over the speed limit I'm sure – sorry everyone), down Main Street, I was passed by the first fire engine. Another quickly followed.

After alerting Chris, we returned to the scene. We could see the blaze from Main Street at the corner of 3<sup>rd</sup> Street. My heart sank. I was sure my house was already alight. But it did not catch fire. Several bushes in the back yard burned to the ground. A few spots are black in the front yard. But Chris and Tony Willis, who lives across East Washington from the fire, were in the yard of our rental for more than an hour with hoses, soaking everything they could reach and putting out all the little flames that took hold.

## Firefighters, Friends Prevent Further Damage

Within a few minutes of my arrival back at the scene, the fire district had engines hooked to hydrants and were pumping streams of water at the main fire, the Nechodom's house and any flames trying to spread to our place. I spotted Dan Nechodom in the street a block away. He approached me.

"Is everyone okay?" Michelle Swan had called him after she got off the phone with my daughter, and he had raced over from his new residence in Waitsburg. "Yes," I told him. "Everyone is fine."

"That's all that matters then," he said. In the hours that followed, I spent time with the Swans, who had arrived to sit on the curb opposite the fire and hold each other as the flames took nearly all their earthly possessions. Several pet rabbits, which had been kept in a hutch on the west side of the home, were gone.

Family and friends rallied around the Swans. Scott, who was away working out of state, had already been told of the loss. Michelle was hugging my daughter, Chase, who cried when she thought about their loss and was shaking with the adrenaline - and a little fear when she realized she would have been alone in the house, in the bathtub, as the fire broke out if it had happened just a few minutes later. The smoke was thick as the firefighters fought the blaze. The house on the corner was gone. It burned to the ground. The Nechodom house was gutted, and the roof caved in. Dan Nechodom said he's meeting with his insurance assessor this week, but he assumes it will be a total loss. He, and the Ihle family before him, raised dozens of their own children and foster children in that home, he said.

### **Saving Other Homes**

Thank goodness. We dashed off the porch and ran to the truck. We jumped in, and I drove west, past the blaze. We could see that the west side of the Nechodom house was now on fire. I remembered the 911 operator, but I had dropped the phone on the floor of the pickup cab in my haste to get away from the heat and the embers. Holding a cellphone to your ear and shifting gears is not easy under the best of circumstances.

I screeched to a halt on the corner of North First and East Washington, in front of a vacant home for sale, kitty-corner from the burning houses. "Oh no! My shoes!" Chase cried. I thought she was worried about them burning up – turns out, she was barefoot and hadn't realized until just then.

I think we must have stood on the corner watching for a full minute in awe. Less than five minutes had passed, and the house on the corner was almost gone. It was a blackened skeleton against the bright glare of the flames. One or two people were now out on the street, taking photos on their phones, texting or calling other people.

My brain started working again. The most important thing was done. Everyone was out of the nearby houses and safe. I sent Chase to wake the neighbors directly across the alley from the burning houses. As she left, Deputy Jason DeVoir arrived on the scene. I suggested he alert oth-

### Loss and Support

Timothy Ihle, one of the children fostered in that home, was at the scene on Sunday night. He watched quietly with my daughter, Wren, from the curb. "A lot of childhood memories going up in smoke," he said to her. Marshall Nechodom, who spent most of his late childhood in the house with his parents, was standing at the white picket fence around the house gazing at the wreckage the next morning when I stopped by to check on things.

"Did you have anything in the house?" I asked him. "Oh yeah," he said. "Lots of things. But it's all good." He took a piece of the picket fence as a memento and wandered away.

The garage seems to have survived, Dan Nechodom said on Monday afternoon. Several expensive pieces of sports equipment were in the garage, he said. But a few priceless family heirlooms – a chandelier and a sewing table – were lost.

The Swan family lost nearly everything. They had a few things at their new residence, but not much. But on Tuesday, Michelle had posted on Facebook that she'd found a few totes of items that may be salvageable. And her family and friends continue to rally around her and her family. Several started a donation fund for the family at http://www.gofundme.com/ theswans.

"Feeling very humbled," Michelle wrote on Facebook Monday night. "Thank you everyone for your gracious love and support. Has been a very difficult day and we survived it!"

# **Best Job Ever**

## JUDY ROWLAND CELEBRATES NINE YEARS RUNNING ROOSTER'S BREW AT DAYTON'S WEST END

DAYTON – Many people in Columbia County know what it's like to wake to the sound of roosters crowing. Even in some parts of town. For the caffeinated at heart in Dayton, a rooster in the morning means so much more.

It means fresh coffee, conveniently located right off of Highway 12 on the western edge of town, served by the chipper, smiling and often psychic Judy Rowland.

"People hardly ever have to order," Rowland said, claiming that she has memorized 95 percent of her customers' favorite drinks. "I know what they want."

Rowland has owned and operated Rooster's Brew at 36709 Highway 12 for the last nine years. It wasn't a career she planned, but she couldn't be happier.

"It's the best job I've ever had," she said. "The people, oh my. They're so supportive!"

Rowland confesses she has never bought an espresso. She doesn't even drink coffee anymore.

"When I first started, I had to tell people, 'Okay, taste that and tell me if it needs more. I can't take away but I can always add more."

Rowland moved to Dayton with her husband, Bill Rowland, 31 years ago. She had lived in Dayton previously but had moved away for a number of years.

Bill worked at many jobs over the years – drilling and blasting, county

road crew and groomer at Ski Bluewood. Rowland tried out many office positions around town – she worked a clerical job at Dayton General Hospital, The Dayton Chronicle, at Banner Bank, at the former DQS and at McQuary's Grocery.

Then, in 2006, Tom Heinrich bought Broken Spoke Storage and former Rooster's Brew building, which was originally run by Ginger Watko and her husband, Rowland said. Heinrich, who doesn't live in the area, needed someone to help manage the storage units – so he offered Rowland the coffee shop building in exchange.

"It worked out great," Rowland said. She kept the name of the old business. She works from about 4:30 a.m. until early afternoon in the coffee shop and can help storage renters with keys, contracts and other issues.

"If I do have to take off, I leave a little note in the window so people know where I went."

Rowland said she wasn't sure right away whether the business would work. She did some calculations on a scrap of paper (which she still has), estimating how many cups of coffee at what price she'd need to sell to make it. Her numbers were pretty close – in fact, she does even better than she expected. And she does it all herself – no helpers.

Once every other Sunday she dashes to the Tri-Cities for supplies, but otherwise she's almost always at the shop or at home, where she and Bill live out on North Touchet Road.

She and Bill do not have children together, but she is step-mom to Bill's children. And many of the children (and adults) in the community are part of her extended family. She has photos and drawings all over the refrigerator in the shop.

Over the years, she's had her share of trials and tribulations. She's been burglarized three times, she said.

"It's kinda devastating." But she

doesn't store much in the way of valuables or cash in the little building, so she hasn't lost much.

The rewards have been much more influential. She has a loyal customer base. About 40 percent of her customers each day are regulars. She even knows their routines. She'll often check the clock and prepare a drink just in time for the customer to drive up to the window – and Rowland will hold the drink out the window so the customer can grab and go.

Many regulars keep a "reverse tab" in the shop – a carefully guarded sack of labeled envelopes of cash from which Rowland can pull out each day's cup of joe and add to her till. "And I never send someone away without their coffee," she said.

If a newbie stops in without realizing that Rowland doesn't take credit or debit cards, she'll offer to let them have their drink with the promise to return another day and pay.

"They almost always come back to pay," she said. "And they often buy another drink while they're here paying for the last one."

She even has regulars who don't have a favorite drink but who trust her

to make them a yummy surprise every day. She's never gotten a complaint.

Rowland hears stories all day long – complaints about work, excited chatter about life, gossip, and other news. She calls many people "honey" and gives some tough love where it's needed.

"Here you go honey," she tells one man who's stopped for a drink and is already having a bad morning. "Just a plain one today. You have enough on your mind."

For another customer, she adds a dash of sweet love. "I put a little whipped cream on this one," she said. "It'll make her a happy woman."

One dedicated customer, a woman who often drives through town on her way to Idaho, will stop only at Rooster's Brew for her chai tea.

In return for her morning ministrations, Rowland is often treated herself. One long-time storage-unit renter, Bob, donated all of his wife's rooster decorations when she passed away. Rowland says she hasn't bought any of the many roosters that festoon the inside of the shop. They've all been gifted by the grateful coffee lovers in her life.

## **CCHS Set to Hire Architect Soon**

CONSTRUCTION MAY START IN FALL; BOARD IS ALSO LOOKING AT ALTERNATIVES FOR NEW IT SYSTEM

DAYTON – Executives with the Columbia County Health System are in the final stages of hiring an architect for the Dayton General Hospital upgrade approved by voters with a \$5.5 million bond levy last year.

Chief Operations Officer Shane McGuire reported to the hospital district board last week that two architects had replied so far to the ad that ran in both The Times and Dayton Chronicle for the last two weeks.

The timeline for the project is to have an architect selected before the next board meeting in July, McGuire said. Interim CEO Jon Smiley will select a team to rate and choose the best candidate.

From there, the architect will submit plans for the board of directors to approve. The architect will

use the report created by Stroudwater Associates as a basis for his or her design.

At their meeting last month, the board said they hoped to start the upgrade to the facility in mid to late fall, depending on how fast the state health department responds to their go-ahead request for the construction, which will primarily take place inside the current hospital footprint.

In a separate move, the directors agreed to allow McGuire and Smiley to research a new Information Technology system for the health system, including DGH, Booker Rest Home, and the clinics in Dayton and Waitsburg.

The state health department is encouraging medical providers to become more proactive and focus on population health rather than just individual health, board chair Ted Paterson said. This will require that hospitals and clinics be able to produce reports and other documentation of their quality of service.

The current IT system at CCHS is outdated and won't fit the bill, board members said. The matter was discussed at length in previous board meetings as well.

"Our doctors may provide quality care, but if we can't report quality of care, it didn't happen," Paterson said. A new system is likely to cost \$1.5 million over the next five years, with installation and regular service fees, McGuire said. Board members unanimously agreed that it was a move that had to be made. Lee Holter, the new CCHS chief financial officer, said he supported the decision.

The hospital district purchase a new and costly IT system five years ago, CPSI, but that system has not kept up with the state requirements for reporting, McGuire said.

"We have given CPSI every opportunity to come to the table with something we like, and they just keep missing the mark."

CCHS executives are looking at a system called Meditech. They told the board that, in addition to being a top-tier system that has come down to affordable prices recently, it is a system used by many surrounding health systems – this means patient information can be more easily shared between providers.

And service support is in-state, which makes it more likely that the company will keep up with Washington state reporting regulations, McGuire and Holter both stated.

# **Pockets with Purpose**

Pocket Innerwear aims to make living with diabetes easier

WAITSBURG – "But where do we put it?"

That is the first questions parents ask insulin pump representatives, doctors, and diabetes educators when setting up a small child with a pump or continuous glucose monitor (CGM) to help to manage their diabetes.

Pocket Innerwear owners believe they have the answer, and the company recently launched a Kickstarter campaign to help make that solution available on a larger scale.

"It can be overwhelming for a parent to figure out how to help a kid maintain, manage and wear a \$10,000 device," said Pocket Innerwear co-founder and CFO Laurel Bloomfield of Waitsburg.

She, along with partners Chy Jorgenson of Dayton, and Katie Larsen and Nicholle Peterson of Idaho Falls, Ida., are up to meeting that challenge.

Looking for a creative outlet, the four ladies started a successful online women's boutique called My Rolling Rack several years ago. After proving that they could sell clothes, they decide apply their creativity to solving problems.

Their first solution-based fashion item, a boot cuff with a pocket to hold a cell phone, flew off the shelves. From that cuff, Pocket Innerwear was born.

The ladies quickly developed the patent-pending pocket that they incorporated into stretchy TechWear, which can be worn under everyday clothing. Each piece has a pocket that can be used to hold a phone, credit card, cash or keys.

Bloomfield said the partners were brainstorming during a conference call when they hit upon the idea that they're most excited about – adapting their pockets to hold insulin pumps. Each of the ladies has friends or family members with type 1 diabetes and they were eager to design a product that would make life with diabetes easier.

"We were also inspired by Sierra Anne Sandison, Miss Idaho 2014, who is best known for wearing her pump onstage during the Miss America bikini competition," Bloomfield said. "We realized our pockets could have a higher purpose."

Bloomfield said Pocket Innerwear began creating PumpPocket prototypes about six months ago and the response has been incredible. Sandison was



so impressed with the sample product that she even partnered with the company on their Kickstarter campaign.

An outing with the former Miss Idaho, as well as an autographed copy of her new book, "Sugar Linings," is one of the pledge prizes.

Pocket Innerwear consulted with doctors, diabetic camps and charities, endocrinologists and T-Slim and DexCom pump representatives when creating their T1D (type 1 diabetes) line of PumpPockets. They have also sent out hundreds of samples, soliciting feedback from both parents and users, Bloomfield said.

PumpPockets free users from wearing their pump clipped to their pants, stuck in a bra, or from having to wear a fanny pack. Instead, the pockets are sewn into comfortable tank tops, undershirts, boy shorts, boxer briefs, bandeaus and more.

Men and boys can carry their pumps in a new PumpBrief and designs for men's tanks and compression tops are in the works.

The discreet pocket holds the insulin pump or CGM while the tubing feeds through the back of the pocket to the infusion site. The pump stays in place and the tubing is tucked away rather than hanging loose where it can get caught and torn loose, possibly even pulling out the infusion site.

Bloomfield says their pockets are simple, but that it's the right combination of stretchy fabric, pocket dimensions, and flap depth that make them work. "Kids can even do flips on the trampoline and the pump stays in place," she said.

Funds from the Kickstarter campaign will be used to make the move to larger scale manufacturing. Bloomfield says the company has several ladies that sew for them now, but they have sent samples to manufacturing plants in Texas, Utah and China.

Bloomfield says the partners are most excited about their One for One mission. "For every adult PumpPocket we sell, we give one away," she said. TID TechWear pieces are donated to Pocket Innerwear's official partners: Beyond Type 1, Diabetes Daily, Carb DM and Sierra Sandison.

Pocket Innerwear's Kickstarter page says, "We want to flood every charity event, camp and foundation with the gift of freedom and security. We want to flood the market with a solution that changes lives. Back us and contribute to this massive effort – a reward in itself."

To meet their goal, Pocket Innerwear must raise \$20,000 in 30 days, with a deadline of July 18. When The Times went to press on Tuesday afternoon, the company was well on its way with XX backers having pledged \$XXX.

## **Aboard the USS Turner Joy**

weekend, while all of you were marin a t i n g in record

triple-digit heat, I was relaxing on Puget Sound, enjoying temperatures in the mid-80s and mild breezes off the water.

The official purpose of my trip was to check on my father's boat, which is moored at the Port of Bremerton marina. In reality, that was just a free place to sleep while I got a quick big-city fix.

Besides a couple of ferry trips to Seattle, and way too much time and money spent at Starbucks, I took some time Saturday to tour a couple of Naval museums in Bremerton and learn a lot about the Puget Sound area's contribution to U.S. Naval history.

Those visits allowed me to provide the first installment of what we hope will be an occasional feature in The Times this summer. Since there are no high school sports to cover on these pages, we plan to share some of our summer adventures here, and hopefully inspire our readers to take road trips of your own outside the Touchet Valley, and maybe learn something while you're at it.

The first museum I visited in Bremerton was a ship. Here's its story:

In August 1964, the American destroyer USS Turner Joy was accompanying another destroyer, USS Maddox, on "watch dog" patrols in the Gulf of Tonkin off the coast of Viet Nam. When the Maddox reported sighting

North Vietnamese torpedo boats, the two ships fired rockets, apparently sinking two of them.

Two days later, in very heavy seas, the Turner Joy's radar picked up what appeared to be more torpedo boats. Again the ships fired shells, while planes from the nearby aircraft carrier USS Ticonderoga attacked from the air. Radar operators were never able to confirm for sure whether the ships had been under attack the second time. Some have claimed ever since that the radar readings were due to weather issues.

This conflict became known as the "Gulf of Tonkin Incident." As a direct result of this incident, despite the lack of clarity about what happened, the U.S. Congress passed the "Gulf of Tonkin Resolution," which served as the official start of the United States' war against North Vietnam.

The USS Turner Joy is now berthed at the Port of Bremerton, about 100 yards from my dad's boat. It's a museum, and while I've seen it there for years, I took the tour for the first time on Saturday. Before I get to that, a little more history:

The Turner Joy was built by the Puget Sound Bridge and Dredging Company in Seattle. It was launched in 1958 tom row, from left: The equipment on the ship's bridge was high-tech in its day. ### and was commissioned at the Naval Shipyard in Bremerton.

The ship is named after Adm. Charles Turner Joy, who was a Naval Captain and ship commander in the Pacific during World War II, and later became an Admiral and commander of the Pacific fleet during the Korean War in the early 1950s. He died in 1956.

His namesake ship made several tours to Southeast Asia during the Vietnam War years and for a few years after. It was retired from service in 1982.

In the early 1990s, the Turner Joy was refurbished by the Bremerton Historic Ships Association, and was opened to the public at the Bremerton Port in 1992.

For a \$14 entry fee, I was able to roam almost the entire ship, including two decks below and two levels above. The tours are all self-guided, but there is copious signage describing what you see. I even climbed inside the gun turrets, two of which are trained on a condominium complex on the Bremerton waterfront.

The living and eating (and yes, bathroom) facil-

## PUGET SOUND NAVY MUSEUM

BREMERTON - The Bremerton Naval Shipyard is one of the largest U.S. Navy facilities. Approximately 190 acres was purchased on Sinclair Inlet in 1891 for what was to be a repair facility.

With the advent of World War I, the yard began constructing battleships. It became a major shipbuilding and repair facility during World War II, and to this day remains an important maintenance and repair facility for navy ships.

The Puget Sound Navy Museum, located next to the Bremerton ferry dock, tells the story of the Bremerton shipyards. It also contains a wide range of exhibits about the Navy and maritime military history in general.

One of my favorite exhibits is called "The Golden Age of Tattoos." Today's tattoo enthusiasts might be surprised at the level of artistic talent that went into tattooing a century ago. The Museum's exhibit shows many examples. Tattoos were particularly popular among Navy sailors in the first half of the 20<sup>th</sup> century.

The museum also includes exhibits showing several types of ships and what life is like on them for sailors today.

If you're in the Seattle area, it's worth a ferry ride to Bremerton to visit the Puget Sound Navy Museum – and the USS Turner Joy.

## **Truck Flips Near Dayton**

DAYTON - A single-vehicle accident on Highway 12 west of Dayton blocked traffic for several hours on Monday morning. At approximately 10 a.m., a caller reported that a semi-truck traveling eastbound on the highway hauling produce had drifted off the road into the eastbound ditch at milepost 366. ities are fascinating. With a crew of nearly 250 sailors and officers, privacy was clearly out of the question; unless maybe if you were working in the ship's bowels, with the engines and boiler.

The myriad controls on the ship are amazingly primitive by today's standards. Mechanical dials are everywhere, and the only electronics are old-fashioned sonar and radar.

When I was there, a large group was preparing for the wedding of a sailor, which was held that afternoon on the aft of the ship. Other visitors of all ages were touring the ship, including young ones who enjoyed climbing inside the gun turrets at least as much as I did.

Since the Gulf of Tonkin incident took place about two weeks before my ninth birthday, my ship tour (and the Googling I did along with it) brought back lots of memories of things I heard about as a child, but didn't really understand back then.

It also made me appreciate more than ever the commitment and bravery of the sailors and officers who served on this ship and others like it. The Turner Joy seems big when parked next to all those pleasure boats in the harbor, but to those on board at sea, it must have seemed tiny.


