### Port Commissioners hear concerns about railroad right-ofway, Columbia Pulp asset auction

DAYTON – The Columbia Port Commissioners held their regular meeting at 5 p.m. on May 10, 2023, in the Port of Columbia conference room and on Zoom. Commissioners Genie Crowe, Seth Bryan, and the Executive Director, Jennie Dickinson, were present. Johnny Watts was absent.

During public comment, Joann Patras from All Saints Thrift Store thanked Dickinson for her help in the thrift store's successful grant application to Sherwood Trust.

### Dayton City Council approved road work, inclusion on Parks and Rec proposal

DAYTON- The Dayton City Council held its regular meeting at 6 p.m. on May 10, 2023. Mayor Zac Weatherford and Council Members Teeny McMunn, James Su'euga, Laura Aukerman, Kyle Anderson, Dain Nysoe, Shannon McMillen, and Tiger Dieu were present at Dayton City Hall.

Belinda Larsen from the Chamber of Commerce gave an update on chamber activities. She reminded the council that

Patras addressed Dickinson, saying, "What a blessing you were to me. You were so kind and so helpful."

She said that the result was that Sherwood awarded \$10,000 more than they requested. The funds were used to buy a 2021 Silverado 1500 with decals of their logo on the side.

Crowe read a letter from Carol Anderson, who opposed the port selling the rail right-of-way. Anderson was most concerned about the line's future should it be sold.

Dickinson said a new two-year lease at Blue Mountain Station, signed with Mast Year Cider Collective, is to take effect on June 1, 2023.

Dickinson said assets of Columbia Pulp, LLC are scheduled to be auctioned in June 2023. She said there were a couple of potential bidders who would need to develop a product.

She mentioned the Packaging Corporation of America announced the pulp mill at Wallua will be mothballed until autumn, laying off 300 of their 450 employees. Dickenson was worried about what that meant for the whole pulp industry.

There were no significant updates to the broadband project. The broadband project is going well. Columbia iConnect has signed a lease, and the port is working on others.

All customer issues have been taken care of with regard to ground cover and vaults that needed to be moved or modified due to sinking.

Lyons Ferry passed an on-site DOH septic inspection on large septic systems.

The restaurant increased operating hours, now serving dinner on Fridays and Saturdays. They have also begun offering local meat for burgers and fish caught from the river.

An Artisan miller considering space at BMS has chosen a different site because the port property does not have natural gas.

A citizen in the final public comment period expressed concern about selling the railroad right-of-way. Without the railway, the speaker was worried about farmers having efficient grain transportation if dams were removed and barge traffic was eliminated. He was concerned that a future owner could use the right-of-way for non-transportation use, including housing.

The regular commissioners' meeting adjourned at 5:28 p.m., followed by a workshop facilitated by Maul, Foster, and Alongi on the Comprehensive Plan. Discussions included possibly building affordable housing on seven acres West of Blue Mountain Station. This affordable housing could consist of mixed single-family units and apartments.

The workshop adjourned at 6:24 p.m.

Dayton Days is scheduled for Memorial Day weekend and All Wheels Weekend will be in June.

Sheriff Helm reported that two deputies graduated from the state's police academy and are completing their field training. The academy's staff and fellow cadets selected Deputy Daniel Wagner to receive the Patrol Partner Award. He was chosen as the cadet most wanted to assist on a call due to his demeanor, ability, and skill.

Helm said a Search and Rescue Academy will be held May 9-21, 2023, at Lewis and Clark Park. Citizens interested in participating may contact the Sheriff's Office. He said the Sheriff's Office received a Yamaha side-by-side from Main Street Motorsports in Lewiston, Idaho, to replace the utility vehicle donated last year. Main Street Motorsports plans to replace the side-byside annually at no cost to the county.

Helm said the Sheriff's Office has nine patrol deputies and three administrative staff.

County Commissioner Ryan Rundell said the county is working to find a building inspector to replace Clint Atteberry after his sudden passing. Rundell said Atteberry's would be big shoes to fill.

The council considered Resolution 1509 to approve including the City of Dayton in the Proposed Park and Recreation District. Su'euga requested reassurance that the district would provide adequate and consistent funding for the swimming pool operations and maintenance. Aukerman moved the Resolution to be adopted. It was approved, with Su'euga abstaining and Nysoe voting no.

The council also approved Resolution 1510, which authorizes the sale of surplus city property, and Resolution 1511, awarding a contract to Humbert Asphalt, Inc., for improvements to Third Street, J Street, Pearson Street, and Main Street.

To support the same road project, the council approved Resolutions 1512 and 1513 for Anderson Perry to provide engineering support. The scope of the roadwork will depend on additional funding since bids for the project exceed the city's budget.

The council discussed a meeting with government staff and regulatory agencies concerning flood mitigation on the Touchet River. The May 25, 2023, meeting will be on-site and include an inspection walk along the river.

Nysoe requested action on the vacant positions on the City's Affordable Housing Committee. He specifically highlighted the need for more apartments.

Su'euga said he saw a big puddle on Main Street during the last big rainstorm and witnessed a resident clearing detritus from the storm sewer grates with a shovel to drain the water. Su'euga said he had been impressed and revealed the citizen he saw working on the street was Mayor Weatherford.

The meeting adjourned at 7:44 p.m., with the next meeting scheduled for 6 p.m. on June 13, 2023.

### AT THE LIBERTY: "Dungeons & Dragons: Honor Among Thieves"

DAYTON-A charming thief and a band of unlikely adventurers undertake an epic heist to retrieve a lost relic, but things go dangerously awry when they run afoul of the wrong people. This movie brings the rich world and playful spirit of the legendary roleplaying game to the big screen in a hilarious and action-packed adventure.

Rotten Tomatoes critics rate Dungeons & Dragons: Honor Among Thieves at 91% favorable, while and audience gives it a 93% favorable. This movie is rated PG-13 for fantasy action/violence and some language. It is considered in the IMDb parent's guide as moderate for violence and gore, as well as for frightening and intense scenes. It has a runtime of 134 minutes.

### **EASTERN WASHINGTON SCHOOLS RECEIVE ANONYMOUS THREATS**

DAYTON-The Columbia County Sheriff's Department reported that on May 10, 2023, dispatch centers in Easter Washington, including Columbia County, received similar calls from an individual threatening violence towards area schools.

The Dayton Schools went into lockdown after the Columbia County Dispatch Center received the threat. Deputies from the Columbia County Sheriff's Office and troopers from the Washington State Patrol secured a perimeter around school grounds and placed officers inside the building. Law enforcement worked with school officials and staff to ensure appropriate safety protocols.

The lockdown was lifted after the threatening phone calls received throughout the region were found to be unsubstantiated.

The matter is currently under investigation.

In a press release, Columbia County Sheriff Joe Helm thanked the teachers and administrative staff of the Dayton School District, the Washington State Patrol, and deputies of the Columbia County Sheriff's Office for their swift and professional response during this event

### **NEW TAX CREDIT FOR** WASHINGTON WORKERS

### THE TIMES

OLYMPIA—Individuals and families may receive refunds of up to \$1,200 through Working Families Tax Credit if they meet eligibility requirements. The program is modeled after the Earned Income Tax Credit program; applications may be submitted through December 31, 2023.

The Working Families Tax Credit aims to stimulate the local economy, promote racial equity, and support the financial stability and well-being of low-to-moderate-income Washington residents and their families.

The program is managed by the Washington State Department of Revenue (DOR), the state's tax administration agency. The DOH asks Businesses, unions, service providers, and others who work with people eligible for the program to join outreach efforts to promote the program.

Information and answers to commonly asked questions are available on the program's website, www.workingfamiliestaxcredit.wa.gov. The site also provides a qualifying tool to help applicants see if they meet the criteria for the refund.

# A Guitar with history By Lane Gwinn | THE TIMES

WAITSBURG-This weekend, Burgers, Bands, and Brews features alternative country band Frog Hollow Band and some family lore. Band member Ty Lane plans on playing his grandfather Norval's Gibson ES-125 on a few numbers.

The distinctive sunburst, hollow-body electric guitar holds a special place in Lane's family history. Norvel most likely purchased it in the late 50s and performed with it through the following decades.

The guitar was played by Lane's aunt Leah in a band with Norval and Ty's father, Kit. Known as The Lanes, they played country standards in Spring Valley, Oregon, in the '70s.

Family lore puts Norval and his ES-125 on stage with country great Johnny Cash sometime in the mid-60s.

"He played it one night backing up Johnny Cash in the Dalles, Oregon (rumor has it)," said Lane. As the story goes, Cash was on tour in Oregon and needed to find a backup band for a performance. Norvel played the Gibson as part of the band that came to the rescue.

After Norval died in 2014 at 81, Lane's grandmother gave him the guitar. It had seen better days, and after years on the wall as a family heirloom, Lane decided it was time to take it down.

For years, the musician had heard about guitar tech Joe Patrick, owner of Orchard Street Studios in Waitsburg. Lane decided to see what Patrick could do with Norval's Gibson, which was then barely playable.

"Ty brought the vintage Gibson 125 to me with the hope he could one day honor his grandfather's legacy by performing with




it on stage. It had a long history of constant touring and little maintenance, and though it looked cool, Ty didn't like how it played or sounded," said Patrick.

After Patrick delivered the guitar, he received the following text from Ty, "Played the guitar well past midnight. Couldn't put it down!

I switched to a lighter pick and was able to enjoy never before heard tones through my Marshal Origin50 amp!"

When Bill was young, he was involved in 4H, FFA, and activities on his

family's farm. As an adult, he was on the FFA Advisory Board for many years. He attended Waitsburg Schools, later graduating from St. Patrick's High School, Walla Walla, in 1958. Bill graduated from Seattle University in 1963 with a Bachelor's in Commercial Science.

Bill worked in agriculture, including marketing and sales. Notably, he was the Chairman of the Board of Dry Pea & Lentil Council, served on USDA government committees, as well as a member of Northwest Grain Growers, Walla Walla County Cattleman's Association, and served on the Columbia REA Board of Directors for 17 years.

Linda's paternal great-great-grandfather, Daniel Harris, settled on the Lower Whetstone in the early 1880s. Her maternal great-grandfather, G. W. Loundagin, homesteaded on the lower Coppei near Waitsburg in 1863. He later built the Royal Block Hotel and Mercantile in the 1880s. Linda's parents, Gus Harris and Evelyn Loundagin Harris, were involved community members in Waitsburg. Her father, Gus, was on the first board of the Bruce House & Renovations.

In 1958, Linda was a Days of Real Sports royalty court member, graduating from Waitsburg High School that spring. She graduated from WSU in 1962 with a degree in Office Administration. Over the years, Linda provided clerical work to the Junior Livestock Show and was a member of Chapter BE PEO and the Walla Walla County Cowbelles. Today she remains actively involved in her church as a Board Member/Trustee and as the Historian.

Bill and Linda married in 1963 and returned to the area to farm with his parents. They had two daughters, Suzanne and Carrie, and three grandsons, Ryan, Alex, and Sean. They supported their daughters in 4-H, FFA, Rainbow Girls, and school activities. Bill even taught Sunday School.

The couple mentored many teenagers and young adults, teaching them about farming, hay and wheat harvesting, and their work ethic. They also shared their extensive knowledge of local history, including offering demonstrations at the Waitsburg Fall Festival.

Bill passed away on October 31, 2022, only a few months before the couple's 60th wedding anniversary on Jan 6, 2023.

"It is an honor to be selected as Celebration Days Parade Marshals," said Linda Stoncipher.

Walla Walla winemaker Kelsey Itämeri makes an interesting pair of Sémillons, this one fermented and aged in stainless, the other in neutral wood. Both wines are 100% varietal from the same block at Les Collines. The '1 of 2' is effusively juicy and fruity with luscious lime and pineapple. That opening burst of flavor is framed with a refreshing mineral note, and the nicely balanced phenolics add further details to the finish. Sémillon remains a bit of a rarity in Walla Walla (and throughout the Northwest), and it's a real pleasure to taste one so fresh and delicious as this. 




#### **Ten Years Ago**

### Sausage and Spinach asagna

When I was a freshman in high school, I had my first paid catering gig. Some family friends who were having a big, Italian American themed dinner party decided to take a chance on a 15-year-old who had grown up idolizing Julia Childs and Jacques Pépin. I spent weeks researching recipes and creating the menu, which was centered around several trays of lasagna. They were a huge hit, in part because of the velvety bechamel sauce that held the layers together, a secret ingredient I still use in my lasagna to this day.

**Ingredients:** 

1 tablespoon olive oil

1-pound Italian sausage

1 yellow onion, finely chopped

2 celery stalks, finely chopped

3 to 4 garlic cloves, minced 1/2 tablespoon dried oregano

2 tablespoons tomato paste

1 tablespoon red wine vinegar

1 28-ounce can whole tomatoes

1 14-ounce can chopped tomatoes

2 carrots, peeled and finely chopped

1 tablespoon fresh rosemary, minced



2 bay leaves 3 tablespoons butter 3 tablespoons all-purpose flour 3 cups milk Pinch nutmeg Salt & fresh ground black pepper 1 bunch fresh spinach, well-rinsed <sup>1</sup>/<sub>2</sub> cup parmesan, grated (divided) 15 ounces whole milk ricotta 1 egg

- 1 pound mozzarella, grated
- 1 pound dry lasagna noodles

**Directions:** First make your sauce. Pour the olive oil into a Dutch-oven and set over medium-high heat. Add the sausage and brown all over, breaking up with a wooden spoon. Remove the browned sausage with a slotted spoon and set aside. Next add the onion, carrots, and celery to the pot, reducing the heat to medium. Cook until vegetables are soft, and onion is translucent, about 5 to 7 minutes. Stir in the garlic, oregano, and rosemary, and continue to cook another minute. Make a well in the middle of vegetable mixture and add the tomato paste to the opening. Cook the tomato paste until fragrant and lightly toasted, stirring frequently, about 2 minutes, then combine with the vegetables. Add the vinegar and scrape up any browned bits from the bottom of the pan. Add the tomatoes with all the juices from the can, crushing the tomatoes with the back of a wooden spoon. Bring sauce to a simmer and then lower the temperature to maintain a gentle simmer. Add the bay leaves and season to taste with salt and black pepper. Cook uncovered for about 20 to 25 minutes, stirring occasionally. If sauce gets too thick add a little water to get desired texture.

Meanwhile, make the bechamel sauce. In a medium saucepan, melt the butter over medium heat. Sprinkle the flour over the top and whisk together into a smooth paste. Cook, whisking constantly for several minutes until the mixture is bubbling and lightly golden. The roux should have a sweet nutty smell. Next slowly pour in the milk while continuing to whisk into a smooth sauce, careful to break up all clumps. Continue to cook until smooth and reduced, about 20 minutes, whisking often. Season to taste with salt, pepper, and a pinch of ground nutmeg. Take off the heat and set aside covered.

Bring a large pot of salted water to a boil. Add the spinach and blanch for 1 to 2 minutes, then drain and immediately rinse in cold water to stop cooking. Drain well in strainer then wrap in a clean towel and squeeze out all the excess moisture. Coarsely chop spinach then add to a mixing bowl with the ricotta and egg. Add half the grated parmesan and season to taste with salt and black pepper. Set aside. Cook lasagna noodles al dente per package instructions. Drain and lay noodles over clean towels careful to not let them stick together. Preheat oven to 375 degrees. Begin layering the lasagna in a 9-inch by 13-inch baking dish. First spread a thin, even layer of the tomato sauce over bottom of the pan then cover with a single layer of noodles. Use a rubber spatula to spread 1/3 of the bechamel over the noodles, then spoon a layer of tomato sauce over that. Sprinkle a thin layer of mozzarella over the sauces then cover with another layer of noodles. Top this layer with tomato sauce then cover with all of the ricotta-spinach mixture and a sprinkle of mozzarella. Cover with a third layer of noodles then spread another 1/3 of the bechamel on top, and spoon tomato sauce over that. Sprinkle more mozzarella then top with the last layer of noodles. Spread the last of the bechamel over the top then an even layer of mozzarella. Finally, top everything with the last of the grated parmesan and cover the dish with foil. Bake for about 25 minutes on the middle oven rack. Remove the foil then bake for another 20 to 25 minutes until lasagna is bubbling along the sides and the top is nice and golden. Remove from the oven and allow to rest for at least 10 minutes before cutting. Enjoy!


