Hospital Renovation in Full Swing

PHYSICAL THERAPY, PHARMACY DEPARTMENTS SHOULD BE RELOCATED BY YEAR-END


DAYTON - When renovation of Dayton General Hospital is complete next year, the main entrance to the facility will be on the north side of the building, near the former emergency room entrance. That side of the building is a construction zone now, but one can begin to visualize the circular driveway entrance that will soon be in place.

During a tour of the construction late last month, hospital officials described the work underway in Phase 1 of the renovation project, which includes constructing a new pharmacy department, a new gift shop area, laying out of the new entrance area and, perhaps most significantly, construction of a new, much larger physical therapy department, and the addition of an aquatic thera-

The wing that formerly housed Booker Annex has been gutted and a new gym for the P.T. department is well under way. According to Columbia County Health Systems CEO Shane Mc-Guire, the gym will be about 1½ times the size of the current one. Adjacent to the new gym will be seven new private rehabilitation rooms.

The only expansion of the hospital footprint in the entire renovation project is the addition of the therapy pool. The foundation walls for the pool have been poured and a new self-contained will soon be lowered into place. The pool area will then be enclosed.

Work is also well underway on the new hospital pharmacy. McGuire said that the state health department and state pharma-

cy board still need to inspect and approve the new facility before the pharmacy staff moves in. The hospital pharmacy will continue to be operated by staff from Dayton's

While the new circular entrance area to the hospital should be completed before the end of the year, patients and visitors will continue to enter into the building at

Ten Years Ago

Sept. 14, 2006

Anyone fortunate enough to have known Roberta Stonecipher Broom Adams – and there were many - can imagine her take on being named Pioneer of the Year at the 34th Annual Pioneer Fall Festival, which will take place this coming Sunday in Waitsburg. She'd laugh and exclaim "Really?! Me?! Ya shouldn't have!" Roberta was one of Waitsburg's citizens known for the many firsts in her life. She was the first female Student Body President At Waitsburg High School, and the first Queen of the Days of Real Sport. And fittingly, she will be the first Pioneer of the Year to be honored posthumously by the Waitsburg Historical Society.







KEN GRAHAM: FROM THE PUBLISHER

Who is Gary Johnson?

Por nine years in the 1980s and '90s I lived and worked in Albuquerque, N.M. It's a big sprawling city with a large Air Force base and a large university.



Traveling north from Albuquerque

will take you into some of the most beautiful country in America: an area that includes Santa Fe, Taos and Los Alamos.

In 1994, two years before I moved to Dayton, a guy named Gary Johnson ran for governor of New Mexico as a Republican. I voted for him and he won, though those two facts must surely be unconnected. Right?

Johnson had never run for elected office before; he was just a really rich guy who ran his own construction business. He beat the incumbent Democrat Bruce King, who had been a political institution in the state for many years, by 10 points. Johnson was re-elected in 1998, serving a total of eight years as governor – the maximum allowed by term limits there.

His campaign slogan was "People Before Politics," and he ran on a platform of limited government.

Johnson started out doing handyman jobs while attending the University of New Mexico – the large university I mentioned before. He built "Big J Enterprises" into a behemoth, winning contracts to build Intel microprocessor plants just outside Albuquerque.

Johnson has climbed Mt. Everest, and he has competed in three Iron Man Triathlons. During his first run for governor, he rode his bicycle around the state while campaigning.

Now he's running for President on the Libertarian Party ticket. Though he's trailing Hillary Clinton and Donald Trump badly (he's gotten in the high single digits in most recent polls), Johnson and the Libertarians might be worth thinking about.

The Libertarian Party's motto is "Minimum Government, Maximum Freedom." It has an interesting set of positions, many of which I find appealing.

US Election So Nuts I Just Might Win, Libertarian Johnson Says

ibertarian Gary Johnson's plan for capturing the White House hinges on voters following through on polls suggesting they dislike the Republican and Democratic presidential nominees more than in any election year in history.

"You know how crazy this election cycle is?" Johnson told Chris Wallace on "Fox News Sunday."
"I might be the next president."

First, Johnson, the former Republican governor of New Mexico, has to be allowed into the nationally televised debates that for now are set to feature only Democrat Hillary Clinton and Republican Donald Trump. Johnson con-

ceded it's "game over" if he doesn't secure a place on the podium.

To get there, the Commission on Presidential Debates requires candidates to secure 15 percent support in five national polls. According to Real Clear Politics' average of recent polls, Johnson is at 8.1 percent, though he noted he has climbed to 10 percent in five polls identified by the commission and is hitting 16 percent in five states.

The debates begin Sept. 26 at Hofstra University in New York.

Americans want to see Johnson get the chance to take on Clinton and Trump, in far greater numbers than those who say they'd vote for him. In the latest Quinnipiac University poll, 62 percent of respondents said Johnson should be included in the debates.

Johnson says his goal is to win the presidency outright, but there's another path to the presidency for a third-party candidate. If neither of the mainstream candidates secure a majority -- 270 -- of electoral votes, the decision would be punted to the House of Representatives.

Johnson and his running mate, former Massachusetts Governor Bill Weld, depart from libertarian principles in some respects to the dismay of party purists. They have tried to marry the party's philosophies of limited government and individual freedom

with the fiscal conservatism espoused by Republicans and social views embraced by Democrats.

Johnson wants to replace the corporate and income taxes with a national sales tax, arguing that such a levy with a "prebate" sent to households on a monthly basis would "create tens of millions of jobs"

He proposes removing marijuana from the Drug Enforcement Agency's list of controlled substances, arguing that it is safer than other illegal drugs and even alcohol. Johnson previously was the chief executive officer of Cannabis Sativa Inc., a medical marijuana company. Ultimately, he said, the issue would be left to the states.

Johnson said he and Weld are "really skeptical about intervening militarily to achieve regime change that I think has resulted in a less-safe world." He supports the Trans Pacific Partnership trade deal, putting him at odds with both Trump and Clinton, who have vowed to negotiate better deals.

Where Trump's evolving position on immigration still has him building a wall along the U.S. border with Mexico, Johnson says it should be easier for foreigners to enter the U.S. on work visas after clearing background checks. "These are hard-working individuals who are taking jobs that U.S. citizens don't want," he said.

Polarization in Congress is sure to be even worse if either Trump or Clinton is elected, Johnson says. "Our pitch is the third alternative, which is a couple of Libertarians in the middle hiring a bipartisan administration, everybody Libertarian-leaning," he said. "I think you can make a case that that third scenario might work."

NESTLE TREATMENT WAS DISCRIMINATION

Citizens, corporations/companies, and developers interested in Waitsburg, BEWARE!! New "normal" established whereby "MAJORITY" declared by elected officials as he/she who protests loudest, acts rudest/profane/interruptive, and/or displays most signs. Officials acknowledge Waitsburg laws indicate how development should be handled, with Council and Public input only after examination by city staff and planning commission; and that city's treatment of Nestle was unusual, not how other developments are addressed probably not ethical, honest, or legal!

No official vote on Nestle's proposal for water bottling plant occurred, just "tally" by council member in a meeting. NO FACTS were given by city or Nestle (excluded from meeting). Instead misleading statements were issued by MAJORITY, including non-Waitsburg residents, and Facebook petition against Nestle submitted ("1,200+ signatures", with nominal signatures from Waitsburg, about half of those "anonymous", and balance from around the world and US).

New development process is in Title 10 Waitsburg Municipal Code and Comprehensive Plan. Code and plan changes are legal process with citizen input. Council should stay with laws for a reason – they are elected to uphold them, their duty even in difficult situations!! From code the use was legally permissible, size of project was allowable, and process existed whereby Nestle could address impacts on water, wastewater, traffic, and other. No code prohibits international corporations from developing. Nestle's treatment by MAJORITY is discrimination of a different color and dangerous path taken by city to consider it!!

Before council's decision against Nestle, my 4-page letter included:

Proposed water use was 14% of City's system capacity of 1.052 million gallons per year.

No water rights would be given away, nor would trucks drive around watershed; Nestle would be a municipal water user, like all other users in town turning their faucets on.

From studies on Nestle Cascade Locks proposal, a similar size as Waitsburg's, \$50 million facility could support 30 local permanent jobs, and with multiplier effects, 97 full and part-time employment; \$2.8 million labor income, and \$32.0 million total output. Construction impacts were 356 full and part-time employment, \$11.6 million labor income, and \$35.3 million total output.

Libertarians would free property owners from government restrictions on their rights to control and enjoy their property, as long as their choices do not harm or infringe on the rights of others.

We oppose all laws at any level of government restricting, registering, or monitoring the ownership, manufacture, or transfer of firearms or ammunition.

Competitive free markets and property rights stimulate the technological innovations and behavioral changes required to protect our environment and ecosystems. Private landowners and conservation groups have a vested interest in maintaining natural resources. Governments are unaccountable for damage done to our environment and have a terrible track record when it comes to environmental protection.

We oppose all government control of energy pricing, allocation, and pro-

We favor a free-market health care system. We recognize the freedom of individuals to determine the level of health insurance they want (if any), the level of health care they want, the care providers they want, the medicines and treatments they will use and all other aspects of their medical care, including end-of-life decisions.

Libertarians advocate individual privacy and government transparency. We are committed to ending government's practice of spying on everyone.

All persons are entitled to keep the

fruits of their labor. We call for the re- riage, child custody, adoption, immipeal of the income tax, the abolishment of the Internal Revenue Service and all federal programs and services not required under the U.S. Constitution.

(Lest you think the party favors government insolvency, Johnson has proposed a consumption tax to replace the income tax.)

Here are some more Libertarian platform positions:

We support the removal of governmental impediments to free trade. Political freedom and escape from tyranny demand that individuals not be unreasonably constrained by government in the crossing of political boundaries. Economic freedom demands the unrestricted movement of human as well as financial capital across national borders. However, we support control over the entry into our country of foreign nationals who pose a credible threat to security, health or property.

Our foreign policy should emphasize defense against attack from abroad and enhance the likelihood of peace by avoiding foreign entanglements. We would end the current U.S. government policy of foreign intervention, including military and economic aid.

Recognizing that abortion is a sensitive issue and that people can hold good-faith views on all sides, we believe that government should be kept out of the matter, leaving the question to each person for their conscientious consideration.

We oppose the administration of the death penalty by the state.

Sexual orientation, preference, gender, or gender identity should have no impact on the government's treatment of individuals, such as in current margration or military service laws. Government does not have the authority to define, license or restrict personal relationships. Consenting adults should be free to choose their own sexual practices and personal relationships.

Criminal laws should be limited in their application to violations of the rights of others through force or fraud, or to deliberate actions that place others involuntarily at significant risk of harm. Therefore, we favor the repeal of all laws creating "crimes" without victims, such as the use of drugs for medicinal or recreational purposes.

Some Libertarians take the concept of "limited government" to the extreme. For instance, Johnson has been criticized by some members of his party for saying he thinks it's okay

for states to issue driver's licenses.

The role of government in people's lives will always be a source of debate and disagreement. Libertarians advocate limited interference by government into all people's lives, including those who wish to live much differently than most of us do.

In the accompanying column about Gary Johnson on these pages, he says he thinks he has a realistic chance of winning this year's presidential election. Let's be honest; his chances are as realistic as my chance of playing in this year's World Series.

However, for those readers who, like me, are less than enthusiastic about the two major party nominees in this year's presidential race, Libertarian Gary Johnson might be worth a





For the past six years, Wyatt has been associate and youth pastor at The Ridge Church, in Lincoln, Calif. During his time in Lincoln, he grew the youth group from two to more than 130 young people, and opened the first Christian youth center in the community.

He also provided marriage and addiction counseling, and supports seniors with life changes, end of life decisions, and families in bereavement.

Wyatt's wife Krystal, grew up in Walla Walla. She currently works as a medical patient coordinator. Daughter Mikaila is a high school sophomore this year, and is an avid volleyball and basketball player.

"I lived in Waitsburg for 19 years and love this town with everything in me," Wyatt said. 'To have this opportunity is deeply moving to

According to Pulpit Committee member Robbie Johnson, the church congregation will be asked to approve Wyatt's appointment in a ballot to be sent out next week.

Johnson hopes Wyatt can start in the new position in October.


the old main entrance, which is also the emergency entrance. Construction for Phase 2, beginning early next year will continue on the north side of the building.

Upon completion of Phase 1, the former P.T. area will be set up as a temporary dining room, while the existing kitchen and dining facilities are renovated as part of Phase 2. The imaging department will also be renovated and expanded as part of the second phase. New CT scanning equipment will be installed as part of that phase. Phase 2 is expected to be completed in March 2017.

Phase 3, to begin next spring, will see completion of the main interior entrance area and the new medical lab facilities. The new lab will be built in the former P.T. area after the dining facility moves back to its renovated space. The new main entrance area on the north side of the building will open at the end of Phase 3, sometime next summer.

Phase 4 will see the completion of the new emergency entrance, near the current main entrance. A new emergency room waiting area with an expanded nurses' station will also be built. The recently modernized and expanded emergency facilities will remain in their current location.

The hospital renovation project is being funded by a \$5.5 million bond that was narrowly approved by voters in November, 2014. Groundbreaking on the project took place at the beginning of july.




"We will see alot smarter play as well as confidence from these girls this season. They are an athletic, hardworking, competitive group of girls," Turner said.


